Accordingly, the objective of the ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are also responsible for communicating significant matters related to the audit that are, in our professional judgment, relevant to your responsibilities in overseeing the financial reporting process. However, we are not required to design procedures for the purpose of identifying other matters to communicate to you.

Planned Scope and Timing of the Audit

We conducted our audit consistent with the planned scope and timing we previously communicated to you.

Compliance with All Ethics Requirements Regarding Independence

The engagement team, others in our firm, as appropriate, our firm, and our network firms have complied with all relevant ethical requirements regarding independence.

In the normal course of our professional association with Appddiction Studio LLC 401k, we generally discuss a variety of matters, including the application of accounting principles and auditing standards, significant events or transactions that occurred during the year, business conditions affecting the plan, and business plans and strategies that may affect the risks of material misstatement. None of the matters discussed resulted in a condition to our retention as the Plan's auditors.



Qualitative Aspects of the Plan's Significant Accounting Practices

Significant Accounting Policies

Management has the responsibility to select and use appropriate accounting policies. A summary of the significant accounting policies adopted by the Plan is included in Note 2 to the financial statements. There have been no initial selection of accounting policies and no changes in significant accounting policies or their application during 2024. No matters have come to our attention that would require us, under professional standards, to inform you about (1) the methods used to account for significant unusual transactions and (2) the effect of significant accounting policies in controversial or emerging areas for which there is a lack of authoritative guidance or consensus.

Significant Accounting Estimates

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's current judgments. Those judgments are normally based on knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ markedly from management's current judgments. The most sensitive accounting estimate affecting the financial statements is:

Management's estimate of the fair value of investments is described in Note 4 to the financial statements. We evaluated the key factors and assumptions used to develop the fair value of investments and determined that it is reasonable in relation to the basic financial statements taken as a whole.

Financial Statement Disclosures

Certain financial statement disclosures involve significant judgment and are particularly sensitive because of their significance to financial statement users. The most significant disclosures affecting the financial statements are:

Fair Value Measurements disclosure note, which describes the valuation methodologies used to estimate the fair value of investments.

Significant Unusual Transactions

We encountered no significant unusual transactions during the performance of the audit.

Significant Difficulties Encountered during the Audit

We encountered no significant difficulties in dealing with management relating to the performance of the audit.

Uncorrected and Corrected Misstatements

For purposes of this communication, professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that we believe are trivial, and communicate them to the appropriate level of management. Further, professional standards require us to also communicate the effect of uncorrected misstatements related to prior periods on the relevant classes of transactions, account balances or disclosures, and the financial statements as a whole. The management representation letter described below includes an attachment that summarizes uncorrected financial statement misstatements whose effects in the current and prior periods, as determined by management, are immaterial, both individually and in the aggregate, to the financial statements taken as a whole. Uncorrected misstatements or matters underlying those uncorrected misstatements could potentially cause

future-period financial statements to be materially misstated, even though the uncorrected misstatements are immaterial to the financial statements currently under audit.

In addition, professional standards require us to communicate to you all material, corrected misstatements that were brought to the attention of management as a result of our audit procedures. See financial statement footnote "Reconciliation to Form 5500", if any, for material, corrected misstatements.

Disagreements with Management

For purposes of this letter, professional standards define a disagreement with management as a matter, whether or not resolved to our satisfaction, concerning a financial accounting, reporting, or auditing matter, which could be significant to the Plan's financial statements or the auditor's report. No such disagreements arose during the course of the audit.

Representations Requested from Management

We have requested certain written representations from management, which are dated July 17, 2025.

Management's Consultations with Other Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters. Management informed us that, and to our knowledge, there were no consultations with other accountants regarding auditing and accounting matters.

Internal Control Matters

Except as discussed in the Our Responsibility in Relation to the Financial Statement Audit paragraph, in planning and performing our audit of the financial statements of the Plan in accordance with auditing standards generally accepted in the United States of America, we considered the Plan's internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of expressing our opinion on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

Our consideration of internal control was for the limited purpose described in the preceding paragraph and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and, therefore, material weaknesses or significant deficiencies may exist that were not identified. However, as discussed below, we identified certain deficiencies in internal controls and considered their nature as follows:

- A material weakness is a deficiency, or a combination of deficiencies, in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis.
- A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance.
- A control deficiency exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis.

We identified the following deficiencies in the Plan's internal control, which are also considered to be reportable findings:

Control deficiency - Employee Demographic Data

Matters Identified: During our audit, we noted there are insufficient controls in place to ensure that employee data matches between the recordkeeping system and payroll system. We noted certain employee data did not match between service providers, and therefore, alternative procedures were used to ensure the discrepancies did not affect Plan operations. It is important that employee data in the recordkeeping system be accurate since this is the data used for Plan operations and to ensure the plan's compliance with laws and regulations.

Recommendation: We recommend Plan management put policies and procedures into place to ensure employee data captured in the recordkeeping system is reviewed for accuracy and relevance for proper Plan operations.

Control Deficiency - Eligible Compensation

Matters Identified: As part of our audit procedures over eligible compensation, we identified that the Plan Sponsor has been excluding both "Bonus" and "Expense Reimbursement" amounts from compensation used in deferral and match calculations. However, the plan's adoption agreement does not formally exclude these compensation elements, resulting in a potential operational deviation.

We were informed that this exclusion has been part of the plan sponsor's historical payroll processing procedures. In order to align operational treatment with plan terms, a formal amendment to exclude these compensation elements was filed on September 17, 2024. The discrepancy applies only to the period prior to this amendment.

Management Response: Management acknowledges that both Bonus and Expense Reimbursement amounts were operationally excluded from eligible compensation prior to the September 17, 2024 amendment. This amendment was filed to bring the plan document into alignment with the company's long-standing practice. Management has reviewed payroll processes to confirm consistency going forward and believes that no participant impact or corrective action is necessary. Ongoing monitoring will be implemented to ensure continued compliance with the amended plan provisions

Control deficiency - Mandatory Distributions

Matters Identified: During our audit, we found that there is no procedural control in place to ensure that mandatory distributions are processed following severance of employment for participants with an account balance of \$5,000 or less, pursuant to Plan provisions. We noted participant accounts exist at audit year end that belong to terminated employees and do not exceed \$5,000.

Recommendation: We recommend Plan management consult with its service provider to develop a procedural control to periodically (at least annually) review the accounts of terminated employees and process mandatory distributions pursuant to Plan provisions. If mandatory distributions cannot be made due to missing participants, plan fiduciary must be able to demonstrate compliance with DOL's missing participants guidance (<https://www.dol.gov/agencies/ebsa/employers-and-advisers/plan-administration-and-compliance/retirement/missing-participants-guidance>) regarding efforts made in locating missing participants or the selection of a distribution option for the benefit of missing participants.

Control deficiency - *Loan Repayment Setup*

Matters Identified: During our review of participant loan activity, we identified instances involving two participants where loan repayments continued to be withheld from payroll after the participants had terminated employment. The plan sponsor did not discontinue loan repayment deductions in a timely manner following loan payoff and participant termination. While the amounts involved were insignificant, and no adjustments were deemed necessary, the issue highlights a procedural weakness.

Recommendation: The Plan Sponsor should implement or enhance procedures to ensure loan repayments are halted immediately upon participant termination or loan payoff. This may include reconciling payroll data against recordkeeper reports more frequently or instituting termination checklists. Prompt monitoring will help mitigate recurrence and support overall plan compliance.

Other Matters

The ERISA-required supplemental schedules, other than that agreed to or derived from the certified investment information, were subjected to the audit procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards (GAAS).

Our responsibility also includes communicating to you any information which we believe is a material misstatement of fact. We obtained and read a substantially complete draft of the Form 5500 prior to the dating of our auditor's report. Material inconsistencies with the information, or manner of its presentation, appearing in the financial statements are included in the financial statement footnote "Reconciliation to Form 5500", if any. Our procedures are not sufficient, nor are they intended, to determine that the Form 5500 is completely and accurately prepared.

This communication is intended solely for the information and use of those charged with governance and management of the Plan and is not intended to be, and should not be, used by anyone other than these specified parties.
