Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audits of the accompanying financial statements of Medve Group, Inc. 401(K) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1: DESCRIPTION OF THE PLAN

General

Medve Group, Inc. 401(k) Profit Sharing Plan (the "Plan") is a defined contribution plan covering substantially all of the eligible employees of Medve Group, Inc. (the "Company", or "Plan Sponsor"). The Plan is a qualified plan as defined by Section 401(a) of the Internal Revenue Code and contains a provision for salary reduction contributions under Section 401(k) of the Internal Revenue Code. The Plan is also subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following description provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Eligibility

Non-excluded employees who have reached the age of 18 years of age, and have completed six months of service are eligible to participate in the Plan. Upon eligibility, employees are automatically enrolled into the Plan at one percent on the first day of the month after meeting eligibility requirements.

Contributions

The Company automatically enrolls eligible participants into the plan at a pre-tax deferral contribution of 1% of that participant's eligible compensation. The Company will also automatically increase participants' contribution by 1% annually up to 4% of their eligible compensation. Participants may elect to contribute up to 90% of their annual pre-tax compensation, as defined, to the Plan, subject to Internal Revenue Service limitations, and may direct their contributions to various investment alternatives. Participants may also designate some or all of their contributions as an after-tax Roth contribution, subject to limitations. The contribution limit applies to any calendar year and is adjusted annually by the Internal Revenue Service. For 2024, the maximum contribution allowed for any employee was \$23,000. Additionally, participants who attain age 50 during the plan year may make "catch up" contributions of up to \$7,500 for 2024. The Plan allows rollover contributions from other qualified retirement plans.

The Company may make a discretionary matching contribution. For the year ended December 31, 2024, the Company contributed 50% of the first 6% of compensation that a participant contributed to the Plan for all participants employed at the end of the year. The Plan also permits the Company to make qualified non-elective contributions to those eligible participants who are not highly compensated employees as well as discretionary non-elective contributions to all eligible participants. There were no qualified nonelective or discretionary contributions made by the Company for 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and (a) the Company's contribution and (b) investment income or loss, less expenses. Income for each of the investment choices is allocated to the participants' accounts on a daily basis and is based on the relative units of participation. Benefits paid to participants under the Plan are limited to the vested balance in each participant's account.

Vesting and Payment of Benefits

Participants are immediately vested in their contributions and their actual earnings. Company matching contributions vest as follows:

Years of Service	Percentage Vested
Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

If death or permanent disability occurs during employment, an employee's entire account becomes fully vested.

Upon a participant's retirement, termination, disability, or death, a participant may elect to receive the value of his or her vested interest as a lump-sum payment. Participants, upon reaching the age of 59½, may also take an in-service distribution. Upon a participant's termination, mandatory automatic distributions are made for participant balances less than \$7,000. Certain minimum distributions are required for inactive employees who have reached the age of 70½. Hardship withdrawals from employee deferrals, subject to account balance limits and applicable laws, are allowed under the Plan.

Forfeitures

Forfeitures of Company contributions due to termination of employment are used to reduce future Company contributions to the Plan. Total forfeitures for the year ended December 31, 2024 were \$2,601.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of additions and expenses during the reporting period. Actual results could differ from those estimates.

Investments

The Plan's investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade date basis.

Notes Receivable from Participants

Participants may borrow a portion of the vested balance of their account, subject to a minimum of \$500 and up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest and are secured by the participant's vested account balance. The notes bear interest and interest income is recorded on the accrual basis.

Administrative fees

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to notes receivable from participants, withdrawals, and certain investment transaction fees are charged directly to the participant's account and are included in administrative expenses, net of reimbursements. Other investment-related expenses are included in net appreciation of investments.

Benefit Payments

Distributions to participants are recorded when paid.

NOTE 3: TAX STATUS

The Plan is an adoption of a non-standardized prototype arrangement designed by ADP, LLC. ADP, LLC received a determination letter July 8, 2014 from the Internal Revenue Service (IRS) that qualified the prototype arrangement as tax-exempt under the appropriate sections of the Internal Revenue Code (IRC). The Plan has not yet received its own determination letter from the IRS. Although the Plan has been amended since adoption, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 4: ADMINISTRATION AND INVESTMENTS

Administration

All of the Plan's investments are administered by Reliance Trust Company ("Reliance Trust"). Among other duties, Reliance Trust receives contributions, invests and reinvests the Plan's assets, collects income and makes distributions from the Plan's assets as directed by the trustee for the Plan.

Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company.

NOTE 5: FAIR VALUE MEASUREMENTS

FASB ASC 820-10 provides standards and disclosures for assets and liabilities that are measured and reported at fair value. As defined in FASB ASC 820-10, fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). FASB ASC 820-10 requires disclosure that establishes a framework for measuring fair value and expands disclosure about fair value measurements. The statement requires fair value measurements be classified and disclosed in one of the following categories:

Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities. An active market for the asset or liability is a market in which transactions for the asset or liability occur with sufficient frequency and volume to provide pricing information on an ongoing basis.

Level 2: Measured based upon inputs that are observable, either directly or indirectly, for the asset or liability other than quoted market prices included in Level 1. These inputs include: a) quoted prices for similar asset or liabilities in active markets b) quoted prices for identical or similar assets or liabilities in markets that are not active c) inputs other than quoted market prices that are observable and d) inputs that are derived primarily from or corroborated by observable market data by correlation or other means.

Level 3: Measured based on unobservable inputs for the asset or liability for which there is little, if any, market activity for the asset or liability at the measurement date. This input includes management's own assumptions about the assumptions that market participants would use in pricing the asset or liability. The inputs are developed based on the best information available in the circumstances, which might include management's own data.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds and Money Market Funds

The fair value of mutual funds and money market funds is determined by obtaining quoted prices on nationally recognized securities exchanges, which are generally classified within Level 1 of the fair value hierarchy.

NOTE 6: RELATED PARTY TRANSACTIONS

The Plan invests in mutual funds that are managed by the trustee. During the year ended December 31, 2024, the Plan paid Reliance Trust \$7,862, in administration fees that are included in administrative expenses. The Plan believes the fees charged by the trustee and its administrative fees are no different than those that would be charged by other companies engaged in managing pension assets.

NOTE 7: RISKS AND UNCERTAINTIES

Plan participants make choices regarding their investment securities, and are exposed to risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that reduction in value can occur in the near term and that such changes could materially affect participant account balances reported in the statement of net assets available for benefits.

NOTE 8: PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and terminate the Plan Subject to the provisions of ERISA. Upon termination of the Plan, each participant's account balance becomes 100% vested.

NOTE 9: INCOME TAXES

The Plan did not have unrecognized tax benefits as of December 31, 2024 and 2023 and does not expect this to change significantly over the next twelve months. The Plan will recognize interest and penalties accrued on any unrecognized tax benefits as a component of income tax expense. As of December 31, 2024 and 2023, the Plan has not accrued interest or penalties related to uncertain tax positions.

NOTE 10: SUBSEQUENT EVENTS

Subsequent events were evaluated from January 1, 2025 through July 22, 2025, which is the date the financial statements were available to be issued. The Plan noted no significant subsequent events.
