Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Consortium Health Plans, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Consortium Health Plans, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Consortium Health Plans, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

Consortium Health Plans, Inc. (the Company) established the Consortium Health Plans, Inc. 401(k) Plan on January 1, 1994. The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) and covers all eligible employees of Consortium Health Plans, Inc. The Plan is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by the trustees of the Plan as appointed by the Company's Board of Directors.

Eligibility

The Plan covers all employees of Consortium Health Plans, Inc. (the Company) who are age 21, except for union and non-resident aliens. Employees' entry date will be the first day of the quarter coinciding with or next following the date they satisfy the eligibility requirements.

Contributions

Participants may contribute up to 90% of their annual compensation on a pre-tax basis, as defined in the Plan, subject to the statutory limitations established by the Internal Revenue Code (IRC). Effective January 1, 2024, participants may also make "roth" contributions to the Plan, which are subject to federal income taxes in the year of deferral. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollovers from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and common collective trust as investment options for participants.

The Plan includes an auto-enrollment provision whereby newly eligible employees are auto-enrolled in the Plan with a default deferral rate set at 6% of eligible compensation, unless they affirmatively elect not to participate. Contributions are automatically invested in the target date fund based on the participants' expected retirement age.

The Company provides a safe harbor matching contribution for all eligible employees, equal to 100% of the first 3% of the participants' compensation contributed to the plan, and 50% of the next 3% of compensation contributed to the plan. For purposes of calculating the safe harbor matching contribution, eligible employee compensation and contributions are determined on a payroll period basis. The Company calculates and contributes to the Plan a true-up contribution at the end of each year, based on the ratio of eligible employees' elective deferrals to compensation for the plan year. The Company may also make discretionary matching and non-elective contributions on behalf of eligible participants.

NOTE 1 - DESCRIPTION OF THE PLAN (Continued)

During 2024 and 2023, the Company made safe harbor matching contributions of \$605,312 and \$517,988, respectively. The Company did not make any discretionary matching and non-elective contributions in 2024 or 2023.

Participant Accounts

Each participant's account is participant-directed and is credited with the participant's contributions and allocations of the Company's contributions, investment earnings and losses and any administrative expenses paid by the plan. Allocations are based on participant investments held, account balances, or specific participant transactions, as defined. Plan participants have daily access to their account via phone or internet and may change the allocation of their investments to any of the investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferrals, rollovers and company's safe harbor matching contributions, plus actual earnings thereon. Vesting in the company's discretionary matching and non-elective contributions portion of their account is based on years of continuous service. After three years of service, a participant becomes 100% vested in the Company contributions to the Plan.

Notes Receivable from Participants

Participants in the Plan may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their eligible account balance, reduced by any outstanding note balance. A participant may have up to one loan outstanding at any one time. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Loan terms range from one to five years, or up to 30 years for the purchase of a principal residence. Principal and interest are paid ratably through payroll deductions.

The interest rates on the outstanding loans ranged from 4.25% to 9.50% at December 31, 2024 and December 31, 2023.

Payment of Benefits

Upon retirement, death, disability, or termination of employment, a participant may elect to receive an amount equal to the value of the vested interest in his or her account in the form of a lump sum payment, direct rollover into a qualified retirement plan, or a combination of cash and direct rollover distribution. In-service withdrawals at age 59 1/2 are also permitted, subject to the provisions described in the Plan document. The Plan allows for hardship distributions of some or all of the participant's vested account balance. Hardship withdrawals are subject to specific statutory and regulatory requirements.

Forfeited Accounts

Forfeitures resulting from terminated participants may be used to pay plan administrative expenses or reduce employer matching contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$17,632 and \$10, respectively. During the years ended December 31, 2024 and 2023, the Plan used \$973 and \$-0-, respectively, from forfeited nonvested accounts to reduce employer contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting standards generally accepted in the United States of America (U.S. GAAP).

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on an accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recognized on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Contributions

Contributions from Plan participants and the associated Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses may be either paid out of the Plan or paid directly by the Company. Plan expenses paid by the Company are excluded from these financial statements. The Plan is not required to reimburse the Company for Plan expenses the Company pays on the Plan's behalf. Investment related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Use of Estimates

The preparation of the financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

NOTE 3 - CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified by Reliance Trust Company (a qualified institution), as complete and accurate in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4 - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Common Collective Trust Funds

The common collective investment trust funds (CCT funds) are issued and managed by State Street Global Advisors and Invesco. The CCT funds are valued at the NAV of units of the trust, which is based on the fair value of the underlying investments held by the trust less its liabilities and is available to plan participants on the plan recordkeeper website. Participant transactions (purchases and sales) may occur daily. The NAV for all CCT funds is a readily determinable fair value and is the basis for current transactions.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

NOTE 6 - TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan’s investments include mutual funds managed by the Plan’s trustee. Therefore, the transactions in these funds qualify as party-in-interest transactions. Personnel and facilities of the Company have been used to perform administrative functions for the Plan at no charge to the plan.

There were no financial transactions recorded between the Company and the Plan other than contributions made. Notes receivable from participants also qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 - TAX STATUS

The Plan has adopted a prototype non-standardized profit-sharing plan sponsored by Automatic Data Processing (ADP). The prototype plan has received an opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, which states that the prototype non-standardized profit-sharing plan, as then designed, is in compliance with the applicable requirements of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the plan and recognize a tax liability (or asset) for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions for the statutory period; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
