Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Strand Systems Engineering, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

1) DESCRIPTION OF PLAN

The following description of the Strand Systems Engineering, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is sponsored by Strand Systems Engineering, Inc. (the “Sponsor” or “Company”) and is a single employer defined contribution 401(k) plan covering substantially all employees of the Company excluding union employees, nonresident aliens, and residents of Puerto Rico. Participants are eligible to participate in the Plan the first day of the month coinciding with or following attainment of age 18 and the completion of 6 months of service.

The Plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), became effective January 1, 2005.

Contributions

Participants may elect to contribute a percentage or dollar amount of their eligible compensation as defined by the Plan. The minimum percentage of compensation a participant may elect to defer is 1% and the maximum is 80% of eligible compensation. Participants who have attained age 50 before the end of the Plan year are also eligible to make catch up contributions. Participants may select from pre-tax or Roth deferrals. These contributions are subject to annual limitations established by the Internal Revenue Service (IRS). The Plan provides an automatic enrollment provision whereby new participants are automatically enrolled in the Plan and have pre-tax elective deferral contributions equal to 1% of eligible pay unless they complete an alternative election or elect to not participate. There is no escalation clause, and the deferral percentage will remain at 1% until the participant elects a change in the deferral rate. Participants may also contribute amounts representing distributions from other qualified retirement plans.

For Participants employed six months and contributing to the Plan, the Company has elected to make matching contributions in compliance with safe harbor provisions. The Company made safe harbor contributions equal to 100% on the first 4% of a participant’s compensation deferred into the Plan which totaled \$567,708 and is included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

At its discretion, the Company may also make a non-elective contribution to all eligible employees. The Company did not elect to make any non-elective contributions for the Plan year ended December 31, 2024.

1) DESCRIPTION OF PLAN (CONTINUED)

Investments

Participants direct the investments of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and self-directed brokerage accounts as investment options for participants. Participants may change their investment options for future contributions at any time.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution, if any, (b) the Company's non-elective contribution, if any, (c) Plan earnings or losses, and (d) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants are also immediately vested in the safe harbor contributions and related investment earnings.

Participants are vested in employer non-elective contributions and related investment earnings based on years of continuous service. The Plan utilizes the following vesting schedule for employer non-elective contributions:

Participants will become fully vested upon death or disability, as defined by the Plan document.

1) DESCRIPTION OF PLAN (CONTINUED)

Payment of Benefits

Distributions generally will be made in the event of retirement, death, disability, resignation, or dismissal. Vested account balances can be distributed by lump sum distributions, substantially equal installments, or partial withdrawals, provided the minimum withdrawal is \$500. Vested account balances that do not exceed \$5,000 are subject to automatic distribution without participant's consent. Rollover contributions are excluded in determining the \$5,000 threshold. All other accounts must receive participant consent before a distribution to the participant can occur.

Certain in-service withdrawals are allowed. A participant may also elect to withdraw all or a portion of their vested account balance while employed after reaching age 59.5. Hardship withdrawals are allowed only for immediate and heavy financial needs for reasons defined by the Plan document.

Forfeitures

Participants are immediately vested in employer safe harbor matching contributions. A forfeiture is defined as a non-vested amount remaining in a terminated participant account after the earlier of a) the distribution of his or her vested account balance or b) five consecutive one-year breaks in service. Forfeitures may be used to reduce Plan Sponsor contributions or pay plan expenses. Total outstanding forfeitures remaining are included in investments on the accompanying statements of net assets available for benefits and amounted to \$13,938 and \$13,110 as of December 31, 2024 and 2023, respectively. Forfeitures used to fund employer matching contributions are reported in net employer contributions on the statement of changes in net assets available for benefits. For the Plan years ended December 31, 2024 and 2023, zero forfeitures were used to fund employer matching contributions.

2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements for the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires the Plan's management to make estimates and assumptions that affect certain reported amounts reported in the financial statements, accompanying notes, and supplemental schedule. Actual results may vary from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits and Receipt of Contributions

Benefits paid to participants are recorded when paid. Contributions are recorded when deemed a receivable by the Plan.

Excess Contribution Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with corresponding reduction to contributions. There were no excess contributions payable for the years ended December 31, 2024 or 2023.

Administrative Expenses

Certain administrative expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to notes receivable from participants and benefits paid to participants are charged directly to the participant's accounts and are included in administrative expenses on the statement of changes in net assets available for benefits. Investment related expenses are included in net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

3) INFORMATION PREPARED AND CERTIFIED BY PLAN CUSTODIAN

The Plan Sponsor has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the Custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- a. Investments, at fair value, as shown in the statements of net assets available for benefits, as of December 31, 2024 and 2023.
- b. Dividend income and net appreciation in fair value of investments, as shown in the statement of changes in net assets available for benefits, for the year ended December 31, 2024.
- c. The Form 5500, Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown in the supplemental schedule.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

4) FAIR VALUE MEASUREMENTS

Valuation techniques used to measure fair value use a hierarchy, which gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Quoted prices in active markets for identical assets or liabilities

Level 2 – Valuations based on inputs other than quoted prices included within Level 1 that are observable, either directly or indirectly, such as quoted prices in markets that are not active; other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 – Valuations based on inputs that are unobservable and significant to the overall measurement.

The assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the classification of assets and liabilities within the fair value hierarchy. Because of the long-term nature of certain assets and liabilities measured at fair value as well as differences in the availability of market prices and market liquidity over their terms, inputs for some assets and liabilities may fall into any one of the three levels in the fair value hierarchy. GAAP requires these assets and liabilities to be classified in the lowest level in the hierarchy for which inputs are significant to the fair value measurement; a portion of that measurement may be determined using inputs from a higher level in the hierarchy.

4) FAIR VALUE MEASUREMENTS (CONTINUED)

The availability of valuation techniques and observable inputs can vary from investment to investment and is affected by a wide array of factors. In certain cases, the inputs used to measure fair value may fall into different levels of the hierarchy. For disclosure purposes, the level in the hierarchy within which the fair value measurement in its entirety falls is determined based on the lowest level input that is significant to the fair value measurement. The estimated values do not necessarily represent the amounts that may be ultimately realized due to the occurrence of future circumstances that cannot be reasonably determined.

To the extent that a specific valuation is based on models or inputs that are less observable or unobservable in the market, the determination of fair value requires more judgment. As such, the degree of judgment exercised by the Plan in determining fair value is greatest for investments in Level 3.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

- *Mutual funds of registered investment companies.* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Self-Directed Brokerage Accounts.* The self-directed accounts can hold cash, money market funds, common stock, mutual funds, exchange traded funds, and exchange traded notes. The common stock is valued at the closing price on an actively traded market. The mutual funds, exchange traded notes, and exchange traded funds are all valued at the net asset value per share, which are traded on an active market. The money market funds are valued based upon the net asset value provided by the fund manager.

5) NON-PARTICIPANT DIRECTED INVESTMENTS

The Plan's participants direct all investments. There are no non-participant directed investments as of December 31, 2024 and 2023.

6) RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Reliance Trust, the Custodian as defined by the Plan, manages certain investment options. Fees paid by the Plan for the investment services are included in the administrative expenses reported on the statement of changes in net assets available for benefits.

Certain administrative functions are performed by officers and employees of the Company for which the officers or employees receive no compensation from the Plan nor is the Plan charged by the Company for these services.

These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

7) PLAN TERMINATION

Although no intent to do so has been expressed, the Sponsor has the right under the Plan to discontinue its contributions, if any, at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Plan assets will be distributed in accordance with the Plan document.

8) TAX STATUS

Effective May 1, 2022, the Plan is based on a volume submitter plan developed by ADP, LLC, which received a favorable determination letter dated October 6, 2020 from the IRS stating the Plan constitutes a qualified plan under Section 401 of the Internal Revenue Code.

GAAP requires Plan management to evaluate the tax positions taken by the Plan and recognize a liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the DOL or IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9) RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect a participants' account balance and the amounts reported in the statements of net assets available for benefits.

10) SUBSEQUENT EVENTS

The Plan has evaluated events that occurred through July 23, 2025, which is the date these financial statements were available to be issued.

Effective January 1, 2025, the Company elected the traditional safe harbor match option, which is safe harbor match contributions equal to 100% on the first 3% of a participants elective deferrals that does not exceed 3% of participants compensation deferred, plus 50% of the amount to participants elective deferrals that exceed 3% of the participants compensation, but not to exceed 5% of the participants compensation deferred.
