Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed audits of the accompanying financial statements of Sovereign Consulting Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

A. DESCRIPTION OF PLAN

The following description of the Sovereign Consulting Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Sovereign Consulting Inc. (the "Company"). All employees who are age twenty-one or older are eligible to participate in the salary deferral portion of the Plan, except certain types of employees, as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Company appointed Reliance Trust Company (the "Trustee") as trustee of the Plan's assets. Under the terms of the agreement between the Trustee and the Plan, the Trustee has the primary duty and responsibility to administer, manage and control the assets of the Plan. The record keeping function of the Plan is the responsibility of ADP Retirement Services.

Effective May 1, 2022, the Plan was restated to conform to the required Cycle 3 restatements.

Contributions

Each year, participants may elect to defer 1% to 86% of their annual compensation to be contributed directly to the Plan, subject to Internal Revenue Code ("IRC") specified limits. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Effective January 1, 2017, the Plan was amended to permit post-tax (Roth) contributions to the plan. The Company provides a matching contribution of fifty percent (50%) of eligible participant contributions to the Plan, up to a maximum of eight percent (8%) of each participant's compensation, not to exceed \$1,375.

The Company may also elect to make discretionary non-elective contributions. The Company did not make non-elective contributions in 2024.

Participants' Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching and non-elective contributions and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their own contributions, all rollovers and transfers from qualified plans and actual earnings or losses thereon. Vesting in the Company's matching and non-elective contribution portions of their accounts is based on years of service. A participant becomes vested as follows:

Expenses of the Plan

The Plan's administrative expenses are paid primarily by the Company, as provided by the Plan document. Certain expenses, such as brokerage fees, are borne by the participant. The Plan's investment advisor, Merrill Lynch, Pierce, Fenner & Smith, Incorporated ("Merrill Lynch") charges the Plan a fixed annual rate for fiduciary services related to the Plan's investment options. Merrill Lynch's fee is paid through investment-related fund revenue. If investment-related fund revenue exceeds Merrill Lynch's fees, the excess revenue is deposited into the Plan's expense account and can be used to pay for future Plan expenses. During the year ended December 31, 2024, \$16,434 of excess revenue collected by Merrill Lynch was deposited into the Plan. This is presented as other income on the statement of changes in net assets available for benefits. As of December 31, 2024 and 2023, \$8,930, and \$11,224, respectively, was available in the Plan's expense account.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$15,961 and \$123, respectively. These amounts will be used either to reduce future employer contributions or to pay Plan expenses. For the year ended December 31, 2024, \$9,190 of forfeitures were used to reduce employer contributions.

If a participant receives a distribution as the result of termination and subsequently returns to employment as an active participant within five years from the date of the break in service, the forfeited amount will be restored. The participant must repay to the Plan the full amount of the distribution attributable to his or her employer contribution.

Upon Plan termination, after forfeitures have been restored and all Plan expenses incurred in connection therewith which may permissibly be charged to the Plan under ERISA have been paid by the Plan, any unallocated forfeitures will be reallocated among the remaining Plan participants on a per capita basis.

Payment of Benefits

Upon termination of service due to death, disability or normal retirement, a participant or beneficiary will receive 100% of his or her vested account balance as a lump-sum distribution or have the amount deposited directly into another qualified retirement account. If the Company establishes a group annuity contract, participants will have the option to receive his or her vested benefits as a life annuity (if not married) or a joint and survivor annuity (if married), subject to Plan and regulatory restrictions.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are treated as distributions based upon the terms of the Plan document. Participants may borrow from their account a minimum of \$500 and up to a maximum amount equal to the lesser of 50% of their vested account balance, or \$50,000. The notes receivable are secured by the vested balance in the participants' accounts and must bear a reasonable rate of interest at the time of the borrowing. Principal and interest are paid over a period of up to five years, with equal installments no less frequently than quarterly. Loans up to 30 years are permitted for the purchase of a principal residence. Participants are permitted to have a maximum of one outstanding note receivable at any time. Shareholders of the Company are not permitted to borrow from their accounts. The interest rate on notes receivable from participants ranged from 5.25% - 10.50% as of December 31, 2024 and 2023.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's management determines the Plan's valuation policies utilizing information provided by the Trustee. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions for the year ended December 31, 2024.

Subsequent Events

Management has evaluated subsequent events for potential recognition and disclosure that occurred through July 23, 2025, the date the financial statements were available to be issued. No items were determined by management to require disclosure.

D. FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in less active markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common collective trust: valued at net asset value ("NAV") as reported to the Plan by the Trustee based on the market values of the underlying investments of the fund. The fund is not required to publish a daily NAV, therefore the NAV is a practical expedient in determining the fair value of the funds.

Mutual funds: valued at the net asset value of shares held by the Plan at year end. The NAV is calculated as of the close of the New York Stock Exchange ("NYSE") each day the NYSE is open.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value Levels

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period.

E. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company reserves the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants' rights to their accrued benefits are non-forfeitable.

F. TAX STATUS

The Plan adopted a non-standardized form of a prototype plan sponsored by Automatic Data Processing. The prototype plan has received an opinion letter from the IRS as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by the Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

U.S GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

G. RISKS AND UNCERTAINTIES

The Plan provides for investments in various investment securities. Investment securities in general are exposed to various risks, such as those involving interest rates, credit and overall market volatility. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

H. TRANSACTIONS WITH PARTIES-IN-INTEREST

Some of the Plan trustees are participants of the Plan. During the year ended December 31, 2024, the Plan paid \$18,969 to the Trustee for services provided during the year.
