For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1 Description of Plan

The following description of the Dix 1898, Inc. 401(k) Plan ("Plan") provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General:

The Plan was created October 1, 1993 by Dix 1898, Inc. ("Company"), and covers all employees of the Company and its subsidiaries, Full Spectrum Marketing, WWST radio station, and Mock Woodworking, LLC, who meet the eligibility requirements.

WWST radio station sold in February 2024 and Full Spectrum Marketing sold in December 2024.

Eligibility:

The Plan is a defined contribution plan with a "salary reduction" provision. The Plan covers all full-time employees who are age 18 and older and have one month of service, and part-time employees who are age 21 and older and have 1,000 hours of service. An employee may become a participant as of the first day of the month following the date on which he/she meets the eligibility requirement.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions:

Cash or Deferred Option [401(k)] - Participants may elect a portion of their compensation to be contributed to the Plan by the Company but may not exceed the dollar limit set by law. The Plan includes automatic deferral and increase features. Accordingly, the Company will automatically withhold 4% of the participant's compensation and contribute that amount to the Plan as either a pre-tax or Roth deferral unless the participant makes a contrary election. In addition, the automatic deferral percentage will increase by 1% per year up to a maximum of 10% unless the participant makes a contrary elective. The automatic increase will be effective January 1, beginning with the first Plan year following the date the deferrals were automatically withheld from the participant's compensation.

Employer Matching Contributions - The Company may make discretionary contributions to each eligible participant's account by matching a percentage of the Participant's elective deferral for the Plan year. The total match allocated to Plan participants will be determined each year by the Company. The Company provides for a discretionary matching of contributions of 40% on the first 6% of the participant's eligible compensation for all employees other than Mock employees, and 50% on the first 6% of the participant's eligible compensation for all Mock employees, both of which are remitted to the Plan each pay period.

1 Description of Plan, Continued

Contributions, Continued:

Employer Profit Sharing Contributions - The Company may also make discretionary profit sharing contributions. Such additional contributions, if any, shall be allocated to each eligible participant in proportion to his or her compensation for the calendar year. Employees must be employed as of the last day of the Plan year and have worked at least 1,000 hours during the Plan year to be eligible for the additional discretionary profit sharing contribution. Eligible Mock employees received \$38,632 (2024) and \$22,387 (2023) in discretionary employer profit sharing contributions.

Rollover contributions from other Plans are also accepted, providing certain specified conditions are met. The Plan also allows for in-plan Roth rollover contributions of a participant's pre-tax deferral balance.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code, as defined in the Plan agreement.

Participants' Accounts:

Each participant's account is credited with the participant's elective contributions, employer matching contributions, employer profit sharing contributions, earnings, and losses thereon.

Vesting:

Plan participants are 100% vested in their salary deferral amounts contributed to the Plan. Vesting in the remainder of a participant's account balance is based on years of service. A participant is vested as follows:

Forfeitures:

Forfeited non-vested accounts totaled \$18,513 (2024) and \$1,958 (2023). Future employer contributions will be reduced by these amounts.

Other Plan Provisions:

Normal retirement age is 65, however, a participant may elect early retirement on or after age 55. The Plan also provides for early payment of benefits after reaching age 59-1/2 or for participants with at least sixty months of participation.

1 Description of Plan, Continued

Benefit Payments:

Upon termination of service by reason of separation of service, retirement, death or total and permanent disability, a participant is entitled to receive the balance equal to the vested interest of his or her account. Participants may elect to receive their benefits in a lump sum, installment payments, or partial withdrawals.

Investment Options:

Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan.

2 Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's transactions are reported on the accrual basis of accounting.

Valuation of Investments:

Investments are stated at fair value. Marketable securities are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker.

The fair value of the Stable Value Fund is calculated by dividing the total assets of the fund, less its liabilities, by the total number of units outstanding at the time of such computation.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments purchased and sold as held during the year.

Use of Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2 Summary of Significant Accounting Policies, Continued

Administrative Fees:

Substantially all administrative fees are paid by the Plan unless paid for by the Company.

Risks and Uncertainties:

The Plan's investment includes investments in a stable value fund and mutual funds holding investment contracts with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Plan Benefits.

Subsequent Events:

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through July 23, 2025, which is the date the financial statements were available to be issued.

3 Tax Status

On June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended, however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

4 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- * Quoted prices for similar assets or liabilities in active markets.
- * Quoted prices for identical assets or similar assets or liabilities in inactive markets.
- * Inputs other than quoted prices that are observable for the asset or liability.
- * Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds:

The fair value of the mutual funds are based on quoted market prices. These are classified in the Level 1 category of the valuation hierarchy.

Stable Value Fund:

The fair value of the Stable Value Fund (“Fund”) is based on the underlying assets of the fund. The fair value is expressed in units. The Fund is classified in the Level 2 category of the valuation hierarchy. Participant transactions (purchases and sales) may occur daily. The Fund primarily invests in a New York Life Group Annuity Contract issued by New York Life Insurance Company to Reliance Trust. Full withdrawal of funds for reasons other than participant transfers and benefit payments requires a 12-month advance written notice.

We identified no material inconsistencies in performing and completing our audit.

We encountered no significant difficulties in dealing with management relating to the performance of the audit.
