Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hughes Brothers, Inc. 401(k) Plan for Bargaining Unit Employees (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

1. Description of the Plan

The following description of the Hughes Brothers, Inc. 401(k) Plan for Bargaining Unit Employees (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan was established effective July 1, 1996 and is a defined contribution plan covering the bargaining unit employees of the plan sponsor, Hughes Brothers, Inc. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility – Employees become eligible to participate in the Plan upon completion of a sixty-day employment period. Employees become eligible for Company matching and discretionary contributions upon completion of a twelve consecutive month employment period during which at least one thousand hours of service, as defined in the Plan document, have been completed.

Contributions – Participants may contribute up to 100% of their annual compensation, as defined in the Plan, not to exceed the maximum allowed by the Internal Revenue Code through either pre-tax or after-tax Roth contributions. Participants aged fifty and older by the end of the calendar year may contribute catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit plans (rollover). Employer contributions include a matching contribution equal to 50% of the participant contributions up to 7% of eligible employee compensation (maximum of 3.5% of participant compensation). Participants also receive a base contribution of an amount up to \$1,450 from the employer determined upon hours worked and years of service. In addition, the Company made discretionary contributions of \$860,000 and \$800,000 for the years ended December 31, 2024 and 2023, respectively. Allocation of discretionary contributions is based on the ratio of points earned by a participant for hours of service to the total points earned by all participants during the year. Participants direct the investment of all contributions into the investment options offered by the Plan.

Participant Accounts – Individual accounts are maintained for each Plan participant. Each account is credited with the participant elective contributions, the employer matching, base and discretionary contributions. Participant accounts are allocated investment income and loss and administrative expenses that are paid by the Plan. Allocations are based on account balances or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. **Description of the Plan - Continued**

Vesting – A participant’s interest is fully vested at all times in all elective employee contributions plus actual earnings and losses thereon. A participant’s interest in matching, base and discretionary employer contributions is subject to the following vesting schedule:

3 years	50%
4 years	75%
5 years or more	100%

In the event that the participant dies, is disabled or if retirement conditions are satisfied, the participant’s entire account becomes fully vested.

Payment of Benefits – On termination of service a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested account, or an installment distribution. If the vested account balance is less than \$5,000, a lump sum distribution will be made.

Forfeitures – Forfeited participant balances are retained by the Plan and used to offset future Company contributions. There were no significant forfeitures available to the Company as of December 31, 2024 and 2023. Forfeitures used to offset Company contributions during the years ended December 31, 2024 and 2023 were \$9,332 and \$18,319, respectively.

2. **Summary of Significant Accounting Policies and Procedures**

Basis of Accounting – The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. **Summary of Significant Accounting Policies and Procedures - Continued**

Investment Valuation and Income Recognition – Plan investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value investments.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation of fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless paid directly by the Company. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events – Plan management evaluated transactions and events occurring subsequent to December 31, 2024, and through July 28, 2025, the date the financial statements were available to be issued, to determine whether any events should be recognized or disclosed in these statements. There were no material transactions or events in the subsequent period requiring disclosure or recognition in the statements.

3. **Investments**

4. Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. Plan Termination

The Company is obligated under its contract with the International Association of Machinists and Aerospace Workers to maintain the Plan through February 2026. Although it has not expressed any intent to do so, the Company has the right to discontinue contributions to the Plan and terminate the Plan after February 2026 subject to the provisions of ERISA. If the Plan is terminated or if employer contributions are discontinued, participants will become fully vested and if terminated, the assets of the Plan will be distributed to the participants as specified in the Plan agreement.

6. Tax Status

The IRS has determined and informed the Plan sponsor, by a letter dated June 27, 2014, the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The plan administrator believes the Plan has no significant uncertain tax positions. Therefore, no provision or liability for uncertain taxes has been recorded in the financial statements.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.
