Opinion

NOTE 1 - BACKGROUND AND ORGANIZATION

The American Association of Advertising Agencies (AAAA) established the AAAA Group Insurance Trust (the Trust) for the purpose of providing group insurance benefits to member agencies. The accompanying financial statements reflect the financial position and operating results of the Trust.

AAAA Benefits, Inc., a wholly owned subsidiary of AAAA, manages the Trust for the benefit of participating member agencies. The general purpose of the Trust is to provide participating AAAA member agencies' employees and retirees life, accidental death, long-term and short-term disability and other similar insurance benefits through insurance policies issued by licensed insurance carriers.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Billings to Advertising Agencies and Insurance Premiums Ceded

The Trust is a funding vehicle to provide insurance to members of the AAAA. The inflows and outflows from the Trust include billings to advertising agencies (inflows) and insurance premiums ceded (outflows). The net amount retained is used to pay accounting fees, management fees, and income taxes. Billings to advertising agencies are administered monthly based upon the employee base of each participating agency, the insurance coverage volume of each participating agency and the coverage rate established by AAAA Benefits, Inc. Premiums paid to insurance carriers are remitted monthly or quarterly based on negotiated coverage rates established by AAAA Benefits, Inc.

Due From Member Agencies

The Trust regularly evaluates its accounts receivable due from member agencies for collectability and establishes an allowance for doubtful accounts for those accounts, or portions thereof that management deems to be uncollectible. Management considers each member's payment history and other relevant information that is available. Accounts are written off when collection efforts have terminated. The Trust requires no collateral or other security from member agencies. No allowance for doubtful accounts exists at December 31, 2024 and 2023.

Concentrations

Amounts due from two and four controlled groups comprised greater than 10% of the total accounts receivable due from member agencies as of December 31, 2024 and 2023, respectively.

During the years ended December 31, 2024 and 2023, billings to one controlled group of member agencies represented more than 10% of total billings to advertising agencies.

Insurance premiums to one insurance carrier for life, accidental death, long-term and short-term disability insurance, dental and vision represented 88% and 90% of total insurance premiums paid for December 31, 2024 and 2023, respectively.

Cash on deposit with a bank regularly exceeds federally insured limits.

Income Taxes

The Trust accounts for income taxes under the asset and liability method whereby deferred tax assets and liabilities are measured using enacted tax laws and rates expected to apply to taxable income in the years in which the assets and liabilities are expected to be recovered or settled. The effects on deferred tax assets and liabilities of subsequent changes in the tax laws and rates are recognized in income during the year the changes are enacted.

In assessing the realizability of deferred tax assets, management considers whether it is more likely than not that some portion or all of the deferred tax assets will not be realized. The ultimate realization of deferred tax assets is dependent upon the generation of future taxable income during the periods in which those temporary differences become deductible. Management considers the scheduled reversal of deferred tax liabilities, projected future taxable income, carryback and carryforward periods and tax planning strategies in making this assessment.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in fund balance during the reporting period. Actual results could differ from those estimates.

NOTE 3 - RELATED-PARTY TRANSACTIONS

AAAA Benefits, Inc. provides administrative, accounting and other services in connection with the administration of the Trust. A management fee is determined annually based on estimated costs to be incurred by AAAA Benefits, Inc. For the years ended December 31, 2024 and 2023, management fees amounted to \$253,749 and \$253,598, of which \$232,118 and \$232,699 had been paid as of December 31, 2024 and 2023, respectively.

During the years ended December 31, 2024 and 2023, insurance billings received from entities related to AAAA Benefits, Inc. totaled \$232,104 and \$214,619, of which \$222,231 and \$202,232 had been paid as of December 31, 2024 and 2023, respectively.

The Trust is maintained for the receipt of billings from member agencies, the payment of insurance premiums to the insurance companies and the payment of management fees to AAAA Benefits, Inc. The Trust is a taxable trust; however, the operations are intended to break-even on an annual basis.

The reported income tax expense approximates the tax determined by applying the applicable U.S. federal and statutory income tax rates to the excess (deficit) from operations before income taxes. The Trust recognizes interest and penalties related to income taxes as a component of income tax expense.

The Trust files a tax return in the U.S. federal and New York state jurisdictions. With few exceptions, the Trust is not subject to U.S. federal, state and local or non-U.S. income tax examinations by tax authorities for years before 2020. The Trust does not have any open examinations by any taxing authorities.

NOTE 5 - TERMINATION

The Trust may be terminated at any time by the unanimous concurrence of the Trustees and the written approval of the AAAA, provided that written notice of termination is provided to the member agencies. The Trust may also be terminated by a majority of the member agencies. In the event of termination, the assets of the Trust shall first be used to pay administrative expenses and to satisfy liabilities to existing beneficiaries. Thereafter, all remaining funds shall be applied to benefits for the participants based on a uniform percentage of member agency contributions made on behalf of each participant at the time of Trust termination.

NOTE 6 - SUBSEQUENT EVENTS

The Trust evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through June 16, 2025, the date the financial statements were available to be issued. All subsequent events requiring recognition and disclosure have been incorporated into these financial statements.
