Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Kickhaefer Manufacturing Company 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

General

The Plan is a participant-directed contribution plan sponsored by Kickhaefer Manufacturing Company, LLC (the Company). Employees who are 19 or older are eligible to participate in the Plan on the first day of the month following the completion of two consecutive months of employment.

Contributions

Each year, participants can contribute a percentage of their annual compensation, as defined in the Plan document, subject to the maximum allowed by the Internal Revenue Service (IRS). Participants may also contribute distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated target fund until changed by the participant.

The Company's discretionary match was 50% of the first 6% of the participant's salary deferral election. The Company may make discretionary profit sharing contributions to the Plan. There was no discretionary profit sharing contribution in 2024 and 2023.

Funding

The Company remits participant and Company discretionary matching contributions to the Plan as soon as practical after amounts are withheld from participant wages. The Company's discretionary profit sharing contribution, if any, is annually remitted to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and Company discretionary matching contribution, allocations of the Company's discretionary profit sharing contribution, if any, Plan earnings (losses), and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. Company contributions and any earnings (losses) thereon vest at a rate of 20% per year beginning with the second year of service. Participants become fully vested after six years of service.

A participant is fully vested upon the attainment of normal retirement age, death or disability.

Forfeitures

Forfeitures are portions of participant account balances that participants surrender by terminating employment with the Company prior to becoming fully vested. Forfeitures are used to reduce the Company's contributions. If a terminated participant is reemployed and fulfills certain requirements, the participant's account can be restored. During 2024 and 2023, \$94,896 and \$40,583, respectively, of forfeitures reduced the Company's discretionary matching contributions. At December 31, 2024 and 2023, there was \$38 and 574, respectively, of unallocated forfeitures.

Payment of Benefits

Upon retirement at normal retirement age, disability, death, or termination of employment, a participant or his or her beneficiary can elect to receive either a lump-sum amount equal to the value of his or her vested account, or monthly, quarterly, semi-annual, or annual installments. Participants may elect a combination of the two methods of distribution. In addition, hardship distributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2. Participant accounts between \$1,000 and \$7,000 will be paid in a direct rollover to an individual retirement account and participant accounts less than \$1,000 will be paid in a lump-sum distribution.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that directly affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

Note 2: Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments include the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits paid to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain administrative expenses related to distributions directly attributable to a participant's transaction are deducted from that participant's account. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Subsequent events have been evaluated through July 21, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Note 3: Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Valued as determined by the issuer of the common/collective trust using NAV per share measurement. The Reliance/MetLife Stable Value Fund (Stable Value Fund) is a common/collective trust with underlying investments in fully benefit-responsive investment contracts. Their objective is to preserve principal while generating earnings at rates competitive over time with short-term high quality fixed income investments while maintaining sufficient liquidity. The Stable Value Fund invests in traditional and synthetic guaranteed income contracts with various crediting formulas. The Stable Value Fund manager may limit withdrawals in order to maintain sufficient liquidity.

Investments in the common collective trust can be purchased and sold continuously. A notice of redemption is not required. The Plan has no obligation to buy additional units.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: Information Prepared and Certified by the Custodians

Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information certified as complete and accurate by Reliance Trust Company, custodian, from January 1, 2023 through June 27, 2024 and Transamerica Trust Company, custodian, from June 28, 2024 through December 31, 2024.

Note 5: Income Tax Status

The Company adopted a pre-approved plan offered by Transamerica Retirement Solutions LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6: Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue or amend its contribution amounts at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 7: Risks and Uncertainties

The Plan's investments are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Note 8: Party-In-Interest

As noted in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions qualify as party-in-interest transactions. These transactions are not, however, considered prohibited under ERISA.
