1. **Eligibility:** All employees are eligible on the January 1 or July 1 following the completion of one Year of Service and attainment of age 21. Participation in the plan was frozen as of December 31, 2009.
2. **Normal Retirement Date:** First of the month following the attainment of age 65.
3. **Early Retirement Date:** First of the month coinciding with or next following: the attainment of age 53 and the completion of 20 years of service, or attainment of age 55 and the completion of 15 years of service.
4. **Compensation:** Gross compensation for the year ending December 31.
5. **Average Compensation:** The average of total compensation during the 5, or lesser-completed, consecutive plan years within the last 10 years of service which produce the highest average.
6. **Normal Retirement Benefit:** The sum of (i) and (ii):
 - (i) 1.10% of Average Compensation not in excess of covered compensation
 - (ii) 1.50% of Average Compensation in excess of covered compensationMultiplied by years of participation with a maximum of 35 years for part (ii).

Benefits were frozen as of December 31, 2009.
7. **Early Retirement Benefit:** The unreduced Normal Retirement Benefit is payable to a participant who at the time of termination of service has attained age 53 and has completed at least 20 years of service. In all other cases the Normal Retirement Benefit accrued as of the date of termination of service will be reduced by 1/15th for each of the first five years prior to Normal Retirement Date, 1/30th for the next 5 years and actuarially thereafter.
8. **Accrued Benefit:** Projected benefit at Normal Retirement Date multiplied by a fraction equal to (a) years of participation as of the date of determination, divided by (b) total years of participation at Normal Retirement Date.

Benefits were frozen as of December 31, 2009.
9. **Standard Form of Retirement Benefit:** Ten Year Certain and Life Annuity. If the Participant is married the benefit must be converted to an actuarially equivalent Joint & Survivor Annuity, unless elected otherwise with spousal consent.
10. **Disability Benefit:** Upon retirement due to Total and Permanent Disability, the Early Retirement Benefit is payable.
11. **Death Benefits:** Upon death prior to retirement, the 50% Pre-Retirement Survivor Annuity is payable based on the Normal or Early Retirement Benefit.
12. **Termination of Employment:** Upon termination of employment prior to retirement, death, or disability, the vested Accrued Benefit is payable.
13. **Vesting:** Vested in the accrued benefit based on years of service. 0% for less than 5 years increasing to 100% on or after 5 years. A year of vesting service is credited for each Plan Year in which an employee completes at least 1,000 hours of service.
