## **Independent Auditors' Report**

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of 403(b) Thrift Plan for Congregation of the Daughters of Divine Charity, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### **1. Description of Plan**

The following description of the 403(b) Thrift Plan for Congregation of the Daughters of Divine Charity, Inc. (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan established by Congregation of the Daughters of Divine Charity, Inc. (the "Congregation" or "Employer") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Congregation is the sponsor of the Plan and the insurance company is Mutual of America Life Insurance Company ("Mutual of America" or the "Insurance Company"). The insurance company manages the investments of the Plan. In addition, the insurance company provides recordkeeping services for the Plan. Effective December 1, 2017, the Plan was amended to include the following employers: St. Mary's Residence of New York, Inc. and St. Joseph Hill Academy.

#### ***Eligibility***

Employees are eligible to participate in the Plan on the first day of the pay period coinciding with or immediately following their date of hire. All employees are eligible to participate and make salary reduction contributions to the Plan. All employees who are at least 21 years of age are eligible to receive Congregation contributions on the first date of the month coinciding with or immediately following their date of hire. Upon enrollment in the Plan, a participant may direct contributions to any combination of available investments options.

#### ***Participant Accounts***

Each participant's account is credited with an allocation of the Congregation's contributions and, as applicable, the participant's contribution, rollover contributions, and an allocation of Plan earnings (net of administrative expenses). Allocations are based on the participant's eligible compensation or account balances, as defined by the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

#### ***Contributions***

Eligible employees, who elect to enter into a salary reduction agreement, may contribute their eligible income, up to the lesser of the Internal Revenue Code ("IRC") annual limit or the participant's eligible compensation for the year, as defined by the Plan Document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Congregation may also make a discretionary matching contribution. In 2024, the Company matched 50% of a participant's deferral, up to 4% of the participant's eligible compensation. This match totaled \$75,914 for the year ending December 31, 2024.

***Contributions (continued)***

Additionally, the Congregation may make discretionary base contributions to all employees enrolled in the Plan regardless of whether the employee is making contributions. The contribution is calculated as a percentage of the participant's eligible compensation. The Congregation can change this percentage at their discretion. The percentage can also be different for each organization participating in the Plan. For the year ended December 31, 2024, Congregation of the Daughters of Divine Charity, Inc. and St. Mary's Residence of New York, Inc. chose 1% as their discretionary contributions and St. Joseph Hill Academy chose 3% as their discretionary contribution. For the year ending December 31, 2024, this discretionary base contribution totaled \$128,383.

***Vesting***

Participants are 100% vested in their contributions plus actual earnings thereon. Vesting in the Employer's contributions are as follows:

***Loans to Participants/Collateralized Assets***

Participants may borrow from Mutual of America and use their Plan account balance (invested in the guaranteed interest contract) as collateral. Participants may borrow a minimum of \$1,000 up to a maximum of the lesser of one-half of their vested account balance or \$50,000. The loan bears interest at a rate commensurate with local prevailing rates at the time the funds are borrowed as determined by Mutual of America. Loan terms range from 1 to 5 years; however, terms may exceed 5 years, but not to exceed 10 years, for the purchase of a primary residence. The collateral must be equal to or exceed 120% of the loan, and payments on the loan are made outside the Plan. Therefore, the loans are not shown on the statements of net assets available for benefits. As of December 31, 2024 and 2023, the total outstanding Plan loans collateralized by individual participant accounts were \$9,114 and \$17,900.

Of these loan balances, there were none in default as of December 31, 2024 and 2023. At December 31, 2024, the loans had an interest rate of 5.85% with maturities through 2029.

***Payment of Benefits***

Benefits may be paid to a participant or beneficiary upon the following events: death, disability, termination of employment, or attaining the age of 59½ as defined in the Plan Document. Upon completing at least five years of service, a participant may withdraw any amounts allocated to the Employer contribution accounts. In addition, a participant may qualify for a hardship distribution as defined in the Plan Document. The payment of benefits under the Plan is governed by IRC Section 403(b) and the investment contract distribution restrictions. The Plan permits the recipient to elect distribution of benefits in the form of a lump-sum, installments or various annuity forms, subject to the terms of the Plan.

***Forfeitures***

If a participant terminates employment and is less than 100% vested in their Employer contributions, the participant will forfeit the non-vested portion of their account. Forfeited non-vested amounts are used to reduce Employer contributions. At December 31, 2024 and 2023, the forfeited non-vested accounts totaled \$0 and \$531. During 2024, forfeitures of \$531 were used to reduce Employer contributions.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting and Use of Estimates***

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Investments in separate accounts are valued based on the fair value of the underlying assets as determined by the insurance company and reported to the Plan. The investment in the insurance company general account is reported at fair value, which is based on the contract value as reported by the insurance company. Contract value represents contributions made under the contract, plus interest credited, less benefits paid and expenses. Because the investment is not actively traded and relies on valuation inputs provided by the insurance company, it is considered an estimate of fair value.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded when paid.

***Expenses***

Certain expenses of maintaining the Plan may be paid by the Employer and are excluded from these financial statements. Certain administration fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

***Reclassifications***

Certain amounts in the 2023 financial statements have been reclassified to conform to the 2024 presentation. Such reclassifications had no impact on the Plan's net assets or changes in net assets.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is July 29, 2025.

**3. Information Certified (Unaudited)**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments held at December 31, 2024 and 2023, and the net appreciation in fair value of investments, interest income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America Life Insurance Company, a qualified institution.

**5. Insurance Company General Account**

Amounts placed in the Mutual of America Interest Accumulation Account are credited with interest at a rate determined by Mutual of America. Mutual of America guarantees to credit interest for the life of the contract to amounts in the Interest Accumulation Account of the general account at a rate at least equal to the greater of: (1) any contractual minimum guarantee provided by the contract; or (2) the minimum rate required by applicable state law or, if no state law minimum rate is applicable to a contract, the minimum guaranteed credited interest rate will be set pursuant to National Association of Insurance Commissioners ("NAIC") standard non-forfeiture law. The NAIC minimum rate is determined in accordance with a formula, and cannot be less than 1.00% or more than 3.00% in any event. Mutual of America determines whether the application of the formula will change the minimum guaranteed rate each November, and any change is effective the following January 1 for that calendar year.

The Mutual of America Interest Accumulation Account is not a fully benefit-responsive investment contract and may be subject to withdrawal or transfer restrictions under certain plan or contract provisions.

The interest rate under that contract will not go below that amount regardless of the minimum rate that is set for a calendar year. In Mutual of America's sole discretion, they may credit a higher rate of interest to a participant's contract in the general account, although they are not obligated to credit interest in excess of the minimum guaranteed rate. Mutual of America compounds interest daily on the contract amounts in the general account to produce an effective annual yield that is equal to the stated interest rate.

The Mutual of America Interest Accumulation Account represents approximately 21% and 22% of the net assets available for benefits as of December 31, 2024 and 2023.

**6. Separate Accounts**

The Plan offers various separate accounts as investment options under the Plan. The separate accounts have different investment objectives, investment policies, and risks. The name of each separate account corresponds to the name of the underlying fund in which it invests. When contributions or transfers are made to a separate account, the separate account purchases shares in the appropriate underlying fund.

**7. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Employer contributions.

**8. Tax Status**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (“IRC”). The Plan administrator and the Plan’s tax counsel believe that the terms of the Plan have been prepared to conform with the requirements of Section 403(b) of the IRC, and is currently being operated in conformity with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

**9. Exempt Party-in-Interest Transactions**

All investments of the Plan are managed by Mutual of America Life Insurance Company, the asset holder and record-keeper of the Plan. Therefore, these transactions qualified as exempt party-in-interest transactions under ERISA. During the Plan year ended December 31, 2024 fees in the amount of \$944 were paid to Mutual of America for Plan related services.

Certain employees of the Employer perform administrative services related to the Plan; the Employer pays the salaries of these individuals and no costs are charged to the Plan.

**10. Non-Exempt Party-in-Interest Transactions**

The Employer failed to remit to the Plan certain participants’ contributions within the period described by the Department of Labor’s regulations. The amounts by year are as follows:

In September 2024, the Employer made the necessary corrections to satisfy both the Department of Labor and IRS guidance for this matter for the delinquent contributions from 2023. For 2024, the Employer is in the process of correcting of making the necessary corrections.

**11. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.


