Independent Auditors' Report

To the Administrative Committee of the KPOST Company 401(k)

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the KPOST Company 401(k), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [(ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the KPOST Company 401(k)'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

1. Description of Plan

The following description of the KPOST Company 401(K) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan established by KPOST Company (the “Company”) under the provision of Section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in section 401(k) of the IRC, for the benefit of eligible employees of the Company. All employees of the Company who have completed at least six months of service, as defined in the Plan, are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Plan administration - The Plan is administered by the Pension Committee which is appointed by the Board of Directors of the Company. The Plan’s trustee, Empower Trust Company, LLC, (the “Trustee”), is responsible for the custody and management of the Plan’s assets.

Contributions - Each year, participants may contribute pre-tax and post-tax (Roth) contributions up to the maximum amount allowable under current law of their annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers an insurance investment contract with a General Account plus various mutual funds as investment options for participants.

The Plan provides for safe harbor matching contributions. Under the safe harbor rules of the Plan, the Company matches 100% of the individual participant’s salary deferrals, not to exceed 3% of the individual participant’s compensation, plus 50% of salary deferrals between 3% and 5% of the individual participant’s compensation. The Plan also provides for discretionary profit-sharing contributions. No discretionary profit-sharing contributions were made for the year ended December 31, 2024.

1. Description of Plan (continued)

Participant loans - Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions.

Participant accounts - Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution, Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, participant contributions or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Participants are also immediately vested in safe harbor matching contributions. Vesting in other Company contributions is based on years of continuous service. A participant is 100% vested after six years of credited service. A participant is also 100% vested upon death or disability.

Payment of benefits - For termination of service, under all circumstances, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution. Hardship withdrawals are permitted in certain situations as set forth in the Plan agreement.

Forfeited accounts - At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,761 and \$4,695, respectively. Pursuant to the provisions of the plan, forfeitures are reallocated to participants in the same manner as employer contributions. Forfeitures may be used for the payment of the Plan's administrative expenses. In 2024 and 2023, no administrative expenses were paid from forfeited accounts.

2. Summary of Significant Accounting Policies

Basis of accounting - The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

2. Summary of Significant Accounting Policies (continued)

Payment of benefits - Benefits are recorded when paid.

Investment valuation and income recognition - The Plan's investments are stated at fair value except for its investment contract which is valued at contract value (Note 3). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Expenses - Certain expenses of maintaining and operating the Plan are paid by the Company and are therefore excluded from these financial statements.

Excess contributions - The plan had no excess contributions payable to participants as of December 31, 2024 and 2023.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Reclassifications - Certain 2023 amounts have been reclassified to conform to the 2024 presentation.

3. Investment Contract with Insurance Company

The Plan is funded with a Group Annuity Contract issued by Empower Annuity Insurance Company of America (“Empower”). The contract offers a General Account plus various Separate Accounts, offering mutual funds from a variety of investment managers. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest rate that the issuer guaranteed to the Plan.

Because the general account contract is a traditional, fully benefit-responsive guaranteed investment contract, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The general account contract is presented on the face of the statement of net assets available for benefits at contract value.

Contract value, as reported by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative fees. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Contract value of the investment contract as of December 31, 2024 and 2023, was \$172,525 and \$151,444, respectively.

Certain events may limit the Plan’s ability to transact at contract value with Empower. Such events include complete or partial termination of the Plan, bankruptcy of the Plan sponsor or other Plan sponsor events which result in a significant withdrawal from the Plan, or the failure of the Plan trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Further, certain events may allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include a breach of the Plan’s investment guidelines, a material amendment to the contract without the issuer’s consent, a violation of a material obligation under the contract, or a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan’s ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The crediting interest rate, which resets on a quarterly basis, is based on a formula agreed upon with the issuer, with a guaranteed minimum interest rate.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

6. Fair Value Measurements

Generally accepted accounting standards establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Level 1 Fair Value Measurement

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Realized gains and losses included in changes in net assets available for benefits for the year ended December 31, 2024, are reported in net appreciation (depreciation) in fair value of investments.

7. Investments

Unaudited information certified by Empower Trust Company, LLC- The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, a qualified institution, has certified that the following investment information included in the accompanying financial statements and supplemental schedule is complete and accurate: investments in the statements of net assets available for benefits as of December 31, 2024 and 2023, of \$9,012,786 and \$8,316,999, respectively; participant notes receivable as of December 31, 2024 and 2023, of \$16,073 and \$22,732, respectively; net appreciation in fair value of investments of \$756,856, interest and dividends of \$435,300 and interest on notes receivable from participants of \$1,069 in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and the investment information included in the supplemental Schedule H, Part IV, Line 4i - Schedule of Assets (Held at end of Year) as of December 31, 2024.

8. Related-Party Transactions and Party in Interest Transactions

Certain Plan investments are shares of mutual funds managed by Empower Funds. Empower Funds is related to the Plan trustee and therefore qualifies as a party in interest. Empower Annuity Insurance Company of America provides recordkeeping services to the Plan and is a related party to the Plan trustee and therefore qualifies as a party in interest. The Retirement Advantage, Inc. provides contract administration services to the Plan and therefore qualifies as a party in interest. In 2024, fees paid to Empower Annuity Insurance Company of America and The Retirement Advantage, Inc. totaled \$7,522. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

9. Reconciliation of Financial Statements to Form 5500

As of December 31, 2024 and 2023, the plan had no pending distributions to participants who elected to withdraw from the Plan. Amounts allocated to withdrawing participants are recorded as a liability in the Plan's Form 5500, however, are not recorded as a liability in the financial statements in accordance with generally accepted accounting principles.

10. Tax Status

The Plan Sponsor established the plan with the Third- Party Administrator effective January 1, 2008 (restated November 1, 2021). The Internal Revenue Service has informed the Third-Party Administrator, by a letter dated June 30, 2020, that the Prototype Non-standardized Profit-Sharing Plan with CODA are acceptable under Section 401 of the Internal Revenue Code (“IRC”).

Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

11. Subsequent Events

Generally accepted accounting principles define the period after the balance sheet date during which management shall evaluate events or transactions that may occur for potential recognition or disclosure, the circumstances under which an organization shall recognize events occurring after the balance sheet date and the disclosures that an organization shall make about those events or transactions. Management evaluated all events and transactions that occurred after December 31, 2024, and through July 24, 2025, the date which the financial statements were available to be issued. The Company did not have any material recognizable subsequent events during this period.
