To The Trustees

Opinion

We have audited the accompanying financial statements of **Brethren Mutual Insurance Company 401(K) Retirement Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of **Brethren Mutual Insurance Company 401(K) Retirement Plan** as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of **Brethren Mutual Insurance Company 401(K) Retirement Plan** and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise a substantial doubt about **Brethren Mutual Insurance Company 401(K) Retirement Plan's** ability to continue as a going concern for one year after the date of the financial statements are available to be issued.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the *Brethren Mutual Insurance Company 401(K) Retirement Plan* (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established effective January 1, 1990 to provide retirement benefits for the employees of the Brethren Mutual Insurance Company (Plan Sponsor). The Plan is a defined contribution plan covering all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). For the years ended December 31, 2024 and 2023, the Plan's assets were held and managed by Fidelity Management Trust Company.

Eligibility

Employees are eligible to participate in the Plan after reaching 18 years of age and having completed six months of service.

Compensation

Compensation is defined as total compensation during a Plan year that is subject to income tax and is reflected on the employees Form W-2, but including any salary reduction contributions made to the plan.

Forfeitures

Forfeitures of non-vested account balances are transferred to the Plan's cash account and applied to reduce fees or employer contributions during the Plan year.

Contributions

Contributions can be in the form of discretionary Plan Sponsor profit sharing contributions, Plan Sponsor matching contributions, 401(k) elective contributions by employees up to 70% of their eligible compensation (subject to Internal Revenue Service limitations), and qualified participant rollovers from other qualified defined benefit or contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 6% of eligible compensation, increasing by 1% annually to a maximum of 15%.

The Plan Sponsor will match 50% of the first 6% of compensation that a participant contributes to the Plan. The Plan Sponsor may make discretionary contributions as determined by the Board of Directors of the Plan Sponsor. All contributions are participant-directed and are subject to certain limitations. Plan participants also have the option of contributing on a post-tax basis (Roth elective deferrals). The Plan allows plan participants to make catch up elective deferral contributions in a taxable year if the participant is age 50 or older, subject to Internal Revenue Service limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Plan Sponsor's contribution and Plan earnings (losses). Participant accounts are allocated administrative expenses as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

The Plan provides for individual self-directed accounts which permit participants to exercise investment control over assets held in their individual accounts. The Plan provides approximately 30 investment options to the plan participants. Participants should refer to the Plan Enrollment Form for descriptions of these options.

Vesting

Participants are immediately vested in their 401(k) employee elective deferral contributions, matching contributions of the Plan Sponsor, their vested rollovers from other plans, and actual earnings thereon. Vesting of Plan Sponsor discretionary contributions begin at 20% upon completion of two years of credited service, increasing 20% per year until fully vested at the end of the sixth year of credited service.

Retirement Eligibility

Upon attainment of 65 years of age, death, or determination of permanent and total disability, a participant becomes 100% vested regardless of the number of credited years of service. Pre-retirement withdrawals are permitted when the employee reaches 59.5 years of age.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate of 2% above prime rate at the time of issuance. Principal and interest is paid ratably through payroll deductions from each pay period.

Payment of Benefits

On termination of service, a participant may elect to either roll-over benefits or receive a lump-sum amount equal to the value of the participant's vested interest in their account.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accounting records of the Plan are maintained in conformity with accounting principles generally accepted in the United States. The accompanying financial statements are prepared on the accrual basis of accounting.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, which approximates fair value. Interest income is recorded on the accrual basis. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investment transactions are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Registered investment company investments are valued at quoted market prices as of the last business day of the reporting period. Common collective trusts are valued by the custodian using a market value approach related to the fair value of the underlying securities.

Payment of Benefits

Benefits payments to participants are recorded upon distribution.

Administrative Expenses

It is the policy of the Plan Sponsor to absorb most administrative expenses of the Plan. Forfeitures of non-vested account balances can be applied to reduce fees during the Plan year. Fees related to the distribution of benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts of assets and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Subsequent Events

Subsequent events were evaluated through July 28, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - TAX STATUS OF THE PLAN

The Plan has received a favorable determination letter from the Internal Revenue Service dated March 31, 2008 indicating that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been restated and amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe the Plan is qualified and the related trust is tax-exempt. Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan's Form 5500 is subject to examination by the Internal Revenue Service; plan years that remain open for examination include 2021 and later.

NOTE 4 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Plan assets would be valued and participants' accounts would be adjusted to reflect the allocation of net gains and losses of the underlying investments. At that time, participants' accounts would become fully vested and non-forfeitable.

NOTE 5 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 6 – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. FASB Accounting Standards Topic 820, Fair Value Measurements, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs on the hierarchy are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

As of December 31, the Plan's investments measured at fair value consisted of the following instruments and classifications within the fair value hierarchy.

The common/collective trusts consist of RT Metlife Stable Value Fund and Putnam Stable Value Fund at December 31, 2024 and 2023. The fair value is determined by the custodian using a market value approach related to the fair value of the underlying securities. The Plan's policy is to recognize transfers into and out of Level 2 as of date of the event or change in circumstances that cause the transfer.

NOTE 7 – PARTIES IN INTEREST

The Plan paid recordkeeping fees to Fidelity Management Trust Company of \$19,529 and \$84,075 for the years ended December 31, 2024 and 2023, respectively. The Plan paid advisory fees to Cambridge Investment Research of \$51,873 for the year ended December 31, 2024. The Plan paid advisory fees to Strategic Advisors of \$6,285 for the year ended December 31, 2024.

Certain plan investments are sponsored by the Plan Custodian, Fidelity Management Trust Company. Total investments held by the custodians at December 31, 2024 and 2023 that are party in interest transactions under ERISA amounted to \$100,166 and \$83,219 respectively. In addition, the Plan has notes receivable from plan participants that totaled \$210,085 and \$203,537 at December 31, 2024 and 2023 respectively, which are party in interest transactions under ERISA. These transactions are party in interest transactions that are exempt from the prohibited transaction rules of ERISA.
