We have audited the accompanying financial statements of the Amalgamated Union Local 450-A Welfare Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits (modified cash basis) for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits (modified cash basis) of the Amalgamated Union Local 450-A Welfare Fund as of December 31, 2024 and 2023 and the changes in its net assets available for benefits (modified cash basis) for the years ended December 31, 2024 and 2023, in accordance with the modified cash basis of accounting as described in Note 2.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Amalgamated Union Local 450-A Welfare Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements and supplemental information are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Amalgamated Union Local 450-A Welfare Fund's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.


In performing an audit in accordance with generally accepted auditing standards, we:

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

## Supplemental Schedules

Our audit was conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental information included on page 9 is presented for the purpose of additional analysis and is not a required part of the financial statements. The supplemental information is the responsibility of the plan's management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole.

**Note 1 - Description of Plan**

The following description of the Amalgamated Union Local 450-A Welfare Fund (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan provisions.

*General*

The Plan is a multiple employer defined benefit health and welfare plan covering substantially all members of the Amalgamated Union Local 450-A (the “Union”). The Plan was established on June 1, 2003 as a result of collective bargaining agreements between the Union and contributing employers (collectively, the “CBAs”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Administration of the Plan is the responsibility of the Board of Trustees (the “Trustees”) and is governed by a joint board consisting of equal representation from the participating employers and the Union.

The Plan’s Board of Trustees, as Sponsor, has the right under the Plan to modify the benefits provided to active members. The Plan may be terminated only by joint agreement between the participating employers and the Union, subject to the provisions set forth in ERISA.

*Benefits*

The Plan provides medical, prescription and dental benefits on a fully insured basis to those participants who are employed by a participating employer or employer association. Current health claims of active participants and their dependents and beneficiaries are provided under group insurance contracts with Empire Blue Cross Blue Shield, United Healthcare Oxford, Emblem Health (“HIP”) and Solstice Benefits, Inc., which are experience rated after the anniversary dates of the policies which are October 31 and December 31, respectively. It is the present intention of the Trustees and Plan’s Management to continue obtaining insurance coverage for benefits.

*Contributions*

The collective bargaining agreements require participating employers to pay contributions to the Plan on a per member, per month basis. In accordance with the CBAs, contributions to the Plan range from \$7.00 (vision benefits) to \$6,665 (medical benefits) and from \$7.00 (vision benefits) to \$6,584 (medical benefits), respectively, per member, per month, depending on the coverage opted into by the member for the years ended December 31, 2024 and 2023. Rates vary depending on the provider, plan, and level (employee, employee plus dependents, employee plus spouse, or employee plus family).

As of December 31, 2024, the Plan has one remaining employer, whose CBA was effective November 1, 2023 and expires on October 31, 2025.

*Eligibility*

To be eligible, an employee must be working for a participating employer who is subject to the CBA. The Plan provides benefits to eligible members and specified dependents. A member becomes eligible for benefits on the first day of the month following completion of a service waiting period. Each benefit has its own service waiting period. Once a member meets the initial eligibility requirement, loss of eligibility occurs from legal separation, divorce, death, termination of employment, reduction in the number of hours of employment or any loss of eligibility that is measured based on any of these events.

**Note 2 - Summary of Significant Accounting Policies**

*Basis of Accounting*

The financial statements have been prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America ("U.S. GAAP"). That basis differs from U.S. GAAP principally because employer contributions are recognized when received rather than when earned. Accordingly, receivables from employer contributions and their related effects on earnings have not been recognized in these financial statements. However, investment income is recorded when earned and expenses are recorded when incurred.

*Use of Estimates*

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities. Actual results could differ from these estimates.

*Payment of Benefits and Premiums*

Benefits and premiums are recorded when paid and are reflected as benefits and premiums paid in the accompanying statements of changes in net assets available for benefits.

*Administrative Expenses*

Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

*Tax Status*

The Trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(C)(9) of the Internal Revenue Code ("IRC"), and, accordingly, the Trust's net investment income is exempt from income tax. The Trust has obtained a favorable tax determination letter from the IRC on April 22, 2014, and the Plan sponsor believes that the Trust, as amended since, continues to qualify and to operate in accordance with applicable provisions of the IRC.

*Uncertain Tax Positions*

The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits for any tax periods in process.

*Subsequent Events*

The Plan has evaluated events and transactions that occurred through July 23, 2025, which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements.

**Note 3 - Plan Termination**

Although the Board of Trustees has not expressed its intent to discontinue the Plan, it may do so at any time subject to the provisions of ERISA and the terms of the CBAs. The Agreement and Declaration of Trust, as amended, provides that in the event the Trust is terminated, such termination would follow the applicable sections of ERISA and the IRC, as amended, for the exclusive benefit of the plan participants and beneficiaries under the Trust.

**Note 4 - Risks and Uncertainties**

The Plan maintains cash balances at a bank in the New York metropolitan area. Cash accounts at the banks are insured by the Federal Deposit Insurance Corporation ("FDIC"), subject to certain limits. At times, such cash balances may be in excess of the insured limits. As of December 31, 2024, the Plan had approximately \$358,351 in excess of the FDIC limits. The Plan has not experienced any losses on their accounts.

**Note 5 - Party in Interest Transactions**

The Plan has a number of service providers. Such providers are parties in interest under ERISA. However, all transactions with such providers are exempt party in interest transactions under ERISA.
