Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Automated Financial Systems, Inc. 401(k) Salary Reduction Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Note 1 - Description of Plan

The following description of the Automated Financial Systems, Inc. 401(k) Salary Reduction Plan (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

General

The Plan is a defined contribution pension plan covering all employees of Automated Financial Systems, Inc. (the Company). Full-time employees age 21 or older who have completed one month of service are eligible to participate in the Plan. Part-time employees must complete 1,000 hours of service in order to participate. Additionally, employees hired or rehired on or after January 1, 2007 are automatically enrolled in the Plan, unless they notify the Plan Administrator that they do not wish to participate. Active participants are eligible for employer contributions after six months of credited service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 35% of pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may designate all or a portion of their elective deferrals as after-tax Roth elective deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective June 1, 2021, the Plan features an annual automatic deferral increase of 2% on November 1 each year up to a maximum deferral of 12% of eligible compensation for all participants with a deferral percentage greater than zero. Effective June 12, 2019, eligible participants will be automatically enrolled in the Plan on the plan entry date, as defined in the plan document, unless they elect to opt out. Participants who are automatically enrolled will have 6% of their eligible compensation withheld and remitted to the Plan.

The following groups of eligible participants have different automatic enrollment provisions than noted above.

Participants who received their automatic enrollment notification after August 1, 2016 and prior to June 12, 2019 will be automatically enrolled in the Plan on the plan entry date, as defined in the plan document, unless they opt out. Eligible employees who are automatically enrolled will have 4% of their eligible compensation withheld and remitted to the Plan, with an automatic deferral increase of 2% on November 1 each year up to a maximum deferral of 12% of eligible compensation for all participants with a deferral percentage greater than zero.

Participants hired after January 1, 2007 and who received their automatic enrollment notification prior to August 1, 2016 will be automatically enrolled in the Plan on the plan entry date, as defined in the plan document, unless they opt out. Eligible employees who are automatically enrolled will have 3% of their eligible compensation withheld and remitted to the Plan, with an automatic deferral increase of 1% on November 1 each year up to a maximum deferral of 12% of eligible compensation for all participants with a deferral percentage greater than zero.

Contributions (continued)

The Company's matching contribution is discretionary. For the years ended December 31, 2024 and 2023, the Company's matching contribution equaled 50% of participants' contributions with a maximum match of 3% of compensation. Additional discretionary nonelective employer contributions may also be made in an amount equal to a percentage of the participants' annual compensation up to certain levels, as defined in the Plan. The Company made no additional discretionary contributions for the years ended December 31, 2024 and 2023. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching contributions, as well as allocations of (a) the Company's nonelective contributions and (b) plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Self-Directed Brokerage Accounts

Each participant may elect to remit contributions into a self-directed brokerage account. These participants direct their contributions into investments at their discretion. Each participant's self-directed brokerage account is credited with the participant's contributions, the Company's contributions, earnings, and are charged with administrative expenses.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's matching and discretionary nonelective contribution portion of their accounts, including earnings thereon, is based on the number of years of continuous service. A participant is 100% vested after six years of credited service based on the following vesting schedule:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, unless the loan is used to acquire the participant's principal residence, in which case, the loan may exceed five years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through semi-monthly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant will receive a lump-sum payment if his or her vested account balance is \$5,000 or less. If the account balance is greater than \$5,000, the participant may elect to receive the value of the vested interest in his or her account as a single lump-sum distribution, installments under a systematic withdrawal plan, or partial withdrawal. Effective May 22, 2024, the single lump-sum distribution amount was increased from \$5,000 to \$7,000.

In addition, the Plan allows for hardship distribution if certain criteria are met, and in-service withdrawals for participants, which have attained age 59 ½.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$18,890 and \$4,844, respectively. These accounts may be used to pay administrative expenses or used to reduce future employer contributions. During 2024 and 2023, \$8,044 and \$38,656, respectively, of forfeited nonvested accounts were used to offset the employer contributions.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and fees related to self-directed brokerage accounts are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Note 3 - Information Certified and Provided by Fidelity Management Trust Company

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to, or derived from, information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies are valued at the net asset value (NAV) of shares held by the Plan at year-end.

One of the Plan's investment options includes a self-directed brokerage account, which allows participants to establish a brokerage account and selected various investments consisting of registered investment companies, common stocks, corporate bonds and U.S. government securities, and cash. Common stocks are valued at the closing price reported on the active market on which the individual securities are traded. Corporate Bonds and U.S. government securities are valued using pricing models maximizing the use of observable inputs for similar securities. Cash is valued at cost, which approximates fair value.

The collective trust fund is valued based on the NAV of units of a bank collective trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust, less its liabilities. The collective trust fund is a direct filing entity.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Tax Status

The Company adopted a pre-approved plan document that was sponsored by FMR LLC. The pre-approved document has received an opinion letter from the IRS, dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable provisions of the IRC and; therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. Federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in the Company contribution portion of their account.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8 - Related Party Transactions and Party-In-Interest Transactions

Certain plan investments are shares of registered investment companies managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and; therefore, these transactions qualify as party-in-interest transactions.

The Plan participates in Fidelity's Revenue Credit Program (RCP). Proceeds from the RCP can be used to pay plan expenses. RCP accounts at December 31, 2024 and 2023 were immaterial. These transactions qualify as party-in-interest transactions.

Note 9 - Subsequent Events

Plan management has evaluated subsequent events through July 15, 2025. This date is the date the financial statements were available to be issued. No material events subsequent to December 31, 2024 were noted.
