### Note 1: Description of Plan

The following description of the Certco, Inc. Union Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Investments are participant directed.

#### Eligibility

Eligible employees include all employees of Certco, Inc. (the "Company") over the age of 18, who are covered under a collective bargaining agreement ("Union"). Employees are automatically enrolled to participate in the Plan on the first day of each month subsequent to completing one year of service with 1,000 hours. Participants automatically contribute 6% of compensation upon Plan entry unless a contrary election is made. Automatic deferrals do not increase in following Plan years.

#### Contributions

Each year, participants may contribute up to the maximum allowed by the Internal Revenue Service ("IRS"). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. The Company will make a matching contribution equal to 50% of participants deferrals, up to 6% of the participant's total compensation each Plan year. Participants may also contribute amounts representing distributions from other qualified defined contribution plans ("rollovers").

#### Participant Accounts

Each participant's account is credited with the participant's contribution and the Company's matching contributions, and an allocation of Plan earnings or losses. The participant's account is charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Payment of Benefits

Upon termination of service for any reason, a participant may elect to receive either a lump sum amount equal to the value of participant's vested interest in his or her account, installments, or ad-hoc distributions. In-service withdrawals are permitted from deferral contributions in the event of financial hardship, defined as an immediate and heavy financial need that cannot be satisfied from other financial resources. Hardship withdrawals need to meet certain specific criteria, as defined by the Plan. The Plan also allows for in-service distributions upon attaining age 59 ½. Minimum distributions are required once the participant reaches the age of 70 ½. Benefits are recorded when paid.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants vest according to the following schedule:

1	33 %
2	67 %
3	100 %

#### Forfeitures

Plan forfeitures arise as a result of participants who terminate service before becoming 100% vested in the Company's contributions. These accounts will be used to reduce future Company contributions or to pay administrative expenses of the Plan in accordance with the Plan document.

As of December 31, 2024 and 2023, there were no unallocated forfeitures. Forfeitures of \$3,846 were used to reduce the Company contributions during the year ended December 31, 2024.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, trustees, and insurance company. See Note 3 for discussion of fair value measurements.

#### **Investment Valuation and Income Recognition** (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fully benefit-responsive investment contracts are stated at contract value. Contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Expenses directly attributable to a participant's transactions are deducted from the participant's account. Investment related expenses are allocated proportionately to plan participants based on their respective account balance and are included in total investment income.

#### **Subsequent Events**

Subsequent events have been evaluated through July 28, 2025, the date these financial statements were available to be issued.

### **Note 3: Fair Value Measurements**

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Mutual funds held in pooled separate accounts:* Fair value of mutual funds held in pooled separate accounts is based on quoted net asset values of underlying investments held by the pooled separate accounts adjusted by an asset charge. The underlying mutual funds held in the pooled separate accounts are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price.

*Common collective trust:* Valued at the NAV of units of an investment trust fund. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying assets and liabilities of the fund. Fund unit sales and repurchases occur on a daily basis at the NAV per share determined at the close of each business day. The Plan has no obligation to buy any additional units.

### Note 4: Guaranteed Interest Fund

The Plan holds a traditional investment contract with an insurance company that meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. The contract value of the investment was \$205,708 and \$114,192 as of December 31, 2024 and 2023, respectively.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. The crediting rate is reviewed on a quarterly basis for resetting, the average yield earned during the years ended December 31, 2024 and 2023, was 1.66% and 1.48%, respectively.

The contract cannot be terminated before the scheduled maturity date. The Plan's ability to receive amounts due in accordance with fully benefit responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

The plan administrator believes that any events which would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

### **Note 5: Information Prepared and Certified by the Trustee and Custodian**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information in the accompanying financial statements and supplemental schedule, including investments and fully benefit-responsive investment contracts held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC. (collectively "Empower"), the Trustee and Custodian of the Plan.

### **Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

### **Note 7: Tax Status**

The Company adopted a nonstandard prototype Profit Sharing Plan with an IRS notification letter dated November 14, 2022, stating that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code ("IRC") to maintain tax-exempt status. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance the applicable sections of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 9: Party-In-Interest Transactions**

Certain Plan investments are managed by Empower or an affiliate, who is the Custodian, therefore, these transactions qualify as party-in-interest transactions. These transactions are not considered prohibited transactions under ERISA. Fees paid by the Plan to the Trustees for investment management and other services amounted to \$57,629 for the year ended December 31, 2024.
