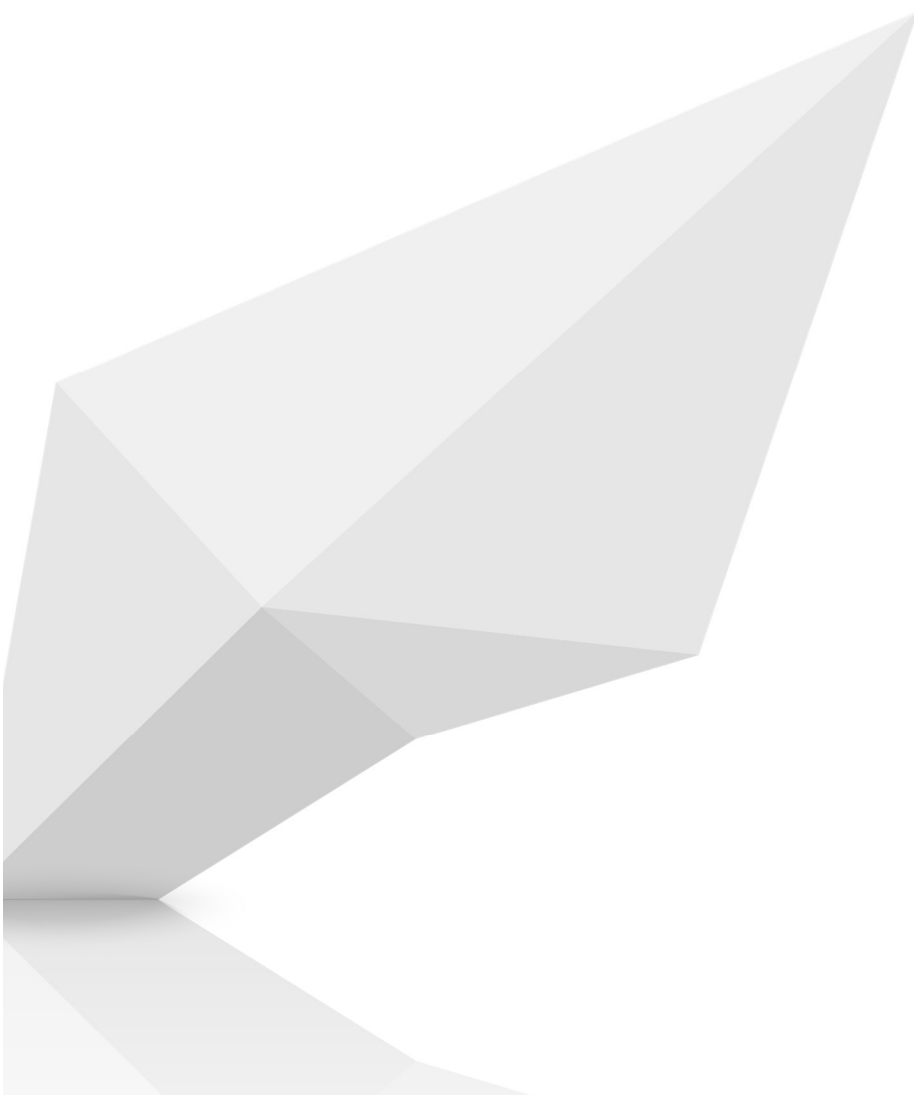

We have performed audits of the financial statements of First Western 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of First Western 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

Note 1: Plan Description

The following description of First Western 401(k) Plan (the "Plan"), provides only general information. Participants should refer to the plan agreement or Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of First Western Financial, Inc. (the "Company"), except for bargaining employees, leased employees, nonresident aliens, and junior associates, as defined. Employees become eligible to participate in the Plan on the first day of the month following one month of service and obtaining age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

First Western Financial, Inc. is the plan administrator. Principal Trust Company (Principal) is the asset custodian, the trustee of the Plan, and the record keeper pursuant to the terms of service provider agreements.

Contributions

Each year, participants may contribute pretax compensation or Roth contributions up to the annual maximum allowed by the Internal Revenue Service ("IRS"). Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation with an automatic 1% increase on each subsequent January 1, up to a maximum deferral of 10%.

The Company may make a discretionary matching contribution to the Plan, which is allocated as a percentage of the participant's elected deferral contribution, to eligible participants with at least 1,000 hours of service during the plan year and who are employed on the last day of the plan year; however, participants who retire, die, or are disabled during the plan year will also receive the matching contribution. During 2024, the Company matched 50% of participant deferrals up to a maximum of 6% of participant compensation. The Company's 2024 discretionary matching contributions of \$848,550 were contributed to the Plan on February 28, 2025.

The Company may also make a discretionary profit sharing contribution, which is allocated to eligible participants with at least 1,000 hours of service during the plan year and who are employed on the last day of the plan year; however, participants who retire, die, or are disabled during the plan year will also receive the discretionary profit sharing contributions. The discretionary profit sharing contribution is allocated to participants based on an integrated formula as allowed by the Internal Revenue Code ("IRC"). No discretionary profit sharing contributions were made for the plan year ended December 31, 2024.

Note 1: Plan Description (Continued)

Participant Accounts

Each participant's account is credited with the participant's deferral (pre-tax and Roth) contributions, catch-up contributions, rollover contributions, Company discretionary matching contributions, and allocations of the Company's discretionary profit sharing contributions, and allocations of net plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds, pooled separate accounts, and a common collective trust fund as investment options for participants. Participants may change their investment options at any time.

Vesting

Participants are 100 percent vested in their deferral and rollover contributions and the allocated earnings (losses) thereon. Vesting in the Company's contribution portion of their account, plus actual earnings (losses) thereon, is based on years of continuous service. Participants vest at a rate of 25% per year beginning with the first year of service. Participants become fully vested after four years of service or upon the participant's death, disability, or reaching normal retirement age.

Notes Receivable From Participants

A participant may borrow a minimum of \$1,000, up to 50 percent of his or her vested balance, not to exceed \$50,000. The notes are secured by the balance in the participant's account and bear interest based on the rates available for similar borrowings from commercial institutions. Interest rates are fixed for the term of the note. The interest rates on outstanding notes at December 31, 2024, ranged from 5.25% to 10.50%. The notes are repaid ratably through payroll deductions over a period of five years or less. Two notes may be outstanding at a time, and a participant may originate two new borrowings in a twelve-month period.

Payment of Benefits

Upon termination of service for any reason, a participant (or beneficiary) may elect to receive either a lump-sum amount equal to the vested value of the participant's account or may rollover the amount to another qualified retirement plan. Installment payments are also permitted by the Plan. Distributions of account balances greater than \$1,000, but less than \$5,000, are paid as a direct rollover to an Individual Retirement Account ("IRA") in the name of the plan participant. If the account balance is less than \$1,000, it will be paid in a lump-sum directly to the participant. These mandatory distributions apply only to participants who have separated from service and do not actively elect a distribution of their account or transfer to an eligible retirement plan. Hardship distributions, in-service distributions at age 59 ½, and in-service distributions from all or part of the participant's vested account balance resulting from rollover contributions are also allowed by the Plan if certain criteria are met.

Forfeited Accounts

Forfeitures from participants may be used to pay administrative expenses or to offset Company matching contributions. At December 31, 2024 and 2023, the balance of the forfeited accounts was \$41,950 and \$63,754, respectively. During the year ended December 31, 2024, \$17,529 of forfeitures were used to reduce administrative expenses and \$63,754 were used to offset Company matching contributions. New forfeited accounts and earnings thereon were \$59,479 during the year ended December 31, 2024.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends and capital gains are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net change in the fair value of investments represents capital gain distributions, and realized and unrealized gains and losses on the investments, net of any fees charged within the mutual funds.

Contributions

Participant contributions are recognized in the plan year during which the Company makes payroll deductions from the participant's compensation. Company matching contributions are recorded on the accrual basis.

Payment of Benefits

Benefits are recorded when paid.

Note 2: Summary of Significant Accounting Policies (Continued)

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees (primarily loan and distribution fees) are charged directly to the participant's account and are included in administrative fees. Certain investment related expenses may also be charged within the mutual funds and are included in net change in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through July 25, 2025, the date the financial statements were available to be issued and no significant subsequent events have been identified.

Note 3: Information Prepared and Certified by the Trustee (Unaudited)

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net change in fair value of investments, interest and dividends for the year ended December 31, 2024 was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal Trust Company (Principal), the Custodian of the Plan.

Note 4: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets in active markets; Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Note 4: Fair Value Measurements (Continued)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: Each pooled separate account invests in assets solely in the shares or units of an underlying mutual fund, and the investment objective of each sub-account corresponds to the investment objective of the underlying fund. The value of each pooled separate account is determined using various inputs, such as the NAV of the shares of the underlying mutual fund held at year-end, adjusted for administrative expenses and other charges.

Common Collective Trust Fund: Valued at the NAV of units of the common collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 month's notification in order to ensure that securities' liquidations will be carried out in an orderly business matter. There were no unfunded commitments.

Note 5: Related-Party Transactions and Party-in-Interest Transactions

The Plan invests in shares of mutual funds, collective common trust funds and pooled separate accounts which are managed by Principal. Principal is the custodian, trustee and recordkeeper of the Plan. Transactions with Principal qualify as party-in-interest transactions. The Plan paid Principal \$56,228 for certain client requested services during the year ended December 31, 2024. Principal also receives certain indirect fees from various mutual fund companies. Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

Note 7: Tax Status

The Company adopted a nonstandard prototype plan document with an IRS notification letter which states the prototype plan document is in compliance with the applicable sections of the IRC. The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risks. Additionally, the value, liquidity, and related income of the investment securities are sensitive to changes in economic conditions, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates. Due to the level of risk associated with certain investment securities and the level of uncertainty related to the changes in the value of investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
