The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Indiana Industrial Services, LLC and Affiliates 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all non-union employees of Indiana Industrial Services, LLC and its Affiliates (the "Company" or "Employer") who are age twenty-one or older and have one year of service with 1,000 hours. Employee's may enter the Plan the first day of the 1st and 7th month of the Plan Year once eligibility is met. The Affiliates include Midwest Finishing Systems, Inc.; Clover Associates, Inc. d/b/a Clover Machinery Movers; J.B Cunningham, Inc.; and Lincoln Chemical Corporation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions: Participants may voluntarily elect to defer and contribute to the Plan an amount not to exceed the statutory limit set forth by the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Employees may rollover funds from another qualified plan. The Company may also make a discretionary matching contribution and a discretionary profit-sharing contribution to the Plan. Deferrals can be made as either pre-tax or Roth after-tax. For the year ended December 31, 2024, the Company matched 25% of employee contributions for all companies included in the Plan. Participants direct their contributions into various investment options offered by the Plan.

Participant Accounts: Each participant's account is credited with the participant's contribution, the Company's matching contribution, Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the vested benefit from the participant's account.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are immediately vested in their voluntary contributions and earnings on such contributions. A participant partially vests 20% each year of service in Company contributions beginning after two years of service and is 100% vested after six years of credited service.

Payment of Benefits: Upon termination of service, a participant may elect to receive a lump-sum or installment payment amount equal to the value of the participant's vested interest in their account. Withdrawals may also be made when a participant demonstrates financial hardship or reach the age of 59-1/2. There were no benefits payable to participants who were eligible to receive a distribution from the Plan, but who have not yet been paid as of December 31, 2024.

Investment Options: Each participant may direct their contributions in any of the investment options available under the Plan.

Plan Termination: Although it has not expressed intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become 100% vested in employer contributions.

Administrative and Investment Management Expense: The Plan's recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan or included in administrative expenses. All other expenses of the Plan are paid by the Company.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through July 22, 2025, the date the financial statements were available to be issued.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The principles and policies which significantly affect the determination of net assets available for benefits and results of operations are summarized below.

Basis of Accounting: The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principle or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments: Benefit payments are recorded when paid.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan provides for various investment options. The underlying investment securities are exposed to various risks, such as interest rate, market, liquidity, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by 1st Source Bank (the trustee of the Plan).

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

(Continued)

NOTE 4 - FAIR VALUE MEASUREMENTS (Continued)

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value includes inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the trustee and the Plan administrator to estimate the fair values of investments apply to investments held directly by the Plan:

Mutual Funds – The fair values of mutual fund investments are determined using the market approach by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Stable Return Fund – The fair value of participation units in the stable return collective trust are based on the net asset value per unit as reported by the fund manager. The fund invests in guaranteed investment contracts issued by insurance companies; investment contracts issued by banks; structures or synthetic investment contracts issued by banks, insurance companies; as well as the securities supporting the underlying assets, with the objective of providing a high level of return that is consistent with also providing stability of investment return, preservation of capital, and liquidity to pay plan benefits for withdrawals for certain participant initiated transactions. The fund provides for daily redemptions by the Plan at reported net asset value per share, with no advance notification requirements or redemption restrictions. The stable return fund previously held by the Plan was fully liquidated in May of 2024. Any accounts invested in this fund were automatically transferred into the Deposit Management Fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - INCOME TAX STATUS

The Internal Revenue Service issued an opinion letter, most recently dated June 30, 2020, that stated the prototype plan was designed in accordance with applicable requirements of the IRC. Although the Plan has since been amended from the original prototype document, the Plan administrator believes that the Plan is currently designed and operating in compliance with the applicable requirements of the IRC.

NOTE 5 - INCOME TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021 and has adopted interim amendments under the pre-approved plan cycle procedures.

NOTE 6 - PARTIES-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL's Rules and Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Investment management fees are paid by the Plan to the Plan trustee, which are party-in-interest. These expenses are reflected in the financial statements as a reduction of the return on the Plan's investments.
