Opinion

We have audited the financial statements of Landoll Corporation Employee Health Care Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), which comprise the statements of net assets available for benefits (modified cash basis) as of November 30, 2024 and 2023, the related statements of changes in net assets available for benefits (modified cash basis) for the years then ended, and the related notes to the financial statements.

Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTES TO THE FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following description of the Landoll Corporation Employee Health Care Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General The Plan, established as of December 1, 1994, provides health and other benefits to eligible employees of Landoll Corporation (the Company) and covered dependents. An eligible employee includes any person who is actively at work for the Company and is regularly scheduled to work at least 30 hours per week. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Benefits The Plan provides hospitalization, medical, short and long-term disability, dental benefits, and life insurance to eligible participants and their covered dependents. A participant may also contribute specified amounts determined by the Company to extend coverage to eligible dependents. Participants may also elect additional life insurance for an additional cost to the employee. Terminated employees, or their qualified beneficiaries, may elect to continue hospitalization, medical, and dental coverage under the *Consolidated Omnibus Budget Reconciliation Act of 1965* (COBRA) by paying required timely premiums.

Contributions In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

Payment of Benefits The third-party claims processor processes medical, dental, and vision claims for benefits on behalf of the trustees, and disburses claim payments that are determined to be due to the person or assignee entitled thereto in accordance with provisions of the Plan. The Plan pays the third-party claims processor an administrative fee for these services based on the number of enrolled employees. Life insurance and disability benefits are paid completely by Mutual of Omaha Insurance Company.

Trustees Three trustees are the fiduciaries of the Plan, with full authority to control and manage the operation and administration of the Plan.

Plan Termination The Company may amend or terminate the Plan at any time subject to the provisions of the Plan and ERISA. No amendment or termination may discontinue or curtail the benefits that have accrued to any participant or beneficiary prior to the adoption of such amendment or termination. Upon termination of the Plan, all funds of the Plan shall be used to pay all benefits accrued under the Plan and to pay additional benefits for participants as determined by the Plan administrator. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

Stop-Loss Coverage The Plan has entered into a stop-loss insurance agreement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount).

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting The accounting records of the Plan are maintained on a modified cash basis of accounting. Consequently, certain revenues are recognized when received rather than when earned and the obligation is incurred, although certain receivables (Company funding and related employee payroll deductions) are recorded when earned. Accordingly, the accompanying financial statements are not intended to present the financial position and results of operations in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates The preparation of financial statements in conformity with the modified cash basis of accounting, requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits Premiums paid by either the Company or the trust are recorded as premiums paid in the accompanying statements of changes in net assets available for benefits. Claims payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have not been reimbursed by the Plan are recorded as payable to claim administrators in the accompanying statements of net assets available for benefits.

Expenses The Plan pays administrative expenses that consist primarily of fees paid to third-party claims administrators. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan and are excluded from these financial statements.

Stop-Loss Coverage Premiums for stop-loss insurance are included in premiums paid in the accompanying statements of changes in net assets available for benefits. For the years ended November 30, 2024 and 2023, no stop-loss refunds have been noted with benefits paid to participants in the accompanying statements of changes in net assets available for benefits.

Rebates Rebates are recorded as received by the Plan. They are presented with premium expenses in the accompanying statements of changes in net assets available for benefits.

Evaluation of Subsequent Events The Plan has evaluated subsequent events through July 25, 2025, the date the financial statements were available to be issued.

3. BENEFIT OBLIGATIONS

Plan benefit obligations for health claims incurred but not reported are estimated by the Plan's third-party claims processor at the present value, based on historic claims experience and actual claims reported subsequent to the Plan's year-end.

The Plan's benefit obligations consist of amounts currently payable for health claims incurred but not reported for both active employees and separated employees who are participating through COBRA. The obligations will be funded by future participants, Company contributions, and stop-loss reimbursements.

5. TAX STATUS

The trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service dated August 17, 1995, stating that the trust was tax exempt under the provisions of Section 501(c)(9) of the *Internal Revenue Code* (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 and 2023 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is operating in compliance with the applicable requirements of the IRC. Therefore, they believe that the related trust is tax exempt.

6. RISKS AND UNCERTAINTIES

The benefit obligations are reported based on certain assumptions pertaining to interest rates, health care inflation rates, claims experience, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

7. PLAN AMENDMENTS

Effective March 1, 2024, the Plan was amended to add Dexcom to the current Elixir benefits.
