The American Rescue Plan (ARP) Act of 2021 was signed into law on March 11, 2021 and includes funding relief effective for the 2022 plan year in the form of an extension of the shortfall amortization period to 15 years with the option for plan sponsors to elect for early application. In addition, effective for plan years 2020 and beyond additional funding rate relief was provided with plan sponsors having the option to elect to defer application of the interest rate relief until 2021 or 2022.
