## Report of Independent Auditors

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the College of American Pathologists Employees' Retirement and 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes (collectively referred to as the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

## Notes to Financial Statements

December 31, 2024

### 1. Description of Plan

The following description of the College of American Pathologists Employees' Retirement and 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all full-time and part-time employees of the College of American Pathologists (the College) who are age 18 or older. Temporary employees shall become eligible to participate in the Plan after reaching age 18 and completing 1,000 hours of service during an eligibility computation period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### Contributions

Participants may contribute up to 50% of pretax annual compensation, as defined in the Plan, subject to maximum amounts established by the Internal Revenue Code (the IRC) immediately upon hire. The Plan has a Roth feature whereby participants may elect to make after-tax contributions. If a participant is automatically enrolled, the participant's deferral is set at 5% of eligible compensation until changed by the participant. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The College may make a discretionary contribution equal to a percentage, approved by the Board of Governors, of the eligible compensation paid to all eligible participants during the current year. Employees will each share in such contribution if they are a participant with one year of service, worked a minimum of 501 hours during the current year, and were employed by the College on the last day of the year. The contribution is allocated to participants in the proportion that their individual compensation bears to the total compensation paid to all participants in the Plan. The College made a discretionary contribution equal to 5% of eligible compensation for the period from January 1, 2024 to December 31, 2024. The College may make a discretionary per-pay-period employer matching contribution. The College made a per-pay-period employer matching contribution in the amount of 100% on the first 5% deferred for the year ended December 31, 2024.

**1. Description of Plan (continued)**

**Participant Accounts**

Each participant's account is credited with the participant's contribution, the College's contribution, and an allocation of the Plan's earnings (losses). Allocation of the Plan's earnings (losses) is based on participants' investment elections or account balances, as defined.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Participant Loans**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to ten years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the College's contribution portion of their accounts for all contributions plus actual earnings thereon is based on years of continuous service. A participant is 100% vested in the College's contributions made after December 31, 2006, after six years of credited service. A participant is 100% vested in the College's contributions made prior to January 1, 2007, after seven years of credited service.

**Forfeitures**

Forfeited balances of terminated participants' non-vested accounts are used to reduce future College contributions or to pay the Plan's expenses. The balance of forfeited non-vested accounts was \$105,861 and \$224,469 as of December 31, 2024 and 2023, respectively. Forfeitures of approximately \$95,000 were used to offset contributions for the plan year ended December 31, 2024.

**1. Description of Plan (continued)**

**Payment of Benefits**

Upon death, disability, or retirement, participants may elect to receive either a lump-sum amount or an annuity equal to the value of their account. Upon termination of service for other reasons, participants may elect to receive a lump-sum distribution of the vested value of their account or, remain invested in the Plan, if the account balance exceeds \$1,000 prior to January 1, 2024 or exceeds \$5,000 on or after January 1, 2024.

**Plan Termination**

Although it has not expressed any intent to do so, the College has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in their accounts.

**Investment Options**

All investment programs are participant directed. Participants may direct the investment of their elective deferrals and College contributions into any of the investment options offered by the Plan.

**2. Significant Accounting Policies**

**Basis of Accounting**

The financial statements have been prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**2. Significant Accounting Policies (continued)**

**Payment of Benefits**

Benefits are recorded when paid.

**Notes Receivable From Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

**Administrative Expenses**

Expenses incurred in administering the Plan are paid from plan assets to the extent such expenses are not paid by the College.

**Use of Estimates**

The preparation of financial statements in conformity with the accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

**3. Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held, notes receivable from participants at December 31, 2024 and 2023, and net appreciation (depreciation) in the fair value of investments, interest and dividend income, interest income on notes receivable from participants, and other income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company (the trustee).

**4. Fair Value Measurements**

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumptions about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level of input that is significant to the fair value measurement in its entirety.

**4. Fair Value Measurements (continued)**

Following is a description of the valuation techniques and inputs used for each general type of asset measured at fair value by the Plan:

*Mutual funds:* Valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year-end.

*Common/collective trust fund:* Valued at the NAV provided by the administrator of the fund.

**5. Tax Status**

The underlying volume submitter plan has received an advisory letter from the Internal Revenue Service (the IRS), dated June 30, 2020, stating that the form of the plan is qualified under Section 401 of the IRC and, therefore, the related trust is tax-exempt. The plan administrator has determined that it is eligible to, and has chosen to, rely on the current IRS volume submitter advisory letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

**5. Tax Status (continued)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

**7. Related-Party and Party-in-Interest Transactions**

The Plan holds units of a common/collective trust fund and shares of mutual funds managed by the trustee of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

**8. Subsequent Events**

Subsequent events have been evaluated through July 29, 2025, which is the date these financial statements were available to be issued.

## Report of Independent Auditors

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the College of American Pathologists Employees' Retirement and 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes (collectively referred to as the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

## Notes to Financial Statements

December 31, 2024

### **1. Description of Plan**

The following description of the College of American Pathologists Employees' Retirement and 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all full-time and part-time employees of the College of American Pathologists (the College) who are age 18 or older. Temporary employees shall become eligible to participate in the Plan after reaching age 18 and completing 1,000 hours of service during an eligibility computation period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### **Contributions**

Participants may contribute up to 50% of pretax annual compensation, as defined in the Plan, subject to maximum amounts established by the Internal Revenue Code (the IRC) immediately upon hire. The Plan has a Roth feature whereby participants may elect to make after-tax contributions. If a participant is automatically enrolled, the participant's deferral is set at 5% of eligible compensation until changed by the participant. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The College may make a discretionary contribution equal to a percentage, approved by the Board of Governors, of the eligible compensation paid to all eligible participants during the current year. Employees will each share in such contribution if they are a participant with one year of service, worked a minimum of 501 hours during the current year, and were employed by the College on the last day of the year. The contribution is allocated to participants in the proportion that their individual compensation bears to the total compensation paid to all participants in the Plan. The College made a discretionary contribution equal to 5% of eligible compensation for the period from January 1, 2024 to December 31, 2024. The College may make a discretionary per-pay-period employer matching contribution. The College made a per-pay-period employer matching contribution in the amount of 100% on the first 5% deferred for the year ended December 31, 2024.

**1. Description of Plan (continued)**

**Participant Accounts**

Each participant's account is credited with the participant's contribution, the College's contribution, and an allocation of the Plan's earnings (losses). Allocation of the Plan's earnings (losses) is based on participants' investment elections or account balances, as defined.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Participant Loans**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to ten years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the College's contribution portion of their accounts for all contributions plus actual earnings thereon is based on years of continuous service. A participant is 100% vested in the College's contributions made after December 31, 2006, after six years of credited service. A participant is 100% vested in the College's contributions made prior to January 1, 2007, after seven years of credited service.

**Forfeitures**

Forfeited balances of terminated participants' non-vested accounts are used to reduce future College contributions or to pay the Plan's expenses. The balance of forfeited non-vested accounts was \$105,861 and \$224,469 as of December 31, 2024 and 2023, respectively. Forfeitures of approximately \$95,000 were used to offset contributions for the plan year ended December 31, 2024.

**1. Description of Plan (continued)**

**Payment of Benefits**

Upon death, disability, or retirement, participants may elect to receive either a lump-sum amount or an annuity equal to the value of their account. Upon termination of service for other reasons, participants may elect to receive a lump-sum distribution of the vested value of their account or, remain invested in the Plan, if the account balance exceeds \$1,000 prior to January 1, 2024 or exceeds \$5,000 on or after January 1, 2024.

**Plan Termination**

Although it has not expressed any intent to do so, the College has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in their accounts.

**Investment Options**

All investment programs are participant directed. Participants may direct the investment of their elective deferrals and College contributions into any of the investment options offered by the Plan.

**2. Significant Accounting Policies**

**Basis of Accounting**

The financial statements have been prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**2. Significant Accounting Policies (continued)**

**Payment of Benefits**

Benefits are recorded when paid.

**Notes Receivable From Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

**Administrative Expenses**

Expenses incurred in administering the Plan are paid from plan assets to the extent such expenses are not paid by the College.

**Use of Estimates**

The preparation of financial statements in conformity with the accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

**3. Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held, notes receivable from participants at December 31, 2024 and 2023, and net appreciation (depreciation) in the fair value of investments, interest and dividend income, interest income on notes receivable from participants, and other income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company (the trustee).

**4. Fair Value Measurements**

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumptions about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level of input that is significant to the fair value measurement in its entirety.

**4. Fair Value Measurements (continued)**

Following is a description of the valuation techniques and inputs used for each general type of asset measured at fair value by the Plan:

*Mutual funds:* Valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year-end.

*Common/collective trust fund:* Valued at the NAV provided by the administrator of the fund.

**5. Tax Status**

The underlying volume submitter plan has received an advisory letter from the Internal Revenue Service (the IRS), dated June 30, 2020, stating that the form of the plan is qualified under Section 401 of the IRC and, therefore, the related trust is tax-exempt. The plan administrator has determined that it is eligible to, and has chosen to, rely on the current IRS volume submitter advisory letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

**5. Tax Status (continued)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

**7. Related-Party and Party-in-Interest Transactions**

The Plan holds units of a common/collective trust fund and shares of mutual funds managed by the trustee of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

**8. Subsequent Events**

Subsequent events have been evaluated through July 29, 2025, which is the date these financial statements were available to be issued.
