### SCOPE AND NATURE OF THE ERISA SECTION 103(a)(3)(C) AUDIT

We have performed an audit of the financial statements of IFS Savings and Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets in liquidation available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### OPINION

In our opinion, based on our audits and on procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## BASIS FOR OPINION

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## EMPHASIS OF MATTER - PLAN TERMINATION AND LIQUIDATION BASIS OF ACCOUNTING

As further discussed in Note 9 to the financial statements, the Board of Directors of IFS Savings and Retirement Plan approved a plan of liquidation in December 2024, and management determined liquidation is imminent. As a result, IFS Savings and Retirement Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

## RESPONSIBILITIES OF MANAGEMENT FOR THE FINANCIAL STATEMENTS

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## AUDITOR'S RESPONSIBILITIES FOR THE AUDIT OF THE FINANCIAL STATEMENTS

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

DECEMBER 31, 2024

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of IFS Savings and Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

Prior to liquidation, the Plan was a participated directed defined contribution plan, covering substantially all eligible employees of Independent Furniture Supply Company, Inc. (the "Employer"). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Directors was responsible for oversight of the Plan. The Plan was adopted effective January 1, 1992, and was amended June 1, 2015, in order to comply with the Pension Protection Act of 2006 and other legislative and regulatory changes. The Plan was restated January 1, 2022, under the Sentry Life Insurance Company Defined Contribution Prototype Plan and Trust.

Eligibility

Prior to liquidation, all employees, other than union employees and nonresident aliens, were eligible to participate in the Plan beginning the January 1, April 1, July 1 or October 1 upon reaching age 21 and completing one year of service, as defined in the plan document.

Contributions

Prior to liquidation, participants elected to defer up to 100% of their compensation, as defined in the Plan document. Participants could contribute amounts representing distributions from other qualified plans. Participants could change their salary deferral percentage on a daily basis. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions.

The Employer made matching contributions at its discretion. During 2024 and 2023, the Employer matched 100% of employee contributions up to \$650. The money was deposited into the Plan annually.

Employer matching contributions could be discontinued in accordance with various provisions of the Plan.

Contributions were subject to certain limitations in accordance with applicable regulatory requirements.

Payment of benefits

Prior to liquidation, benefit distributions equal to a participant's vested account balance were payable to the participant or their beneficiaries upon normal retirement (age 65), death, disability or termination of employment. The method of distribution was determined by the Plan Administrator in accordance with the provisions of the Plan.

In-service withdrawals

Prior to liquidation, in-service withdrawals were permitted by participants who had reached the age of 59 and 1/2.

Participant accounts

Prior to liquidation, each participant's account was credited with the participant's contributions, allocations of Employer contributions and plan earnings, and reduced by an allocation of administrative expenses, any distributions and plan losses. Allocations were based on participant earnings, account balances or specific participant transactions, as defined by the plan document. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Vesting

Prior to liquidation, participants were immediately vested in their voluntary contributions and employer matching contributions plus earnings thereon. Vesting in the remainder of their accounts was based on years of continuous service. A participant was 100% vested after three years of credited service.

Forfeitures

Prior to liquidation, forfeitures resulting from termination of employment under circumstances which did not entitle the participant to be fully vested in his Employer contributions were available to be used to pay Plan expenses.

Investment options

Prior to liquidation, participants directed the investment of their contributions into various investment options offered by the Plan.

Notes receivable from participants

Prior to liquidation, participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the vested balance in the participant's account and bore interest at rates that range from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by the Plan Administrator. Loan terms were for a maximum of 5 years, or longer if used for the purchase of a primary residence. Principal and interest were paid ratably through payroll deductions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of presentation

Due to the decision to terminate the Plan, management determined that liquidation of the Plan was imminent and the financials statements for 2024 have been prepared using the liquidation basis of accounting. The financial statements of the Plan were prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

DECEMBER 31, 2024

Use of estimates

The preparation of financial statements in conformity with GAAP requires the Plan to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Prior to liquidation, investments were stated at fair value, except for fully benefit-responsive investment contracts, which were reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determined the valuation policies utilizing information provided by the investment advisers, Custodian and insurance company. See Note 4 for discussion of fair value measurements.

Contract value is the relevant measure of that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the liquidation basis. Dividends were recorded on the ex-dividend date. Net appreciation in fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Prior to liquidation, notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the liquidation basis. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses as incurred.

No allowance for credit losses had been recorded as of December 31, 2024 and 2023. If a participant ceased to make loan repayments and the Plan Administrator deemed the participant loan to be a distribution, the participant loan balance was reduced and a benefit payment was recorded.

Payment of benefits

Benefit payments were recognized in the year paid.

Expenses

Substantially all expenses of maintaining the Plan were paid by the Employer. Expenses paid by the Employer were excluded from these financial statements. Investment-related expenses were included in net appreciation in fair value of investments.

Except for the fair value of the investment contract, certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified by Sentry Life Insurance Company, the Custodian of the Plan. The contract value of the investment contract was certified by the Custodian.

NOTE 4 - FAIR VALUE

The Plan classified its investments based on a hierarchy consisting of: Level 1 (valued using unadjusted quoted prices from active markets for identical assets), Level 2 (not traded on an active market, but for which observable market inputs are readily available) and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets and liabilities measured at fair value:

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The methods described above produced a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believed the valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

NOTE 5 - INVESTMENT AT CONTRACT VALUE

The Plan held investment contracts that met the fully benefit-responsive investment contract criteria and, therefore, were reported at contract value. The investment contract consisted of a traditional investment contract with balances of \$2,474,165 and \$2,648,250 as of December 31, 2024 and 2023, respectively.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investments contracts was dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Such events could include the following: (1) the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code, (2) permanent termination of the contract, (3) the Plan's termination or merger, (4) changes to the Plan's prohibition on competing investment options or (5) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events occurred that limited the ability of the Plan to transact at contract value with the contract issuer and that limited the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Such events would include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligations under the contract, (3) a material misrepresentation or (4) a material amendment to the agreements without the consent of the issuer.

NOTE 6 - INCOME TAX STATUS

The Plan adopted a prototype plan (Prototype). The Prototype received its latest opinion letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated the Prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has not applied for a separate determination letter.

The Prototype has been amended and restated since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe the Plan and Prototype were designed and have been operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes have been provided in the financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax asset or liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invested in investment securities which were exposed to various risks, such as interest rate, credit and overall market risks. Due to the level of risk associated with certain investment securities, it was reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

At December 31, 2024 and 2023, the Plan had a concentration of investments in one fund, which represented approximately 52% and 59%, respectively, of total investments.

NOTE 8 - PARTY-IN-INTEREST AND RELATED-PARTY TRANSACTIONS

Parties-in-interest are defined under United States Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. Plan investments are held by the Custodian, and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, rather than a direct payment.

These party-in-interest transactions are exempt from the prohibited transactions provisions of ERISA and the IRC.
