### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Winner Regional Healthcare Center Tax Deferred Annuity Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

## **Note 1 - Description of Plan**

The following brief description of the Winner Regional Healthcare Center Tax Deferred Annuity Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan is an annuity contract plan under Internal Revenue Code (IRC) Section 403(b) covering qualified employees of the Winner Regional Healthcare Center (the Center). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Committee determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

### **Eligibility**

Employees are eligible to participate in elective deferrals immediately upon hire. Employees, excluding pro re nata employees, are eligible for employer matching contributions when they complete one year of service and have attained age 21. One year of service for purposes of eligibility is a Plan year during which the employee has 1,000 or more hours of service.

Effective February 15, 2024, employees, excluding pro re nata employees, are eligible for employer matching contributions when they complete one month of service and have attained age 21.

### **Entry Date**

Employees may enter the Plan on the first day of the month immediately coinciding with or following the date they meet the eligibility requirements.

### **Contributions**

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan. Contributions are subject to certain IRC limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions and qualified organization catch-up contributions. The Plan allows participants to designate contributions as Roth contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover).

Employer matching contributions may be made at the discretion of the Center. From January 1, 2024, through February 15, 2024, the Center contributed a match of 100% of the first 3% of eligible compensation, and thereafter, until December 31, 2024, contributed a match of 100% of the first 4% of eligible compensation. Additional amounts may be contributed at the discretion of the Center's Board of Directors. No such additional discretionary contributions were made for the year ended December 31, 2024.

## Participant Accounts

Each participant's account is credited with the participant's contribution, as well as an allocation of the Center's matching contributions and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on the participant's compensation, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Investment Options

Upon enrollment to the Plan, a participant may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

## Vesting

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Center's contribution portion of their accounts from January 1, 2024, through February 14, 2024, is based on years of credited services as set forth in the following table:

## Forfeitures

At December 31, 2024 and 2023, there were no forfeited non-vested account balances. These accounts may be used to reduce future employer contributions. During the year ended December 31, 2024, employer contributions were reduced by \$8,391 from forfeited non-vested accounts.

### **Payment of Benefits**

Participants may elect to receive either a lump-sum amount equal to the value of their vested interest, annual installments, or any annuity option available under the contract as defined in the Plan document upon retirement, termination of service, death, or disability. A terminated participant with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a vested balance between \$1,000 and \$7,000 can still be automatically paid out if their balance is rolled into a qualified Individual Retirement Account (IRA). If the participant's vested account is over \$7,000, the participant may elect to receive a lump-sum distribution, any annuity option available under the group annuity contract, or monthly installments over a fixed reasonable period of time not exceeding the life expectancy of the participant or the beneficiary, or leave the balance in the Plan. Distributions may be made at the participant's election prior to termination upon attainment of age 59½, disability, or hardship as defined in the Plan document.

### **Plan Termination**

Although it has not expressed any intent to do so, the Center has the right under the Plan to discontinue its contributions any time and terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

## **Note 2 - Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings (losses) reported in the statement of changes in net assets available for benefits may differ from the classification of earnings (losses) on Form 5500 due to different reporting requirements on Form 5500.

### **Contributions**

Participant contributions and the related Center matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

### **Payments of Benefits**

Benefit payments to participants are recorded upon distribution.

### **Expenses**

The Plan's expenses are paid by either the Plan or the Center, as provided by the Plan document. Expenses that are paid directly by the Center are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net asset available for benefits. In addition, certain investment-related expenses are included in net appreciation (depreciation) of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

### **Note 3 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts – Valued at fair value based on the net asset value (NAV) of units as determined by the insurance company. The NAV is based on the observable market prices of the underlying assets within the account less liabilities. The NAV for the underlying assets of the account is a readily determinable measure of their fair value and is the basis for current transactions.

## Note 4 - Certified Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest, and dividends, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by American United Life Insurance Company (the custodian of the Plan).

**Note 5 - Tax Status**

The Plan uses a pre-approved plan document sponsored by OneAmerica Financial Partners, Inc., which received an advisory letter from the Internal Revenue Service (IRS), dated November 22, 2017, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6 - Contracts with Insurance Company**

The Plan has three fully benefit-responsive guaranteed investment contracts (GICs) with American United Life Insurance Company (AUL). AUL maintains the contributions in general accounts, which are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GICs issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 4% and 0%, depending on the GIC. Such interest rates are reviewed on a quarterly basis for resetting. The GICs do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Because the GICs are fully benefit-responsive, contract value is the relevant measurement for the GICs, as this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value as reported to the Plan by AUL represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of the investment contracts at December 31, 2024 and 2023, was \$1,498,784 and \$1,634,601, respectively.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (3) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

#### **Note 7 - Related Party and Party-in-Interest Transactions**

Plan investments are GICs and pooled separate accounts managed by AUL, the custodian, as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

AUL provides certain administrative services to the Plan pursuant to an agreement between the Center and AUL. AUL receives revenue from mutual fund and pooled separate account service providers for services AUL provides to the funds. This revenue is used to offset certain amounts owed to AUL for its administrative services to the Plan.

If the income received by AUL from such mutual funds or pooled separate accounts service providers exceeds the amount owed, AUL retains the excess. The Plan or Plan sponsor may make a payment to AUL for administrative expenses not covered by revenue sharing.

#### **Note 8 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **Note 9 - Plan Amendments**

Effective February 15, 2024, the Plan was amended to incorporate the below provisions:

1. The service requirement for employer matching contributions changed from one year of service to one month of service.
2. Vesting schedule changed from five-year graded vesting to four-year graded vesting.

In connection with the SECURE Act 2.0, the Plan has elected to apply the optional provisions including increasing the minimum vested account balance threshold for mandatory distributions from \$5,000 to \$7,000. The Company intends to formally amend the Plan document to reflect the changes in a future amendment.

**Note 10 - Delinquent Participant Contributions**

During 2023, the Company failed to remit to the Plan's trustee certain employee contributions totaling approximately \$148 within the period prescribed by DOL regulations. Delays in remitting contributions to the trustee were due to administrative errors, and the Company has made contributions to the affected participants' accounts to compensate those participants for potential lost income due to the delay.

**Note 11 - Subsequent Event**

Effective June 30, 2025, the Plan was amended and restated for the change in Plan trustee from American United Life Insurance Company to Empower Retirement, LLC.

The Plan sponsor has evaluated subsequent events through June 30, 2025, the date which the financial statements were available to be issued.
