### ***Opinion***

We have audited the financial statements of SPS Companies, Inc. Employee Benefit Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), which comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits (modified cash basis) for the years then ended, and the related notes to the financial statements.

**Note 1. Description of the Plan**

***General***

The following description of the SPS Companies, Inc. Employee Benefit Plan (the Plan) provides only general information about the Plan's provisions. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

The Plan provides health and other benefits covering certain employees and covered dependents who meet certain eligibility requirements. Covered employees include those employed by the following controlled entities: SPS Companies, Inc., Steel and Pipe Supply Company, Inc., Steel Management Group, Inc., Steel Ventures LLC (d/b/a Exttube), SPS Metallurgical Laboratories, LLC, Storage & Processors, Inc., S&P Trucking, Inc., Tubular USA, LLC, Energy Steel Products, Royal Metal Industries, LLC and U.S. Wholesale Pipe & Tube, LLC (the Company). Retired employees are entitled to medical and dental benefits if they have attained at least age 59.5 and have at least 10 years of service with the Company through Medicare eligibility age. Certain plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The eligibility requirement is 30 days of service for entrance into the various plans to begin coverage.

***Benefits***

The Plan provides health, dental, disability, vision, life insurance, critical illness, accident, cancer, accidental death and dismemberment, wellness, employee assistance and identify theft benefits. Retired employees and spouses, if elected, are entitled to the same health and dental benefits at the same premium rates as active employees until retiree coverage ends. The Plan also provides continuation of certain benefits upon termination of employment through the *Consolidated Omnibus Budget Reconciliation Act* (COBRA).

***Insured Benefits***

Participants can enroll in certain voluntary benefits that are fully-insured, including disability, vision, life insurance, critical illness, accident, cancer, accidental death and dismemberment, wellness, employee assistance and identify theft coverage. The Company purchases annual insurance contracts for these insured benefits. Premiums for voluntary coverages are fully funded by participants.

***Self-Insured Benefits***

All other plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the Plan's VEBA trust or the general assets of the Company. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

***Stop-Loss Coverage***

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

***Flexible Spending Arrangements***

The Plan has two flexible spending arrangements (FSAs) that are funded through participant and Company contributions. The FSAs allow eligible participants to be reimbursed tax free for qualified medical and dependent care expenses subject to a specified ceiling. Amounts remaining at the end of the year can generally be carried over to the next year as defined in the Flexible Benefit Plan Document. The employer is not permitted to refund any part of the balance to the employee; the account cannot be used for anything other than reimbursements for qualified medical and dependent care expenses; and remaining amounts are not portable upon termination once the employee leaves the employer.

***Health Savings Account Arrangement***

The Plan's health savings account arrangement (HSA) is funded through participant and Company contributions. The HSA allows eligible participants to be reimbursed tax free for qualified medical expenses subject to a specified ceiling. Amounts remaining at the end of the year can be carried over to the next year. While the HSA is made available to plan participants, the related activity is not included in the Plan's financial statements, as the ultimate disposition of the funds is directed by participants.

***Contributions***

In addition to deductibles and copayments, participants and retirees may contribute specified amounts, based on applicable monthly premiums for their respective benefit elections. The costs of the postretirement benefit plan are shared by the Company and retirees. The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

***Plan Termination***

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The Plan maintains its accounts on the basis of cash receipts and disbursements (modified cash basis) which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Consequently, certain revenue and the related assets are recognized when received rather than when earned, and certain expenses are recognized when paid rather than when the obligation is incurred.

***Use of Estimates***

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported benefit obligations and changes therein. Actual results could differ from those estimates.

**Payment of Benefits**

Premiums paid by either the Company or the VEBA trust are recorded as premium payments in the accompanying statements of changes in net assets available for benefits (modified cash basis).

Claim payments are recorded when paid by the third-party claims processor. These payments are recorded as claims paid in the accompanying statements of changes in net assets available for benefits (modified cash basis).

**Investment Valuation and Income Recognition**

The Plan’s investments are stated at fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the modified cash basis.

**Postretirement Benefits**

A postretirement benefit obligation has been prepared for retiree health and dental benefits for eligible participants and their spouses upon retirement. The postretirement benefit obligation represents the actuarial present value of the cost of those estimated future benefits that are attributed by the terms of the Plan to employee service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current retirees of the Plan (see *Note 3*). The obligations represent the amounts that are expected to be funded by contributions from the Company and from existing assets of the Plan. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their spouses and (2) active employees and their spouses after retirement from service with the Company. Prior to an active employee’s full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee’s service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

For measurement purposes, a 7.5% weighted-average annual rate of increase in the average per capita cost of covered health care benefits was assumed for 2025; the rate was assumed to decrease gradually to 4.50% through 2035 and to remain at that level thereafter. These assumptions are consistent with those used to measure the benefit obligation at December 31, 2024.

The following were other significant assumptions used in the valuations as of December 31, 2024 and 2023. Assumptions are based on the participant census as of November 1 of each year.

***Other Plan Benefits***

Plan obligations for health claims incurred but not reported are estimated based upon historic claims experience and actual claims reported subsequent to the Plan's year end. Additional accruals are included for the estimated ultimate cost of future claims only if such claims are covered as of the Plan's fiscal year end and the Plan is obligated to pay for the care regardless of continued participation in the Plan.

***Stop-Loss***

Premiums for stop-loss insurance are included in premium payments in the accompanying statements of changes in net assets available for benefits (modified cash basis). Stop-loss refunds totaling \$459,098 and \$466,882 have been netted with claims paid in the accompanying statements of changes in net assets available for benefits (modified cash basis) for 2024 and 2023, respectively.

***Flexible Spending Arrangement***

Included in the accompanying statements of net assets available for benefits (modified cash basis) are amounts available to reimburse participants for qualifying medical and dependent care expenses as of December 31, 2024 and 2023 totaling \$25,000 and \$25,384, respectively. Claims incurred before plan year end that were submitted after year end (in the grace period for use of contributions as defined by the Plan agreement) totaled \$19,600 and \$18,332 relating to 2024 and 2023, respectively. Forfeited amounts were used by the Company to offset administrative expenses.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

***Other Obligations for Current Benefit Coverage***

The Plan benefit obligation for other obligations for current benefit coverage as of December 31, 2024 and 2023 are attributable to health and dental claims incurred but not reported. The Company estimates the benefit obligation using the most recent claims reports from the health and dental third-party administrators. The Company believes that by March 31 of the subsequent year, substantially all claims incurred for the previous year have been reported. The following table presents the total claims incurred but not reported and the change in the benefit obligation.

The postretirement benefit obligation represents the actuarial present value of the cost of those estimated future benefits that are attributed by the terms of the Plan to employee service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current retirees of the Plan. The following table presents the postretirement benefit obligation and the change in the benefit obligation.

The weighted-average health care cost-trend rate assumption (see *Note 2*) has a significant effect on the amounts reported as postretirement benefit obligations. If the assumed rates increased by one percentage point in each year, it would increase the obligations as of December 31, 2024 and 2023 by \$321,699 and \$281,465, respectively.

The Plan's deficiency of net assets over benefit obligations at December 31, 2024 and 2023 relates primarily to the postretirement benefit obligation, the funding of which is not covered by the current contribution rate. It is expected that the deficiency will be funded through future increases in the contribution rates.

**Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Company is responsible for day-to-day plan administration and provides certain administrative services at no cost to the Plan. Administrative expenses paid to third-party service administrators under administrative service only agreements for processing of claims and other administrative services were \$354,946 and \$333,279 for the years ended 2024 and 2023, respectively.

**Note 5. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

**Note 6. Risks and Uncertainties**

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**Note 7. Tax Status**

The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service dated December 20, 1995, stating that the trust, as then designed, was tax-exempt under the provisions of Section 501(c)9 of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan and related trust are currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code. However, as a result of the Plan's funding policy, from time to time, the trust may be subject to income taxes. No federal or state income taxes have been recorded in the financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
