## Notes to the Financial Statements

### 1. Description of Plan

The following description of the Rockcastle Hospital and Subsidiaries Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all eligible employees of Rockcastle Regional Hospital and Respiratory Care Center, Inc. and Subsidiaries (collectively referred to as the Plan Sponsor or Administrator). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as well as applicable sections of the *Internal Revenue Code* (IRC). The Board of Directors is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan Sponsor's Board of Directors.

#### Eligibility

Employees become eligible to participate in the Plan upon completion of one year of service (defined as a year within which employees work a minimum of 1,000 hours) and attainment of age 21. Employees can begin participating in the Plan on semi-annual entry dates.

#### Contributions

The Plan permits eligible employees, through salary reduction elections, to make annual contributions of up to the maximum amount allowable under the limits of the IRC, Section 401(k). Participants are required to contribute, at a minimum, 1% of their compensation, as defined by the Plan agreement (2% for all employees hired on January 1, 2018 or after). The Plan Sponsor makes a matching contribution of 50% of each participant's salary reductions (up to 6% of eligible compensation). Employee rollover contributions are also permitted. The Plan Sponsor may also contribute a discretionary amount to be determined annually. No discretionary contributions were made by the Plan Sponsor in 2024.

#### Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions and the Plan Sponsor's matching contribution, as well as allocations of the Plan Sponsor's discretionary contribution, if any, and plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

## 1. Description of Plan, continued

### Forfeited Accounts

Forfeited balances or terminated participants' non-vested accounts are used first to reinstate previously forfeited account balances of re-employed participants, if any. The remaining amount will be used to reduce the Plan Sponsor's contributions or offset Plan expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$81,952 and \$46,011, respectively. During 2024, \$4,459 of forfeitures were used to reduce the Plan Sponsor's contributions. Forfeited participant balances during 2024 totaled \$36,005.

### Investment Options

Participants direct the investments of their contributions into various options offered by the Plan. The Plan Sponsor's contributions are automatically invested in the same investment options at the same percentage as participant deferral contributions.

Periodic transfers among funds of certain accumulated account balances and changes in the direction of future participant deferral and Plan Sponsor matching contributions are permitted.

### Payment of Benefits

Benefits are paid at the normal retirement date, in the event of death or disability, or according to the vested amount if employment is terminated. Upon termination of service, participants receive their benefits in a lump-sum amount.

### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting of the Plan Sponsor's contributions is based on years of continuous service according to the following schedule:

Participants are immediately vested in all contributions in the event of death, disability or the attainment of normal retirement age.

## 1. Description of Plan, continued

### Risks and Uncertainties

The Plan provides for participant-directed investment options into various securities. Investment securities, in general, are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

## 2. Summary of Significant Accounting Policies

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP) which require the Plan's management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. The following is a summary of the significant accounting policies consistently followed by the Plan in the preparation of its financial statements:

### Cash and Cash Equivalents

Cash and cash equivalents consist of investments in money market funds. Cash and cash equivalents are recorded at cost, which approximates fair value.

### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value with the exception of fully benefit-responsive investment contracts, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year.

### Contributions

Contributions from Plan participants and the Plan Sponsor's matching contributions are recorded in the year in the employee contributions are withheld from compensation.

### Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

### 2. Summary of Significant Accounting Policies, continued

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative and Investment Expenses

Certain administrative expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### Subsequent Events

The Plan's management has evaluated subsequent events through July 28, 2025, the date that the financial statements were available to be issued.

### 3. Investment Contract with Insurance Company

The Plan has a fully benefit-responsive investment contract with The Standard. The Standard maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value, as reported to the Plan by The Standard. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (iii) bankruptcy of the Plan Sponsor or other Plan Sponsor event (e.g., divestures or spin-offs of a subsidiary) that causes a significant withdrawal from the Plan; or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The interest crediting rate was 3.04% and 2.78% as of December 31, 2024 and 2023, respectively. Such interest rates are reviewed on a quarterly basis for resetting. The average yield for the year ended December 31, 2024 was 3.04%.

### 4. Certified Investment Information

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held as of December 31, 2024, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (Reliance Trust), a qualified institution.

### 5. Fair Value Measurements

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets), Level 2 (not traded on an active market but for which observable market inputs are readily available), and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 6. Exempt Party-in-Interest Transactions

The Standard is the Plan's recordkeeper as defined by the Plan and therefore, these transactions qualify as party-in-interest. Fees paid by the Plan to The Standard totaled \$11,993 for the year ended December 31, 2024.

Additionally, indirect fees are paid to The Standard based on investment account values. These fees range from 0.02% to 0.82% of the investment account value for The Standard. The fees are included with net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

### 7. Tax Status

The Plan uses a prototype plan document sponsored by The Standard, the Plan's recordkeeper. The Standard received an opinion letter from the IRS, dated June 30, 2020, which states that the prototype document satisfies the application provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

### 8. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
