Opinion

Note 1 – Description of the Plan

The following description of the Thompson & Litton, Inc. Employee Stock Ownership Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

Thompson & Litton, Inc. (the “Company”) established the Plan effective as of January 1, 2012. The Plan operates as an employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the *Internal Revenue Code (IRC)* of 1986, as amended and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is administered by an employee of the Plan Sponsor appointed by the Sponsor Company’s Board of Directors. Five employees of the Plan Sponsor serve as the Plan’s Trustees.

Eligibility

All employees of the Company, except non-resident aliens, union employees, and leased employees, who have obtained the age of 21 are eligible to participate in the Plan following the completion of one year of qualifying service (1,000 hours). An eligible participant may enter the Plan on January 1 or July 1 after meeting the eligibility requirements. The participant must be employed on the last day of the Plan year to be eligible.

Investments

All investments are nonparticipant directed investments. The Plan holds the common stock in a trust established under the Plan. See Note 4 and Note 5 for details of the stock purchase and loan payable. As the Plan makes each payment of principal, an appropriate percentage of stock will be allocated to eligible employees’ accounts in accordance with applicable regulations under the *IRC*. The loan payable is collateralized by the unallocated shares of common stock and is guaranteed by the Company. The lenders have no rights against shares of common stock once they are allocated under the provisions of the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023 and for the year ended December 31, 2024, present separately the assets and liabilities and changes therein pertaining to:

- the accounts of employees with vested rights in allocated common stock (Allocated); and,
- common stock, checking account, and money market not yet allocated to employees (Unallocated).

Employer Contributions

Contributions by the Company are established by resolution of the Company’s Board of Directors. Contributions are made from accumulated earnings of the Company and are discretionary; however, the Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan’s dividends and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its loan payable.

Employer contributions and forfeited balances of terminated participant’s non-vested accounts are allocated based on the proportion of each participant’s compensation to the total compensation of all participants, as defined in the Plan document.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock released by the Trustees from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings and expenses are allocated to each participant's account based on the ratio of the participant's beginning of the year account balance to all participants' beginning of the year account balances. Stock earnings and losses are allocated to each participant's account based on the ratio of the participant's compensation to the total compensation of all participants.

Vesting

Vesting in the Company's contribution, plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service, with no vesting for years of service less than two years and 20% per year for any years of service from two to six years. A participant is fully vested at normal retirement age, delayed retirement, and the date of total and permanent disability or death.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant or a participant's beneficiary may elect to receive a single lump-sum amount equal to the value of the participant's vested interest in his or her account. In-service distributions are not permitted. Upon termination, benefits will commence no later than one year after the close of the 5th Plan year in which a participant separated from service. For termination due to death, disability, or retirement, benefits shall commence no later than one year after the close of the Plan year in which the event occurs. Benefits may be paid in up to 5 annual installments as determined by the employer.

Forfeited Accounts

The non-vested portion of a participant's account is reallocated to participant accounts of remaining eligible participants at the end of the Plan year. No forfeitures were reallocated to participants' accounts for the year ended December 31, 2024.

Voting Rights

Shares of Company stock in the trust shall be voted by the Trustees only, in a manner as shall be directed by the Plan Administrator. In certain instances, such as plan merger, consolidation, and liquidation, each participant is entitled to exercise voting rights attributable to the shares allocated to their account and is notified by the Trustees prior to the time that such rights are to be exercised. Any allocated Company stock with respect to which voting directions are not received from participants shall be voted in the manner determined by the Plan Administrator.

Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market or is subject to trading limitations, includes a put option. The put option is a right to

demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least ten years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify may receive a cash distribution or may elect to rollover that portion of their account balance to the Sponsor Company's 401(k) plan.

Plan Expenses

Substantially all administrative expenses of the Plan are paid by the Company.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Benefit Payments

Benefits are recorded when paid.

Cash

The Plan maintains cash in a non-interest bearing account with a local bank. The account is insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. At times, cash may exceed federally insured limits.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by investment advisors, an independent certified business valuation analyst, and a bank. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Authoritative guidance issued by the Financial Accounting Standards Board establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

The fair value of the Company common stock is determined by an annual independent appraisal. This appraisal was based on an income valuation approach. The appraiser took into account historical and projected cash flow and net income,

return on assets, return on equity, market comparables, and fair value of the Company's assets and liabilities, as well as applying a discount for the lack of marketability for non-publicly traded stock. Significant changes to these inputs could have resulted in a significantly higher or lower fair value measurement for the Company common stock. Note 4 – Investment in Company Common Stock

In April 2013, the Plan purchased 50,000 shares of the Company common stock representing 50.51% of the outstanding stock from four shareholders. The purchase was funded from cash in the Plan of \$499,918 from the 2012 employer contribution, and with notes payable to four shareholders totaling \$1,407,582 (see Note 5) at \$38.15 per share for a total purchase price of \$1,907,500.

On May 21, 2015, the shareholders of Thompson & Litton, Inc. agreed to sell the remaining 49,000 outstanding shares to the Plan at a price of \$32.80 per share for a total of \$1,607,200. Financing was obtained from a bank to make this purchase and to pay off the remaining debt owed to four shareholders for the initial share purchase.

On December 31, 2024, the Board of Directors of Thompson & Litton, Inc. agreed to contribute 7,730 newly issued shares of common stock at a price of \$64.68 per share for a total of \$499,976.

Note 5 – Loans Payable

The Plan purchased common shares of the Company using the proceeds of notes payable to four shareholders, dated April 30, 2013, with required annual installments of \$397,315 including principal and interest at 5.0%, with payments beginning April 30, 2014. These loans were refinanced into two new loans issued by the Company in May 2015 to purchase an additional 49,000 shares and pay off the notes payable to four shareholders. Of these two new loans, one was paid off in its entirety in 2017. The remaining loan consists of repayment terms of 15 annual installment payments of \$127,906

including principal and interest at 2.3%, with payments beginning May 26, 2016 and is secured by a first priority lien and pledge of the unallocated shares and a guarantee of the Company.

Because incurrence of this debt dilutes the value of the share price, the Company implemented a “Price Protection” guarantee for the period from the inception of the loan on April 30, 2013, through April 30, 2017, on which the fair market value of the Company stock equals or exceeds \$38.15 per share, the value before the loan was incurred.

This Price Protection would apply only to distributions to participants with shares allocated to their accounts prior to inception of the loan. Under the guarantee, the participant would receive from the Plan the value of the shares of stock at the current fair market price and would receive from the Company an amount equal to the difference between the current fair market price and the fair market price calculated without the effect of this debt.

Note 6 – Related Party Transactions

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

Note 8 – Tax Status

The Plan obtained its Internal Revenue Service determination letter on July 11, 2014, in which the Internal Revenue Service stated that the Plan and related trust are designed in accordance with applicable sections of the *IRC*. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the *IRC*, and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more

likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 9 – Subsequent Events

Plan management has evaluated subsequent events through July 25, 2025, which is the date the financial statements were available to be issued.
