As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1. Plan Description

The following description of TaborStreet 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan for the benefit of its employees, excluding leased employees, nonresident aliens, employees covered by a collective bargaining agreement and other individuals who for any period are classified by the Company as independent contractors. As of and for the year ended December 31, 2023, the plan was sponsored by NMC Equipment Services, LLC and the Plan name was NMC Group 401(k) Retirement Plan. Effective January 1, 2024, Tabor Street Group LLC (the Company) assumed sponsorship and the plan was amended and the name was changed to TaborStreet 401(k) Retirement Plan. All other provisions of the Plan remained the same.

Non-excluded employees are immediately eligible for the Plan upon their hire date and are able to enter the Plan to make participant contributions and receive Company matching contributions as of the first day of the month following their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and the applicable current Internal Revenue Code provisions. The Plan is administered by the 401(k) Retirement Plan Committee.

Contributions and investment options: Each year, participants may contribute from 1% to 100% of pretax annual compensation, as defined by the Plan. Additionally, participants are able to make Roth elective deferrals and voluntary after-tax contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Participants receive a 100% match on the first 6% of nonelective deferrals. The Plan limits this match to a maximum amount of \$2,000 for the year ended December 31, 2023 and \$3,000 for the year ended December 31, 2024. The Plan also allows for additional discretionary matching contributions. There were no discretionary contributions in 2024 or 2023. Contributions are subject to certain limitations. Participants direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan. Participants may change their investment options at any time.

The Plan has an automatic enrollment feature. Once eligible, employees are automatically enrolled in the Plan at a deferral rate of 3% unless otherwise elected, and additionally are enrolled in the annual automatic deferral increase feature, which automatically increases a participant's deferral each year by 1% until the deferral reaches 10%, occurring April 1 of each year. Participants have 45 days following the date first eligible to elect nonparticipation in the Plan and receive a refund of previous withholdings.

Participant accounts: Each participant's account is credited with the participant's contributions and allocations of: (1) the Company's contributions, (2) Plan earnings and (3) forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of participants' accounts is based on years of continuous service.

Note 1. Plan Description (Continued)

Vesting in the Company's contributions begins after two years of service, based on the following table:

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes receivable are secured by the balance in the participant's account and bear interest at the prime rate plus 1% at the time of issuance. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years from the date of the loan. A loan term may extend beyond five years if the loan is used to acquire the participant's principal residence. A participant may have only one loan outstanding at any time. Notes receivable outstanding as of December 31, 2024, mature through 2029 with interest rates ranging from 4.25% to 9.5%.

Payment of benefits: Upon the earlier of termination of service due to death, permanent disability, retirement or attainment of age 70½, a participant will receive a lump-sum amount equal to the vested value of the participant's account, subject to mandatory income tax withholding, unless the participant rolls over the distribution into another qualified plan. For participants who attain age 70½ after 2019, the required beginning date for required minimum distributions increased from age 70½ to age 72. Participants are allowed to take an in-service withdrawal from their accounts upon attainment of age 59½.

Revenue sharing account: Fees received from the Plan investments in the form of 12b-1 fees, sub-transfer agency fees and administrative servicing fees, are paid into an In Plan ERISA Account within the Plan. Contractual fees for recordkeeping services and other allowable plan administrative expenses are paid from this account or may be allocated to the participants at the discretion of the Company. For the year ended December 31, 2024, revenue sharing income received totaled \$36,301, earnings of \$441 and expenses paid totaled \$30,915. The balance of revenue sharing funds at December 31, 2024 and 2023, was \$8,272 and \$2,886, respectively.

Forfeited accounts: Forfeited nonvested accounts totaled approximately \$0 and \$50,200 at December 31, 2024 and 2023, respectively. These accounts were used to reduce Company contributions in 2024. During 2024, forfeitures of approximately \$239,700 were used to reduce Company contributions.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2. Summary of Significant Accounting Policies (Continued)

Investment valuation and income recognition: Investments are reported at fair value, except for a fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The 401(k) Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by investment advisors, the trustee and the insurance company. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions: Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which employee contributions are withheld from compensation.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Other expenses, primarily contract administration and record-keeping fees, as well as audit fees, are paid by the Plan and are reflected in the Plan's financial statements. Investment-related expenses are included as an offset to net appreciation in fair value of investments.

Note 3. Information Certified or Provided by John Hancock Trust Company LLC (Trustee)

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by John Hancock Trust Company LLC, the trustee of the Plan. The Plan Administrator has obtained certifications from the trustee that information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5. Investment Contract With New York Life Insurance Company

The Plan invests in an investment contract with New York Life Insurance Company (New York Life), which was determined to be a fully benefit-responsive investment contract and, therefore, is reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment account as the guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The Plan owns a promise to receive interest at crediting rates that are announced in advance and guaranteed for a specified period of time as outlined in the group annuity contract. New York Life maintains the contributions in a general account. Contract value, as reported to the Plan by New York Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The crediting interest rate is based on the earnings of the underlying assets and is subject to a minimum rate provision, but it may not be less than 1%. Such interest rates are reviewed on a semiannual basis for resetting. The crediting interest rate is reset per contract provisions. Past interest rates are not indicative of future interest rates. Key factors that could influence the interest crediting rates are changes in economic and market conditions, interest rates, and default or credit failures of the securities in the insurer's general assets.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (a) amendments to the Plan document (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

New York Life may terminate the investment contract with the Plan by providing 30 days' advance written notice to the contract owner. If New York Life terminates the contract, the balance in the guaranteed interest account will be paid within 90 days.

Note 6. Related-Party Transactions and Party-in-Interest Transactions

Plan investments are managed by John Hancock Trust Company LLC, the Plan trustee and recordkeeper, and therefore these transactions qualify as party-in-interest transactions. The Plan paid approximately \$240,000 of record-keeping and other fees to the trustee and D.A. Davidson, investment advisor, during the year ended December 31, 2024. The Company also provides certain administrative services at no cost to the Plan.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

Note 8. Income Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, The Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Note 10. Subsequent Events

The Plan has evaluated subsequent events through July 29, 2025, the date the financial statements were available to be issued.
