### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Carrollton Bank Employees 401(k) and Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Carrollton Bank Employees 401(k) and Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements of information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material aspects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTE 1. DESCRIPTION OF PLAN

The following description of the Carrollton Bank Employees 401(k) and Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Carrollton Bank (the Company) who, are age nineteen or older prior to October 1, 2019 and twenty-one or older thereafter. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year participants may contribute up to 100% of pre-tax annual compensation, not to exceed the dollar limitation contained in section 402(g) of the Internal Revenue Code (IRC) in effect at the beginning of the year. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds and collective trusts as investment options for participants. The Company will make matching contributions equal to a discretionary percentage of participant's elective deferrals on a uniform basis for all participants, in addition to making a discretionary profit sharing contribution. When a Company discretionary contribution is made to the Plan, the contribution amount is allocated to the participants based on the proportion of their eligible earnings to the total of all eligible earnings. Contributions are subject to certain limitations and special arrangements.

Participant Accounts

Each participant's account is credited with the participant's contribution, matching and discretionary contributions made by the Company, and earnings thereon. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portions of their accounts plus actual earnings thereon is based on years of continuous service. The vesting schedules for the Company discretionary and matching contributions are as follows:

Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%

5 but less than 6	80%
6 or more	100%

The Plan also states that any non-highly compensated employee whose position was eliminated between July 28, 2023, and March 1, 2024, due to corporate restructure, becomes 100% vested in the Plan on the date of their separation of employment.

Participant Loans

Loans are not permitted under the Plan.

NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

Payment of Benefits

On termination of service due to death, disability, retirement, or due to other reasons, a participant or beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, as well as two additional distribution options including installment distributions or a partial lump-sum distribution.

Plan Administration

The Plan is administered by the Company's Board of Directors, which is comprised primarily of members of the Company's management. Charles Schwab serves as the asset custodian and Retirement Plan Services is the record keeper for the Plan.

Forfeited Accounts

Forfeitures of the Company's discretionary and matching contributions will reduce future contributions of the same type. Forfeited non-vested accounts totaled \$39,442 and \$187,554 for the years ended December 31, 2024 and 2023. In 2024, employer contributions were reduced by \$39,442 from forfeited non-vested accounts.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accounts of the Plan are maintained on the accrual basis of accounting.

Investments

The Plan's investments are stated at fair value. Quoted market prices are used to value mutual fund investments. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid to participants.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability, with corresponding addition to 2024 distributions. The Plan distributed the 2024 excess contributions prior to March 15, 2025. There were \$250 and \$3,641 for excess contributions for the years ended December 31, 2024 and 2023.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Administrative Expenses

All administrative expenses are allocated to the participants of the Plan.

NOTE 3. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risk such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 4. INVESTMENTS

Unaudited Information Certified by the Asset Custodian

The December 31, 2024 and 2023 Statements of Net Assets Available for Benefits, the investment activities included on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by Charles Schwab Trust Bank, the asset custodian in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$91,111,601 and \$81,055,712 at December 31, 2024 and 2023, respectively, and related net investment income of \$10,222,539 for the year ended December 31, 2024.

NOTE 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 6. FAIR VALUE MEASUREMENT

FASB Accounting Standards Codification 820, Fair Value Measurement and Disclosure, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority with Level 3 inputs having the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The investments in collective trusts are valued as a practical expedient utilizing the net asset valuation, exclusive of the adjustment to contract value. The use of net asset value as fair value is deemed appropriate as the collective trusts do not have a finite life, unfunded commitments relating to these types of investments, or significant restrictions on redemptions. The practical expedient is used for valuation, unless it is probable that the Fund will see a portion of the investment at an amount different from the net asset valuation.

NOTE 7. TAX STATUS

The Internal Revenue Service has determined and informed the Plan by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Company has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the open tax years are those years ended December 31, 2021 through December 31, 2024.

NOTE 8. PARTY IN INTEREST TRANSACTIONS

Fees paid by the Plan for recordkeeping services amounted to \$121,218 for the year ended December 31, 2024. Fees paid by the Plan for advisory services amounted to \$133,770.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 9. SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through July 14, 2025. From this evaluation, no events were identified that met the requirement for disclosure.
