Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Notes to Financial Statements

December 31, 2024

1. Description of the Plan

The following description of iXsystems, Inc. 401(k) Profit Sharing Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions. Copies of this publication are available from iXsystems, Inc. (the “Plan Sponsor”). Effective May 31, 2025, the Plan was renamed iXsystems, Inc., d/b/a TrueNas 401(k) Profit Sharing Plan & Trust.

General

The Plan is a defined contribution plan and is subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA). All employees, other than nonresident aliens, who have completed three months of qualified service and who are at least 21 years of age, are eligible to become participants in the Plan. Effective March 1, 2024, the Plan was amended to allow employees to enter the Plan after 60 days of service.

Contributions

Participants may elect to make 401(k) contributions up to 100% of their pre-tax or after-tax annual compensation, as defined in the Plan Document, subject to certain Internal Revenue Service (IRS) limitations. In addition, participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change the investment options previously elected at any time.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation.

The Plan Sponsor may make discretionary profit-sharing contributions or qualified nonelective contributions to the Plan. Participants that are employees on the last day of the plan year are eligible for the Plan Sponsor profit sharing contributions, if any, after three months of service. The Plan Sponsor makes safe harbor matching contributions equal to 100% of participant deferrals up to 3% of eligible compensation plus 50% of participant deferrals from 3% to 5%.

Cash contribution receivables, if any, are unsecured.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and Plan Sponsor contributions, investment earnings and losses that are allocated based on each participant’s relative account balance within the respective fund, and an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. Description of the Plan (continued)

Vesting

Participants are immediately vested in their elective contributions, rollover contributions from other qualified plans, qualified nonelective contributions, Plan Sponsor safe harbor matching contributions, and related earnings thereon.

Vesting in the Plan Sponsor's profit-sharing contributions plus related earnings thereon is based on years of service (at least 1,000 hours) as follows:

Less than 2 years	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 or more years	100%

Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures of terminated participants' non-vested accounts may be used to reduce future Plan Sponsor contributions to the Plan or plan expenses. If a terminated participant is rehired by the Plan Sponsor, the participant may be entitled to a restoration of certain amounts forfeited, based on provisions in the Plan Agreement. In 2024, forfeitures generated totaled \$4,939. As of December 31, 2024, the forfeitures account totaled \$4,728.

Notes Receivable from Participants

Participants may borrow from their fund accounts. The minimum amount of the loan is \$1,000, and the maximum amount is the lesser of one-half of the participant's vested account balance or \$50,000. Two loans may be outstanding at a time per participant, and the loans generally bear interest at the prime interest rate plus 1%. The loans are generally repayable in level periodic payments over various terms of up to five years, except for those utilized for the acquisition of a principal residence, which may be repaid over a period of time up to 30 years. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions.

1. Description of the Plan (continued)

Payment of Benefits

At any time on or after the age of 59½ or upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount or installments equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

In-service hardship withdrawals are available in certain circumstances.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Plan Sponsor contributions.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP), as are the annual returns filed under applicable provisions of ERISA and the Internal Revenue Code (IRC).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts in the Plan's financial statements. Accordingly, actual results may differ from those estimates.

Investments

Empower Trust Company, LLC (Empower) holds the Plan's investments in various mutual funds and a fixed annuity option of Empower Annuity Insurance Company of America (EAICA), the EI Fixed Account. Net appreciation or depreciation in the fair value of investments is reflected in the Statement of Changes in Net Assets Available for Benefits. This includes all investments bought or sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

2. Significant Accounting Policies (continued)

Investments (continued)

Generally, the Plan's investments are collateralized by the proportionate share of the respective fund's underlying net assets. The maximum loss, if any, incurred by the Plan if the counterparties to the Plan's investments failed to perform and any collateral was insufficient, would be the recorded amount of such investment.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Upon default of notes receivable from participants, the entire outstanding principal and interest shall be immediately due and payable. If a distributable event, as defined by the IRC, has occurred, the note receivable will be foreclosed on and be offset against the participant's account balance. If a participant's note receivable is in default, the participant shall be treated as having a taxable deemed distribution whether or not a distribution event has occurred.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain plan administrative expenses are paid by the Plan Sponsor and are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net realized and unrealized appreciation in the fair value of investments.

Subsequent Events

Plan management has evaluated subsequent events through July 28, 2025, the date the financial statements were available to be issued.

3. Income Tax Status

The Plan Sponsor adopted a prototype plan sponsored by Empower Retirement, LLC that received a favorable opinion letter from the IRS dated November 14, 2022, which states the form of the prototype plan is acceptable for use under applicable sections of the IRC. The Plan has been amended since the latest opinion letter date; however, the Plan Administrator believes the Plan is being operated in accordance with applicable requirements of the IRC and, accordingly, remains exempt from income taxes.

4. Certified Information (Unaudited)

Empower holds the Plan's investments assets and executes transactions therein. Financial information relating to those assets disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, net realized and unrealized appreciation in the fair value of investments, investment income (including \$1,026 from the EI Fixed Account), and interest income on notes receivable from participants, is based upon information provided to the Plan Administrator and agreed to or derived from information certified as complete and accurate by Empower.

5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement (Topic 820)*, are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.
- Level 2 Inputs to the methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

5. Fair Value Measurements (continued)

The fair value measurement level of the asset or liability within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes to the methodologies used as of December 31, 2024 and 2023.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

6. EI Fixed Account

The Plan invests in a fixed annuity contract of EAICA that is fully benefit-responsive. The contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. EAICA is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the investment is fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the investment contract. Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

6. EI Fixed Account (continued)

Certain events limit the ability of the Plan to transact at contract value with EAICA. Such events include amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator believes any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

7. Other Related Party and Party-in-Interest Transactions

Certain investments are held and managed by Empower and EAICA; therefore, these transactions qualify as party-in-interest transactions.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Delinquent Participant Contributions

Defined contribution plans are required to remit participant contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. During 2024, contributions totaling \$818 were not remitted within the required time period. As of July 28, 2025, the Plan Sponsor is in the process of correcting these delinquent contributions, including remitting the associated lost earnings to the Plan.
