1. DESCRIPTION OF THE PLAN

The following description of The Calvert School 403(b) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, which was established by The Calvert School (the School) effective March 1, 1990. The Plan covers substantially all employees of the School, in accordance with universal availability, who are reasonably expected to work more than 1,000 hours in each Plan year. There are no age or service requirements for participating in the Plan. Participants enter the Plan on the first day of the month following the fulfillment of the eligibility requirements. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was most recently amended in December 2024 to allow all employees to participate in the Plan effective January 1, 2025.

Participant Contributions

Participants may make pre-tax contributions in any whole percentage of applicable compensation or as a flat dollar amount, not to exceed the maximum allowable contribution under the Internal Revenue Code (the Code), which totaled \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants' pre-tax contributions for a calendar year must be at least \$200. Participants who have attained age 50 before the end of the Plan year may make additional catch-up contributions, subject to limitations imposed by the Code, which totaled \$7,500 for each of the years ended December 31, 2024 and 2023. The School remits participants' contributions to the Plan through payroll on a biweekly basis. Participants may roll over amounts into the Plan representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants are eligible to make Roth contributions to the Plan. The participants' Roth elective contributions are allocated to a separate account maintained for such contributions. Roth elective contributions are treated as elective contributions for all purposes under the Plan.

Effective July 1, 2023, the Plan was amended to add automatic enrollment of 4% for all new employees whose employment commences after that date and any existing employees not contributing to the Plan, unless they elect not to participate. The Plan was also amended to include an automatic escalation feature whereby the deferral percentage will increase by 1% annually each year on July 1 starting July 1, 2024 up to a maximum of 9%.

School Matching Contributions

Participants are eligible to receive matching contributions following the completion of 90 days of employment. The School makes a matching contribution to the Plan based on the participant's contributions. The match is limited to 50% of a participant's contributions, up to the first 6% of the participant's compensation on a biweekly basis. Participants who elect to make after-tax contributions are eligible to receive a matching contribution on those contributions.

School Matching Contributions – cont’d.

The School made matching contributions to the Plan totaling \$261,297 and \$245,230, net of forfeitures applied, for the years ended December 31, 2024 and 2023, respectively.

School Basic Contributions

Participants are eligible to receive basic contributions following the completion of 90 days of employment. The School makes a basic contribution equal to 3% of a participant’s compensation each payroll period. The School made basic contributions to the Plan totaling \$294,391 and \$283,987 for the years ended December 31, 2024 and 2023, respectively.

Participant Accounts

Accounts are participant-directed and are credited with the participant’s contributions and an allocation of Plan earnings, and are charged with any direct expenses related to the specific account. Allocations are based on participant account balances or participant earnings, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Vesting

Participants are immediately vested in their contributions plus earnings and losses thereon. Participants vest in School matching contributions, basic contributions and earnings thereon based on years of service, as defined by the Plan, according to the following graduated vesting schedule:

Participants become fully vested in School matching and basic contributions upon normal retirement date, permanent disability, or death.

Forfeitures

Forfeitures can be applied to reduce future School matching and basic contributions. There were forfeitures available to the Plan totaling \$108 and \$46 as of December 31, 2024 and 2023, respectively. For the years ended December 31, 2024 and 2023, \$15,209 and \$10,650 of forfeitures were applied to reduce School matching and basic contributions, respectively.

1. DESCRIPTION OF THE PLAN – cont'd.

Payment of Benefits

Upon termination of service, retirement, death, disability, or attainment of age 59½, a participant (or their beneficiary, in the event of death) is entitled to a distribution of their account balance. Distributions from the Plan for participants who have reached retirement age are payable in the form of a lump sum equal to the value of the participant's account balance or in monthly, quarterly, semi-annual, or annual installments over a period of five to fifteen years. Prior to retirement, distributions from the Plan are payable in the form of a lump sum, as defined by the Plan. For terminated participants with vested account balances less than \$1,000 that meet the provisions, a mandatory distribution will automatically be paid to participants in a cash distribution if the participant does not elect the distribution method. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed by the participant may be withdrawn for a hardship purpose. Distributions are subject to the applicable provisions of the Plan agreement. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½. There were no net assets of the Plan allocated to accounts of participants who had elected to withdraw from the Plan that had not received such distributions as of December 31, 2024 and 2023.

Plan Expenses

All administrative expenses are required to be paid with the assets of the Plan, unless paid by the School, at its discretion. Expenses that are paid directly by the School are excluded from the Plan's financial statements.

The School entered into a revenue sharing agreement with T. Rowe Price whereby the accounts are used to redistribute excess Plan paid expenses to pay other expenses by the Plan or to be reallocated to participants. Revenue sharing amounts allocated to participants during the years ended December 31, 2024 and 2023 totaled \$33,993 and \$30,090, respectively. Such expenses are often indirect compensation in nature and are captured as a component of net appreciation in fair value of investments. Distribution fees are paid by the Plan and its participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to net assets and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in assets that are exposed to risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities may occur and materially affect the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Fair Value Measurement – cont’d.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Interest bearing cash: Valued at amortized cost plus accrued interest, which approximates fair value.

Interests in registered investment companies: Valued at the closing price of shares held by the Plan at year-end. Shares are traded on an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan evaluated for disclosure any subsequent events through June 30, 2025, the date on which the financial statements were available to be issued, and determined there were no material events that warrant disclosure.

3. INVESTMENTS

All investment data contained in the accompanying financial statements and supplemental schedule, including assets held at December 31, 2024 and 2023, interest and dividend income and net realized and unrealized appreciation in fair value of investments for the years ended December 31, 2024 and 2023 was obtained or derived from the information supplied to the Plan administrator and certified as complete and accurate by the Trustee of the Plan, T. Rowe Price Trust Company.

4. PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in shares of mutual funds managed by T. Rowe Price, an affiliate of T. Rowe Price Trust Company and T. Rowe Price Retirement Plan Services, Inc. T. Rowe Price acts as Custodian for the Plan. The School provides the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the School has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. INCOME TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the School by a letter dated April 13, 1992, that the Plan was designed in accordance with the applicable sections of the Code. The Plan has been amended since receiving the last determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

6. INCOME TAX STATUS – cont’d.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. Given that the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan’s financial statements. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023.

The Plan is subject to routine audits by the IRS and Department of Labor; however, there are currently no audits for any tax periods in progress.
