Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Corporate Group, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Notes to Financial Statements

1. Description of Plan

The following description of the Corporate Group, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for more complete information. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

General

The Plan is a defined-contribution plan sponsored by Corporate Group, Inc. (the Company or Sponsor) and its affiliated companies.

Two employees of the Company are the Plan Administrators. Transamerica Retirement Solutions is the Plan's third-party administrator and record keeper, and State Street Bank and Trust Company is the Plan's custodian.

Eligibility

Substantially all non-union employees of the Sponsor are eligible to participate in the Plan upon hire and are eligible to receive the Sponsor's matching contributions upon completion of one hour of service. To receive discretionary contributions from the Plan Sponsor, the participant must have completed 1,000 hours of service during the plan year and must be employed by the Plan Sponsor on the last day of the plan year.

Contributions

Participants may elect to defer 100% of their eligible compensation, as defined by the Plan, subject to the maximum contribution limits allowed by the Internal Revenue Service (IRS). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation. The deferral rate for enrolled participants will automatically increase by 1% each year, up to a maximum of 10%, unless otherwise opted out by the participant. The Plan allows participants to roll over distributions from other retirement plans (rollovers).

The Sponsor may make matching and discretionary contributions. During the year ended December 31, 2024, the Sponsor's matching contributions equaled 30% of the first 9% of the participant's contribution. During the year ended December 31, 2024, no discretionary contributions were made.

Participant Accounts

Each participant's account is credited with the participant's contributions, Sponsor contributions, and an allocation of the Plan's net earnings. Each participant's account is also charged with any distributions requested from their account and an allocation of Plan losses and administrative expenses. Plan earnings (losses) and administrative expenses are allocated to participants based on the ratio of each participant's account balance to total participant account balances within each respective Plan fund. The benefit to which a participant is entitled is the vested balance that can be provided by the participant's account.

Investment Options

Participants may invest the portion of their account balances into a variety of investments offered by the Plan. Participants may change their investment options daily.

Notes Receivable from Participants

Participants may request a note from the Plan not to exceed the lesser of 50% of the value of the participant's vested balance or \$50,000. The minimum note amount is \$2,000. Each participant may not have more than one loan outstanding at any time. The notes are secured by the balance in the participant's vested account. The interest rate charged is the prime rate, as stated in the Wall Street Journal, plus 1% at the time the note is executed. Interest rates ranged from 4.25% to 9.50% at December 31, 2024. Principal and interest is paid through payroll deductions.

Vesting

Participants are fully vested in their contributions and earnings thereon. Vesting in the Sponsor's matching and discretionary contributions is based on years of continuous service according to the following schedule:

Forfeitures

Forfeitures are portions of participant's account balances that participants surrender by terminating employment prior to becoming fully vested. Forfeitures of the Sponsor's contributions can be used to offset the Sponsor's matching contributions or administrative expenses. For the plan year ended December 31, 2024, \$283,856 were used to reduce the Sponsor's matching contributions. Unallocated forfeitures totaled \$39,982 and \$16,160 as of December 31, 2024 and 2023, respectively.

Payment of Benefits

Payment of benefits is made upon termination due to retirement, disability, death, or other termination of employment. The participant's vested balance is distributed in a lump-sum payment within 30 days after the request is made. Participants can also request payment of benefits in either installment payments or partial payments in addition to the lump-sum payment option. In addition, hardship distributions are permitted if certain criteria are met.

There were no benefits requested but not paid at December 31, 2024 and 2023.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Fees related to administration of notes receivable and benefit payments are charged directly to the participant's account. Fees related to the general administration of the Plan are allocated to participant accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP), except for benefits which are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the accompanying financial statements and notes. Actual results could differ from those estimates and are subject to change in the near term.

Cash

Cash is held in a non-interest bearing trust account that is recorded at cost.

Investment Valuation and Income Recognition

Investments are reported at fair value. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for further discussion of fair value measurement.

Net appreciation in fair value of investments included in the accompanying statement of changes in net assets available for benefits includes realized gains or losses from the sale of investments and unrealized appreciation or depreciation in the fair value of investments. Net unrealized appreciation or depreciation in the fair value of investments represents the net change in the fair value of investments held during the period. The net realized gains or losses on the sale of investments represents the difference between the sale proceeds and the fair value of the investments as of the beginning of the period or the cost of the investment if purchased during the year.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

Benefits are recorded when paid.

3. Fair Value Measurements

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, defines fair value as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

Accounting standards also establish a fair value hierarchy that requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement. The standard establishes three levels of inputs that may be used to measure fair value:

Level 1 - This level consists of quoted prices in active markets for identical assets or liabilities.

Level 2 - This level consists of inputs other than Level 1 that are observable, either directly or indirectly, such as quote prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - This level consists of unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds - Valued at quoted market prices which represent the net asset value (NAV) of shares held by the Plan at year end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different value measurement at the reporting date.

4. Information Certified by Plan Custodians

Certain information related to the Plan's investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income, and dividends for the year ended December 31, 2024, was obtained or derived from information certified as complete and accurate by State Street Bank and Trust Company and Standard Insurance Company, qualified institutions. As elected by the plan administrators, under the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan's independent accountants did not perform auditing procedures on the above information, except for comparing such information included in the accompanying financial statements and ERISA-required supplemental schedule.

5. Group Annuity Contract

In 2014, the Plan entered into a fixed-rate group annuity contract with Standard Insurance Company. The Standard Stable Asset Fund II (SSAF) is a fully benefit-responsive investment contract. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts, since this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. The contract value of the SSAF equals the accumulated cash contributions, interest credited, and transfers, if any, less any withdrawals and transfers, if any. The contract issuer is contractually obligated to pay the principal and specified interest rates guaranteed. There are no reserves against the contract value for credit risk of the contract issuer as of December 31, 2024 and 2023. The interest rate earned is established quarterly and is not guaranteed in future periods. Standard Insurance Company maintains the contributions in a general account.

The crediting interest rate is set by Standard Insurance Company using a process similar to that used by banks or other insurance companies for similar products. The crediting rate takes into account yield forecasts from Standard Insurance Company's asset advisory group and the margins for their business. The crediting rate is declared in advance and is reset quarterly. The SSAF is a single group annuity contract with a fixed rate of interest that will never drop below 1%. Changes in future

crediting interest rates will not affect the amount reported as an adjustment from fair value to contract value on the statements of net assets available for benefits.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following: (1) not abiding by state and federal law, (2) not in compliance with the terms of the contract, (3) balance in all investments falls below \$25,000, and (4) the IRS disqualifies the Plan.

6. Related Party and Party-in-Interest Transactions

Certain Plan investments were managed by entities related to Transamerica Retirement Solutions. Transamerica Retirement Solutions is the third-party administrator and record keeper, as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. These transactions are not considered prohibited under ERISA. Fees paid by the Plan to Transamerica Retirement Solutions for administration services and other transaction-based administrative expenses amounted to \$35,839 for the year ended December 31, 2024.

Robert W. Baird & Co. provides investment advisory services to the Plan. Fees paid by the Plan for these services were \$28,974 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Certain employees of the Sponsor provide administrative services to the Plan. These employees are not paid by the Plan for their services.

7. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right to discontinue its contributions or terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in the balance of their respective accounts.

8. Risks and Uncertainties

The Plan's investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and overall market volatility, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the financial statements.

Included in investments are the investments in the Janus Henderson Enterprise Fund, the Parnassus Core Equity Fund, and the Vanguard 500 Index Fund Admiral which represent 10% or more of total investments at December 31, 2024. At December 31, 2023, investments in the Janus Henderson Enterprise Fund represented 10% or more of total investments.

9. Tax Status

The Plan adopted a Prototype Plan with an IRS determination letter dated June 30, 2020, which states the Prototype Plan was in compliance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrators believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Delinquent Participant Contributions

During the Plan year ended December 31, 2023, participant contributions totaling \$966 were not remitted to the Plan within the period prescribed by DOL regulations. These transactions constitute prohibited transactions as defined by ERISA. The related lost earnings were remitted to the Plan during the 2024 Plan year.

11. Subsequent Events

Subsequent events have been evaluated through July 29, 2025, which is the date the financial statements were available to be issued.
