## INDEPENDENT AUDITOR'S REPORT

To the Participants and Board of Trustees of:  
Oklahoma State Pipe Trades Annuity Fund

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Oklahoma State Pipe Trades Annuity Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Oklahoma State Pipe Trades Annuity Fund's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Oklahoma State Pipe Trades Annuity Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### ***Responsibilities of Management for the Financial Statements***

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

## **Note 1. Description of Plan**

The following description of the Oklahoma State Pipe Trades Annuity Fund (the Plan) provides only general information. Participants should refer to the Plan rules and regulations for a more complete description of the Plan's provisions.

**General** – The Plan is a multiemployer defined contribution profit sharing plan established January 1, 1982, pursuant to an agreement between Plumbers and Pipefitters Local 205 (the predecessor to Plumbers and Pipe Fitters Local Union 430) and the Associated Mechanical Contractors of Tulsa. The Plan is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Plan Administration** – The Plan is administered by a Board of Trustees, comprised of Union and Employer Trustees, each having equal voting rights. John Hancock Retirement Plan Services, LLC provides recordkeeping and custodial services.

**Eligibility** – An individual is eligible to participate in the Plan on the date of hire by an employer required to participate in the Plan pursuant to the terms of the collective bargaining agreement.

**Contributions** – The Plan is funded by contributions from participants and employers signatory to a collective bargaining agreement. Contributions are based on the numbers of hours worked at the applicable hourly contribution rate. The current hourly participant and employer contribution rates are between \$0.25 and \$3.55. Participants may contribute an additional amount on a voluntary basis. Participants may also contribute amounts (rollovers) representing distribution from other qualified plans, subject to applicable laws and regulations. Additionally, participants who are age 50 or older (or will attain age 50 before the end of the calendar year) may elect to defer additional amounts to the Plan, known as catch-up contributions. For 2024, the maximum catch-up contribution is \$7,500. This limit may be subject to increase in subsequent years based on cost-of-living adjustments.

**Reciprocal Contributions** – The Plan is signatory to reciprocity agreements with various other multiemployer annuity plans outside its territorial jurisdiction that are affiliated with the Plumbers and Pipefitters trade. Employees who are normally employed within the territory of one local union (home local) may be temporarily employed within the territory of another local union (reciprocating local). When an employee of the home local works in the territory of a reciprocating local, the latter is to make contributions to the former's fringe benefit funds on the employee's behalf. Contributions received by the Plan on behalf of persons from outside participating local unions are forwarded to their home local fringe benefit trust funds. The Plan uses the same recognition and measurement criteria for contributions received on behalf of its participants under the terms of reciprocity agreements, as for all other employer contribution revenue.

Amounts paid to other plans under the terms of reciprocity agreements are not reflected in the statements of changes in net assets available for benefits, as the amounts received are not revenue earned by the Plan, and the corresponding payments are not an expense of the Plan. The Plan recognizes a liability upon receiving reciprocal contributions on behalf of nonparticipants working within the jurisdiction of the local union, and recognizes a decrease in that liability upon remitting those contributions to the appropriate plan.

Employer contributions include reciprocal contributions of \$1,999,851 and \$1,319,434 for the years ended December 31, 2024 and 2023 respectively, from various other annuity plans under the terms of reciprocity agreements.

The Plan remitted a total of \$538,351 and \$208,714 in reciprocal contributions to various other annuity plans under the terms of reciprocity agreements for the years ended December 31, 2024 and 2023, respectively.

**Participant Accounts** – Each participant’s account is credited with the participant’s and employer’s contributions, and allocations of Plan net earnings depending on the investment options selected by the participant. Participant accounts are also charged with distributions and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions, as defined. Participants may direct the investment of employee and employer contributions to any of the Plan’s fund options. Participants may also redirect their contributions or exchange their existing account balances among the investment funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting** – Participants are immediately vested in their contributions, employer contributions, and rollover contributions, plus actual earnings thereon.

**Payment of Benefits** – A participant is entitled to receive, upon the earlier of normal retirement, attainment of age 55, disability, death or permanent withdrawal from the industry, the amount in their account as of the valuation date immediately preceding or coinciding with the event giving rise to the distribution, plus the amount of any contributions made on their behalf subsequent to the said valuation date. Normal retirement is on or after the attainment of age 62. Participants are also permitted to take hardship distributions in the event of immediate and heavy financial need in accordance with the Plan’s hardship withdrawal provisions. Hardship distributions cannot exceed the amount of the hardship. If a participant dies, the entire vested amount in the participant’s account is distributed to a designated beneficiary in the form of an annuity or lump sum payment.

### **Note 2. Summary of Significant Accounting Policies**

**Basis of Accounting** – The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United State of America (U.S. GAAP). Under this basis, revenue is recognized when earned and expenses when incurred.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** – Investments are reported at fair value, except for the pooled separate account, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s management determines the Plan’s valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**Participants’ and Employers’ Contributions Receivable** – The Plan derives a portion of its revenue from participants’ and employers’ contributions, which are recognized when earned. Participants’ and employers’ receivables represent contributions that relate to days worked on or before December 31, but not received by year end. Plan management believes that no provision for uncollectible accounts is necessary.

**Benefits** – Benefits are recorded upon distribution.

**Administrative Expenses** – The Plan’s expenses are paid by the Plan and are reflected in the statements of changes in net assets available for benefits as administrative expenses of the Plan.

### **Note 3. Information Prepared and Certified by Custodian**

The Board of Trustees has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the US Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Board of Trustees instructed the Plan’s independent auditor not to perform any auditing procedures with respect to the following information certified by the John Hancock Retirement Plan Services, LLC, except for comparing such information certified by the custodian to information included in the Plan’s financial statements and supplemental schedules.

The following information included in the accompanying financial statements and supplementary schedules was obtained from data that has been prepared and certified to as complete and accurate by the custodian.

### **Note 4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Interest Bearing Cash:* Valued at cost, which approximates fair value.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### **Note 5. Pooled Separate Account**

The Plan is invested in the Pooled Separate Account, a fully benefit-responsive investment contract issued by New York Life Insurance Company. This traditional investment contract meets the fully benefit-responsive investment contract criteria and therefore is reported a contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The crediting interest rate may not be reset more frequently than semi-annually, subject to minimum rate provisions. The contract value of the investment contract as of December 31, 2024 and 2023 was \$6,691,278 and \$6,332,860, respectively.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events may limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

### **Note 9. Risks and Uncertainties**

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

### **Note 10. Concentration of Contributions**

Six signatory employers each contributes more than five percent of total contributions. The withdrawal of one or more of these employers may impact the funding of the Plan.

### **Note 11. Plan Termination**

Although the Trustees have not expressed any intention to do so, in the event of termination of the Plan, the interest of each participant in his or her account after payment of expenses and appropriate adjustment of the accounts of all participants for expenses, charges, and gains and losses shall be nonforfeitable as of the termination date. Upon the receipt by the Trustees of the Internal Revenue Service approval of such termination, the full current value of such amount may be paid.

### **Note 12. Tax Status**

The IRS has determined and informed the Plan by a letter dated January 22, 2016, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require management of an organization to evaluate tax positions taken and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has evaluated the tax positions taken and concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

### **Note 13. Related Party and Party-in-Interest Transactions**

Plan investments are managed by John Hancock Retirement Plan Services, LLC, the custodian for the Plan; therefore, transactions involving these investments qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

The Plan shares office supplies, equipment and staff with Plumbers and Pipefitters Local Union 430 (Local 430). Shared operating and administrative expenses are paid initially by the Local 430 and later reimbursed by the Plan on a timely basis. For the years ended December 31, 2024 and 2023, the Plan reimbursed Local 430 \$122,157 and \$77,827 respectively. Amounts due to or from related organizations represent operating expenses owed at year end. As of December 31, 2024 and 2023, the Plan owed Local 430 \$11,199 and \$6,356, respectively.

The Plan leases office space from Local 430 on a month-to-month basis. Terms of the lease require monthly payments of \$198. Lease payments received for the years ended December 31, 2024 and 2023 were \$2,376 and \$2,376, respectively.

### **Note 14. Subsequent Events**

Plan management has evaluated events and transactions that occurred after December 31, 2024, for potential recognition or disclosure in the financial statements. These events and transactions were evaluated through July 28, 2025, the date that the financial statements were available to be issued, and no items have come to the attention of management that require recognition or disclosure.
