## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and participants  
The Haynes Retirement Plan  
Fairfax, Virginia

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Haynes Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### Basis for Opinion

## NOTES TO FINANCIAL STATEMENTS - DECEMBER 31, 2024 AND 2023

---

### NOTE 1 - DESCRIPTION OF PLAN

---

The Haynes Retirement Plan (the Plan) is a defined contribution plan sponsored by Haynes Inc. (the Company). The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan that covers substantially all employees of the Company who have reached twenty one years of age, excluding leased employees and employees covered by a collective bargaining agreement. Employees are automatically enrolled in the Plan on the 1st of the month following the attainment of these requirements unless the employee elects to waive participation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Contributions**

The Plan provides for voluntary pre-tax employee contributions up to 60% of eligible compensation. For the years ended December 31, 2024 and 2023, the employer matching contribution was 25% of a participant's deferral contributions.

During 2023, the Plan Sponsor made an additional employer contribution of \$51,647 to reinstate improperly forfeited participant accounts due to the partial plan termination.

In addition, the Company's Board of Directors may authorize discretionary profit sharing contributions to employees who have completed a minimum of 1,000 hours of service during the plan year and are employed on the last day of the plan year. Employees are eligible to share in the allocation of profit sharing contributions even if they do not satisfy the annual service allocation requirement, if they died, or became disabled. The Company did not make a profit sharing contribution for 2024 or 2023. Contributions from Plan participants and the related matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's contribution and earnings thereon, and charged with the withdrawals, losses, and an allocation of Plan expenses. Depending on the nature of the expense, Plan expenses are allocated either proportionally based on the value of participant account balances, or as an equal dollar amount based on the number of participants in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All amounts in participant accounts are participant directed.

#### **Investment Options**

Participants may direct employee and employer contributions in any of several investment options. By designating these investment alternatives for participants, allowing frequent fund transfers, and providing the necessary fund information to participants, it is intended that the Plan be treated as an ERISA 404(c) Participant Directed Account Arrangement.

The Plan currently offers various mutual funds and a common/collective trust as investment options for participants. The mutual funds invest in common stocks of domestic and foreign corporations, corporate bonds, and money market funds, which cover a wide range of fund objectives, risks, and returns.

## ***Plan Expenses***

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Loan and withdrawal administrative fees are charged directly to the participant's account. Investment-related expenses are included in net appreciation in fair value of investments in the accompanying Statements of Changes in Net Assets Available for Benefits.

## ***Vesting***

Participants are immediately fully vested in their contributions, plus actual earnings thereon. Participants become fully vested in the Company portion of their account balances based on the Plan's vesting schedule. A year of vesting service is determined using the elapsed time method.

Company matching and profit sharing contributions are vested on a six-year schedule as follows:

## ***Payment of Benefits***

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of his or her account's vested balance, an annuity, to postpone distribution until required by Internal Revenue Code rules, or elect to rollover all of the balance into an Individual Retirement Account (IRA). If a participant's vested account balance exceeds \$5,000, the participant must consent to the distribution before it is made. If a mandatory distribution is being made to a participant whose vested account balance does not exceed \$5,000 but the amount of the distribution exceeds \$1,000, then the distribution is required to be in the form of an automatic rollover into an IRA. If the participant's balance is below \$1,000, then the balance will be paid in a lump sum distribution directly to the participant. In-service distributions are allowed under certain circumstances as described in the Plan agreement. Effective October 18, 2024, the dollar amount of the automatic distributions was increased to \$7,000.

## ***Notes Receivable from Participants***

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate (as determined by Fidelity's Loan Interest Rate Update Service) at the onset of the participant's loan, plus 4%. Once the participant loan rate is established, the rate of interest will be fixed for the life of the loan. Principal and interest is paid ratably through payroll deductions.

## ***Forfeited Accounts***

Forfeitures are used to reduce employer contributions and pay for Plan expenses. Forfeitures used in 2024 and 2023 were \$10,856 and \$53,976, respectively. There were outstanding forfeitures of \$599 and \$322 as of December 31, 2024 and 2023, respectively.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

---

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

Investments held by a defined contribution plan are required to be reported at fair value, except for a fully benefit-responsive investment contract. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

***Investment Valuation and Income Recognition***

Investments are reported at their fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 4 for discussion of fair value measurements.

Realized gains (losses) and unrealized appreciation (depreciation) are recorded in the accompanying financial statements as net appreciation (depreciation) in fair value of investments. Realized gains (losses) on investment transactions are recorded as the difference between proceeds received and the carrying value of the investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan payments and the Plan administrator considers the participant loan to be in default, the delinquent participant note receivable is recorded on the Form 5500 as a benefit payment based on the terms of the Plan document.

***Payment of Benefits***

Benefits are recorded when paid.

**NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE (UNAUDITED)**

---

The Plan administrator has elected the method of annual reporting compliance allowed by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Plan management instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Fidelity Management Trust Company (FMTC), the trustee of the Plan, as complete and accurate, except for comparing such information certified by the trustee with information included in the Plan's financial statements and supplemental schedule:

- a) Investments as disclosed in the Statements of Net Assets Available for Benefits.
- b) Interest and dividend income and the net appreciation (depreciation) in the fair value of investments as disclosed in the Statements of Changes in Net Assets Available for Benefits.
- c) The Schedule of Assets (Held at End of Year).

The Plan's independent auditors performed limited auditing procedures with respect to this information, including comparing such information to the related information included in the financial statements and supplemental schedule.

---

**NOTE 4 - FAIR VALUE MEASUREMENTS**

---

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses the appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs were used only when Level 1 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for 2024 and 2023.

*Level 1 Fair Value Measurements*

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

There were no significant transfers between Level 1 and Level 2 investments during the year ended December 31, 2024.

Gains and losses included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation (depreciation) in fair value of investments.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their account balances.

---

**NOTE 6 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan participates in a common/collective trust investment contract with FMTC. FMTC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The common/collective trust investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The investment contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value.

There are no reserves against the net asset value for credit risk of the contract issuer or otherwise. The net asset value of the investment contract at December 31, 2024 and 2023 was \$72,507 and \$77,034, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan’s ability to transact at contract value with FMTC. Such events include the following: (a) the Plan’s failure to qualify under Section 401(a) or Section 401(k) of the Internal Revenue Code, (b) the establishment of a defined contribution plan that competes with the Plan for employee contributions, (c) any substantive modification of the portfolio or the administration of the portfolio that is not consented to by the wrap issuer, (d) any change in law, regulation or administrative ruling applicable to the Plan that could have a material adverse effect on the portfolio’s cash flow, (e) any communication given to participants by the plan sponsor, any other plan fiduciary, or FMTC that is designed to induce or influence participants not to invest in the portfolio or to transfer assets out of the portfolio, or (f) any transfer of assets from the portfolio directly to a competing investment option. The Plan administrator does not believe that any of the events that would limit the Plan’s ability to transact at contract value with Plan participants are probable of occurring.

---

**NOTE 7 - TAX STATUS**

---

The Plan, which is a non-standardized pre-approved profit sharing plan with CODA, obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan administrator believes that the Plan is qualified and tax-exempt at the financial statement date.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

---

**NOTE 8 - CARES ACT PROVISIONS**

---

The Plan adopted the CARES Act provisions, including allowing eligible participants to request a distribution up to \$100,000 for qualifying coronavirus-related reasons. The Plan was formally amended during 2023.

---

**NOTE 9 - SECURE ACT 2.0**

---

SECURE Act 2.0 includes provisions that are both mandatory and voluntary. The Plan adopted certain provisions of the SECURE Act 2.0 including increasing the dollar limit for mandatory distributions from \$5,000 to \$7,000. The Plan has until 2026 to formally amend the Plan with these provisions.

---

**NOTE 10 - PARTY-IN-INTEREST TRANSACTIONS**

---

Certain Plan investments are shares of mutual funds managed by FMTC. FMTC is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Additionally, the Plan uses Fidelity Workplace Solutions, LLC, a related party of the Plan's trustee, for recordkeeping services.
