Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Blackhawk Bank & Trust Employees' Profit Sharing and 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Blackhawk Bank & Trust Employees' Profit Sharing and 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years December 31, 2024 and 2023, stating that the certified investment information, as described in Notes 2 and 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with U.S. generally accepted auditing standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Blackhawk Bank & Trust Employees' Profit Sharing and 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with U.S. generally accepted accounting principles and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Blackhawk Bank & Trust Employees' Profit Sharing and 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. (1) Plan Description and Summary of Significant Accounting Policies

(a) Description of Plan

The following description of the Blackhawk Bank & Trust (the "Bank") Employees' Profit Sharing and 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established January 1, 1966 (amended and restated July 15, 2022) covering all employees of Blackhawk Bank & Trust with 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA). Principal Trust Company is the investment custodian and recordkeeper for the Plan. The Board of Directors oversees governance of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Participants may contribute a percentage of annual compensation (as defined in the Plan document) in the form of a pre-tax and/or after-tax salary reduction. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (referred to as rollover contributions). Employees are automatically enrolled in the employer contribution portion of the Plan on the first day of the Plan year, after having satisfied the eligibility requirements. Contributions related to auto-enrollment are automatically invested in a designated balanced fund until changed by the participant. Participants may change or suspend the contribution rate throughout the year. There are no employer matching contributions. Contributions are subject to certain IRS statutory annual limitations.

The Bank contributes 7.5% of its pre-tax income after stipulated adjustments as defined in the Plan document. The Plan provides for additional, or reduced, employer contributions (subject to federal limitations) at the discretion of the Bank.

Employer profit sharing contributions and employee contributions are invested in one or more investment fund options offered by the Plan as directed by the individual participant.

Participant Accounts

Each participant's account is credited with the participant's contributions, if any, an allocation of (a) the Bank's profit sharing contribution, and (b) Plan earnings (losses) and charged with the participant's withdrawals and allocations of administrative expenses paid by the Plan. Allocations of employer contributions and forfeitures of terminated participant's nonvested accounts are based on participant years of service and compensation, as defined in the Plan. Investment earnings are allocated to participant's accounts based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeitures of nonvested participant accounts are reallocated to remaining participants accounts. Forfeitures included in net assets available for benefits as of December 31, 2024 and 2023 amounted to \$142,594 and \$123,797, respectively.

(a) Description of Plan, continued

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Bank's contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant is 100 percent vested after six years of credited service. A participant becomes 20% vested after two years of service and increases at 20% per year thereafter.

Payment of Benefits and Participant Loans

A participant may elect to receive a distribution from his or her account upon retirement, termination of employment, total and permanent disability or death of the participant, whichever occurs earlier. Distributions of the participant's vested accumulated funds in his or her account are paid to the participant (or the participant's beneficiary in the event of death) in a lump sum or at a later date selected by the participant.

Participant loans are not permitted.

(b) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

The Plan evaluated subsequent events through July 29, 2025, which is the date the financial statements were available to be issued.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are held and administered by Principal Trust Company, a member of Principal Financial Group, (Custodian) who allocates Plan assets to the individual accounts of each participant as directed by the participant.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract (Principal Guaranteed Option) which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in a transaction between market participants at the measurement date. Contract value represents contributions made under the contract plus earnings at the contract rate of 3.03% in 2024 and 2023, less participant withdrawals and administrative expenses. The Plan sponsor and Plan administrator determined the Plan's valuation policies. See note 3 for discussion of fair value measurements.

Investment Valuation and Income Recognition, continued

Purchases and sales of securities are recorded on a trade–date basis. Interest is recorded on the accrual basis and dividends are recorded on the ex–dividend date. Net appreciation (depreciation) in the fair value of investments includes realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits

Benefit payments to participants are recorded when paid.

Contribution Recognition

The Plan recognizes employee contributions based on the period the employee contribution is withheld by the Bank from the employee’s compensation.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The excess participant contributions were distributed by the Plan to applicable participants subsequent to year–end.

Administrative Expenses

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan’s sponsor and therefore, are not included in the accompanying statement of changes in net assets available for benefits. Plan administration expenses related to member requested services are deducted directly from the participant’s account balance.

(2) Certified Investments, continued

The Principal Guaranteed Option is a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal) who maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1.05% for the years ended December 31, 2024 and 2023. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Principal. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. However, the Plan sponsor has the option to terminate the contract.

On November 3, 2023, the Plan sponsor terminated the Principal Guaranteed Option contract and elected to have the Plan's value of the contract paid out in six annual installment payments starting in April 2024. The proceeds from the liquidation of the contract will be reinvested in other investment options offered by the Plan as determined by the individual participant.

(3) Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of quoted prices in active markets of similar assets for assets in non-active markets and Level 3 inputs which consist of other valuation techniques that have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

There were no Plan investments requiring the use of Level 3 inputs in 2024 and 2023 and there were no changes in the methods used to measure fair value or transfers between Levels in 2024 and 2023.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end. These mutual funds are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The mutual funds must publish their daily net asset value and transact at that price; and therefore, they are considered actively traded.

Level 2 Fair Value Measurements

The underlying assets of the pooled separate accounts and the common investment trusts consist of publicly traded open-end mutual funds registered with the U.S. Securities and Exchange Commission. The net asset value of these mutual funds is determined daily and transacted at that price. Thus, the fair value of substantially all mutual fund investments within the pooled separate accounts and common investment trusts is based on the quoted market prices of the investments.

(4) Federal Income Taxes

The Plan uses a prototype plan document sponsored by Principal Life Insurance Company. Principal Life Insurance Company received a determination letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the prototype document, as designed, is in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

The Plan evaluates the tax benefits of a tax position using the "more likely than not" threshold. As of December 31, 2024, management is not aware of any uncertain tax positions and related tax benefits which would be material to the Plan's financial statements. The Plan files annual information returns which for years subsequent to 2020 are subject to examination by taxing authorities

(5) Related Party and Party-in-Interest Transactions

The Plan's investments include investments managed by Principal Life Insurance Company, a member of Principal Financial Group. Principal Life Insurance Company is the Contract Administrator as defined by the Plan, and therefore, transactions with them qualify as party-in-interest transactions.

Fees paid to Principal Life Insurance Company amounted to \$86,264 and \$74,056 for the years ended December 31, 2024 and 2023, respectively.

(6) Administrative Expenses

Plan administrative expenses related to member requested services, withdrawal charges and personal retirement accounts are charged to participant accounts. Participant investment fees are a percentage of the individual participant account balance which are deducted from participant accounts.

(7) Plan Termination

Although it has not expressed any intent to do so, the Bank has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(9) Self-Correction Program

The Plan sponsor reviews the years of service calculation used to determine the employer profit share contribution each year. During the 2024 review, the Plan sponsor determined the years of service calculation for three employees was incorrect. The Plan administrator notified each participant of the error and made the corrective contributions, including lost earnings, during 2024.

(10) Recent Developments

On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system and finding ways for them to accumulate more assets. These changes have various effective dates starting in 2023 and forward. The Plan Sponsor is working with Principal to determine that the Plan document is updated to comply with the provisions of SECURE 2.0 Act.

(11) Economic Impacts

National and worldwide factors have led to significant volatility in the financial markets and have affected, and may continue to affect, the value of the Plan's investments. The potential future economic impact of these conditions is difficult to assess or predict. The Plan sponsor is not able to estimate the full impact of these conditions on the Plan's financial statements.
