Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the C. Basil Ford 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of November 21, 2024 and December 31, 2023, and the related statements of changes in net assets available for benefits for the period ended November 21, 2024 and for the year ended December 31, 2023, respectively, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of November 21, 2024 and December 31, 2023, and for the period ended November 21, 2024 and for the year ended December 31, 2023, respectively, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Notes to Financial Statements

1. Description of the Plan

The following description of the C. Basil Ford 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan sponsored by C. Basil Ford, Inc. (the “Plan Sponsor” or “Plan Administrator”). Employees must be at least 21 years of age and complete one year of service with a minimum of 1,000 hours in order to become a participant in the Plan and begin making elective deferrals and receiving Plan Sponsor contributions.

The Plan was established effective January 1, 1992 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was amended and restated effective January 1, 2021 in order to comply with the requirements for Cycle 3 Pre-Approved Plans, pursuant to Rev. Proc. 2017-41.

Effective January 1, 2024, the Plan Sponsor elected to become a participating employer in a separate defined contribution 401(k) plan, Basil Family Dealerships 401(k) Plan (the “Family 401(k) Plan”). Contributions to the Plan continued until November 21, 2024. Plan assets totaling \$13,305,221, consisting of investments in the amount of \$12,967,125, and notes receivable from participants in the amount of \$338,096, transferred to the Family 401(k) Plan on November 21, 2024. The Plan’s merger with the Family 401(k) Plan became effective November 22, 2024. Each participant in the Plan shall be entitled to receive future benefits from the Family 401(k) Plan.

Contributions – Participants may elect to contribute between 1% and 100% of their annual compensation as a pre-tax or Roth contribution, limited by the amount imposed by law. Additionally, participants age 50 or older may elect to make catch-up contributions limited to the amount imposed by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (i.e., rollovers).

Under the Plan, the Plan Sponsor makes matching contributions equal to 25% of salary deferrals each pay period. However, salary deferrals greater than 4% of Plan compensation are not eligible for a matching contribution. In addition, the total matching contribution for any participant is limited to 1% of Plan compensation. The Family 401(k) Plan permits matching contributions equal to 50% of the first 2% of salary deferrals and 25% of the next 4% of salary deferrals. The Plan Sponsor implemented the Family 401(k) Plan’s matching contributions for Plan participants’ salary deferrals for pay periods effective July 1, 2024 through November 21, 2024, and also made retroactive matching contributions for salary deferrals for the period January 1, 2024 through June 30, 2024. See Subsequent Events in Note 2.

The Plan also allowed the Plan Sponsor to make additional discretionary contributions to the Plan. In order to receive Plan Sponsor discretionary contributions, participants must be actively employed by the Plan Sponsor on the last day of the Plan year and work 1,000 hours during the Plan year. Any discretionary contribution will be divided among eligible participants based on certain designated groups under the Plan. There were no additional discretionary contributions made by the Plan Sponsor for the period ended November 21, 2024 and for the year ended December 31, 2023.

Participant Accounts – Individual accounts are participant-directed and are maintained for each Plan participant. Participant accounts are increased by participant contributions, Plan Sponsor contributions, and the participant's share of Plan earnings. Participant accounts are decreased by participant distributions and the participant's share of Plan expenses and losses. The allocation of earnings and losses to participant accounts is based on the value of an individual account in relation to the total assets of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their salary deferral and rollover contributions and actual earnings thereon. Participants vest in Plan Sponsor matching contributions and Plan Sponsor discretionary contributions at the rate of 20% each year of service in which they work at least 1,000 hours, and become fully vested after five years. A participant also becomes fully vested upon reaching the normal retirement age of 65 or upon Plan termination.

Payment of Benefits – Upon termination of service due to retirement, death, disability, or as required by law, a participant may elect to receive a lump-sum distribution in an amount equal to the vested value of their account. The Plan permits in-service distributions for participants age 59½ and older and for financial hardships, as defined in the Plan document.

Forfeitures – The non-vested account balances of participants who have ceased employment with the Plan Sponsor are forfeited upon the distribution of vested balances. The Plan Sponsor may use forfeitures to pay administrative expenses or to reduce amounts otherwise required to be contributed to the Plan. There was \$564 of forfeitures used to offset Plan Sponsor contributions or to pay plan expenses in 2024. There were no forfeitures used to offset Plan Sponsor contributions or to pay plan expenses in 2023. The balance in the forfeiture account totaled \$0 and \$12,002 at November 21, 2024 and December 31, 2023, respectively.

Notes Receivable from Participants – In accordance with Plan provisions, participants are permitted to borrow a minimum of \$1,000 up to a maximum of 50% of their vested account balance. In addition, the total amount a participant may have outstanding as a loan during any 12-month period may not exceed \$50,000. The loans are secured by the balance

in the participant's account and bear a reasonable rate of interest. Participants may only have one loan outstanding at any time. Loans are repayable over a period of up to five years, or longer if used for the purchase of a primary residence. Notes receivable from participants in the accompanying statements of net assets available for benefits are measured at their unpaid principal balances plus accrued but unpaid interest, if any.

Income Taxes – Effective January 1, 2021, the Plan delegated authority to PPS Pension & Financial Services, Inc. ("PPS") to adopt the PPS Nonstandardized Profit Sharing/401(k) Plan #01-002. The Plan relies on an opinion letter issued by the Internal Revenue Service ("IRS") dated June 7, 2021 as evidence that the Plan is qualified under Section 401 of the Internal Revenue Code (the "Code"). Accordingly, no provision for income taxes has been included in the accompanying financial statements.

Accounting principles generally accepted in the United States of America ("U.S. GAAP") require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management is not aware of any uncertain tax positions that would cause the Plan to lose its tax status or to otherwise be subject to other taxes or penalties.

Plan Termination – As stated above, effective November 22, 2024, the Plan merged with the Family 401(k) Plan. Each participant in the Plan shall be entitled to receive future benefits from the Family 401(k) Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting – The accompanying financial statements are prepared under the accrual method of accounting in accordance with U.S. GAAP.

Valuation of Investments – The Plan's investments in mutual funds and pooled separate accounts are stated at fair value, as determined by Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC (collectively, "Empower" or the "Trustee") as of November 21, 2024 and December 31, 2023. Life insurance contracts are reported at cash surrender value, which approximates fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan's investment in a guaranteed interest account is reported at contract value. Interest is credited on contract balances using a single-interest crediting rate applied to all contributions made regardless of the timing of the contributions. Interest-crediting rates are reviewed on a semi-annual basis for resetting.

2. Summary of Significant Accounting Policies (continued)

The Plan presents in the accompanying statements of changes in net assets available for benefits the net appreciation in the fair value of its investments which includes both realized gains and losses and unrealized appreciation or depreciation in the fair value of investments. Realized gains and losses on disposition of investments are based upon actual costs and selling prices.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Benefit Payments – Benefits are recorded when paid.

Administrative Expenses – Certain accounting and administrative expenses of the Plan are paid by the Plan Sponsor. Expenses relating to investment activity are paid by the Plan.

Party-in-Interest Transactions – Plan investments in mutual funds, pooled separate accounts, the guaranteed interest account, and life insurance contracts are managed by Empower. Transactions with Empower qualify as party-in-interest transactions. Fees paid collectively to Empower for services amounted to \$45,799 and \$40,399 for the period ended November 21, 2024 and for the year ended December 31, 2023, respectively.

Risks and Uncertainties – Investments are exposed to various risks, such as interest rate and market risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amount reported in the accompanying financial statements.

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Subsequent Events – The Plan Sponsor has evaluated subsequent events, for recognition and disclosure through July 24, 2025, the date the accompanying financial statements were available to be issued, and determined that no additional recognition or disclosure was necessary.

In July 2025, the Plan Sponsor identified an error with the retroactive matching contributions for salary deferrals for the period January 1, 2024 through June 30, 2024. Additional matching contributions of approximately \$17,000 were credited to the applicable Plan participants' accounts within the Family 401(k) Plan.

4. Fair Value Measurements

The framework below provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure the fair value of the Plan’s assets. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

- **Level 1** – Unadjusted quoted prices in active markets for identical, unrestricted assets or liabilities that are accessible at the measurement date.

- **Level 2** – Quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets or liabilities in markets that are not active. This level also includes inputs other than quoted prices that are observable, either directly or indirectly, for substantially the full term through corroboration with observable, independent market data. This includes investments valued at quoted prices adjusted for legal or contractual restrictions specific to the security.
- **Level 3** – Pricing inputs are unobservable for the asset or liability. That is, inputs that reflect the reporting entity’s own assumptions about the assumptions that market participants would use in pricing the asset or liability. There were no assets held by the Plan as of November 21, 2024 and December 31, 2023 that utilized Level 3 inputs as its primary measure of fair value.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual Funds – Shares of mutual funds are valued at quoted market prices of shares held by the Plan at year-end.

Pooled Separate Accounts – Pooled separate accounts invest in a variety of separate investments and mutual funds and are valued daily based on the market value of the underlying assets.

Life Insurance Contracts – Life insurance contracts are valued at cash surrender value, which approximates fair value. There were no life insurance policies surrendered during the period ended November 21, 2024 and the year ended December 31, 2023.

5. Investment Contract with Insurance Company

The Plan has a fully benefit-responsive group annuity insurance contract with Empower. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the accompanying financial statements at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value. Such events include the following: (a) removal of a group of participants from Plan coverage as a result of temporary absence, (b) change in position or other occurrence qualifying as a temporary break in service under the Plan, (c) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer, (d) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan Sponsor's business, (e) removal from the Plan of one or more groups or classifications of participants, (f) partial or complete Plan termination, or (g) Plan disqualification.
