Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Applied Control Engineering, Inc. 401(k) Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The supplemental schedule as of December 31, 2024 is presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE A – DESCRIPTION OF PLAN

The following description of the Applied Control Engineering, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a participant-directed, defined contribution plan established by Applied Control Engineering, Inc. (the Plan Sponsor), effective June 1, 1997. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended. The general administration of the Plan and the responsibility for carrying out the provisions of the Plan are maintained by the plan administrator appointed by the Plan Sponsor. In accordance with the provisions of the Plan, Reliance Trust Company was acting as the Trustee and T. Rowe Price is the third-party plan administrator. The third-party plan administrator maintains participant account records and executes transactions such as benefit payments to participants. The Trustee holds the assets of the Plan and executes transactions at the direction of the plan administrator. The Trustee also reports to the Plan's management regarding investments and changes in these investments.

2. Eligibility

An employee becomes eligible as a contributing participant in the Plan after attaining age 21 and completing three months of service with Applied Control Engineering, Inc., at which time the employee may enter the Plan on the next quarterly date. Employees are eligible for the discretionary employer match and profit sharing after attaining age 21 and completing one year of service.

3. Employee Contributions

Each year participants may contribute up to the maximum amount allowed by law, as defined in the Plan, which was \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023 respectively. Plan participants over age 50 may defer an additional \$7,500 in catch-up contributions for both of the years ended December 31, 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

## NOTE A – DESCRIPTION OF PLAN (CONTINUED)

### 4. Employer Contributions

Pursuant to the terms of the Plan, the Plan Sponsor may make matching contributions equal to a discretionary percentage, to be determined by the Plan Sponsor. The Plan Sponsor, at its discretion, may also make an annual contribution as determined by management, which will be allocated to each participant in the ratio that the participant's compensation bears to the compensation of all participants. The Plan Sponsor may elect to forego the matching and / or the discretionary contribution in any year. On May 1, 2018, the Sponsor raised the match to 50% of the first 8% contribution up to a maximum of 4%. The match totaled \$553,259 and \$488,767 for the years ended December 31, 2024 and 2023, respectively. In 2024 and 2023, employer contributions were reduced by \$493 and \$20,181 from forfeited non-vested accounts, respectively.

### 5. Participants' Accounts

Each participant's account is credited with the participant's contribution and allocations of the Plan Sponsor's contributions, allocations of investment income or loss and forfeitures of terminated participants' non-vested accounts, and charged with an allocation of administrative expenses. Allocations are based on the participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan. Currently, the Plan offers one money market account and 33 pooled separate accounts as investment options for participants.

### 6. Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings or losses thereon. Vesting in the Plan Sponsor's matching contributions plus actual earnings or losses thereon is based upon years of continuous service. A participant is 20% vested after two years of credited service and 20% per year thereafter and, thus, is 100% vested after six years of service, as defined. Participants become fully vested upon death or total and permanent disability. Forfeitures are allocated to participant accounts in the same manner as employer contributions.

### 7. Payment of Benefits

Upon reaching normal retirement age or upon permanent disability, all vested amounts credited to a participant's account become distributable. Distributions will be made as soon as administratively feasible, following a participant's request. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan.

Upon a participant's death, the participant's beneficiary is entitled to 100% of the participant's vested account balances.

## NOTE A – DESCRIPTION OF PLAN (CONTINUED)

### 7. Payment of Benefits (Continued)

Upon termination of service, other than for normal retirement or death, the administrator will direct the current Trustee to pay to the participant his or her benefit in an immediate lump sum, if certain criteria are met.

### 8. Forfeited Accounts

Upon a participant's termination date, and prior to the time the participant becomes vested in his or her account, the non-vested portion, if any, shall be forfeited. These forfeitures will first be used to pay plan expenses. Any forfeiture left after paying plan expenses is used to reduce the Plan Sponsor's contributions. In 2024 and 2023, employer contributions were reduced by \$493 and \$20,181 from forfeited non-vested accounts, respectively. Forfeited amounts for the years ended December 31, 2024 and 2023, totaled \$3,267 and \$16,379, respectively.

### 9. Administrative Expenses

All administrative expenses are paid directly through the Plan and are allocated to the participants. Professional fees were paid by the Plan Sponsor.

### 10. Notes Receivable from Participants

Under the terms of the Plan, participants may obtain loans from the Plan, utilizing funds accumulated in their accounts. The minimum amount which may be borrowed is \$1,000. Participants may have only two loans outstanding at any time. The loan interest rates ranged from 4.25% to 9.5% for the years ended December 31, 2024 and 2023. Outstanding loans to participants at December 31, 2024 and 2023, were \$57,006 and \$64,368, respectively.

The loans are repaid to the Plan through after-tax payroll deductions. The loan repayments and interest earned are allocated to each of the investment funds based upon the participant's contribution election percentages. The terms of the loan are by mutual agreement between the Plan Sponsor and the participant.

### 11. Plan Termination

Although there has been no expressed intent to do so, the Plan Sponsor has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

## NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### 1. Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with generally accepted accounting principles in the United States of America.

### 2. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expense during the reporting period. Actual results could differ from those estimates.

### 3. Risk and Uncertainties

The assets of the Plan are primarily financial instruments which are monetary in nature. As a result, interest rates have a more significant impact on the Plan's performance than do the effects of general levels of inflation. Interest rates do not necessarily move in the same direction or in the same magnitude as the prices of goods and services as measured by the consumer price index. Investments in funds are subject to risk conditions of the individual fund objectives, stock and bond market fluctuations, interest rate changes, economic conditions and world affairs.

Due to the level of risk associated with these investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect the participants' account balances and amounts reported in the statement of net assets available for plan benefits.

### 4. Payment of Benefits

Benefit payments are recorded when paid.

### 5. Investment Valuation and Income Recognition

The Plan investments in the pooled separate accounts are stated at fair value and represent the number of participation units owned by the Plan. Quoted market prices of the underlying investments are used to value each fund and are based on the net asset value of the shares held by the Plan at the end of the year.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

5. Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Participant loans are stated at cost, which approximates fair value.

6. Tax-Exempt Status

The Plan Sponsor adopted a non-standardized prototype plan provided by the Trustee, who received an Internal Revenue Service (IRS) opinion letter which stated that the Plan, as designed, is in compliance with the applicable section of the *Internal Revenue Service Code* (the Code).

The Plan obtained its latest determination letter on June 1, 2015, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

In accordance with ASC 740-10, *Income Taxes*, the plan administrator has reviewed its current and past federal income tax positions and has determined, based on clear and unambiguous tax law and regulations, that the tax positions taken are certain and that there is no likelihood that a material tax assessment would be made if a respective government agency examined tax returns subject to audit. Therefore, no provision for income tax has been included in the Plan's financial statements.

Currently, the 2021, 2022 and 2023 tax years are open and subject to examination by the IRS. However, the Plan is not currently under audit nor has the Plan been contacted by this jurisdiction. Interest and penalties related to income taxes are included in income tax expense when incurred.

7. Subsequent Events

The Plan evaluated subsequent events through July 29, 2025, the date the financial statements were available to be issued.

## NOTE C – INFORMATION CERTIFIED BY THE PLAN TRUSTEES

At December 31, 2024 and 2023, the assets of the Plan were allocated among various investment options. The investment funds are administered by independent managers. The plan administrator has elected the method of annual reporting compliance permitted by CFR 2520.103-8 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under ERISA. Accordingly, the custodian has certified the following information was complete and accurate as of December 31:

## NOTE D – PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are units of pooled separate accounts managed by T. Rowe Price. T. Rowe Price is the third party administrator of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Participant loans also qualify as party-in-interest transactions.

## NOTE E – COMMITMENTS AND CONTINGENCIES

In the normal course of business, there are various commitments and contingencies outstanding which are not reflected in these financial statements. In the opinion of the plan administrator, the outcome of such events, if any, would not have a material effect on the Plan's financial position or operations.

## NOTE F – FAIR VALUE MEASUREMENTS

The Plan follows Statement ASC 820, *Fair Value Measurements and Disclosures*, which defines fair value under generally accepted accounting principles in the United States of America, establishes a framework for measuring fair value and enhances disclosures about fair value measurements. This standard defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy, which requires an entity to maximize the use of observable inputs when measuring fair value.

The following provides a description of the three levels of inputs that may be used to measure fair value under the standard, the types of Plan investments that may fall under each category, and the valuation methodologies used to measure these investments at fair value.

NOTE F – FAIR VALUE MEASUREMENTS (CONTINUED)

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date.

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies.

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

The Plan determines the fair value of its assets using unadjusted quoted prices in active markets (Level 1) or pricing inputs that are observable (Level 2) whenever that information is available. The Plan uses unobservable inputs (Level 3) to estimate fair value only when relevant observable inputs are not available.

The Plan classifies assets within the fair value hierarchy based on the lowest level of input that is significant to the fair value measurement of each individual asset taken as a whole. The Plan determines fair value for assets classified as Level 1 by multiplying the market price by the quantity of the asset. The Plan primarily determines fair value measurements classified as Level 2 or Level 3 using the income valuation approach, which involves discounting estimated cash flows using assumptions that market participants would use in pricing the asset.
