NOTE 1 DESCRIPTION OF PLAN

The following description of the Cultivate Solutions 401(k) Plan & Trust provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Cultivate Solutions 401(k) Plan & Trust includes the following companies for the Plan year ending December 31, 2024: Apple Core Enterprises, Inc., AppleBis, Inc., AppleWest, Inc., Grandapple, Inc., AppleFar, Inc., Apple City, Inc., Apple Union, Inc., Capitol Apple, Inc., Apple Yuma II, Inc., Apple Palm, Inc., Apple Msota, Inc., Applexico, Inc., Apple Jtown, Inc., AppleCentro, Inc., Apple Bmont, Inc., AppleValley, Inc., AppleFar South, Inc., Apple Yuma Foothills, Inc., Apple Dome, Inc., Apple Quinta, Inc., Apple Lake, Inc., Food Management Investors, Inc. dba Cultivate Solutions, LLC, Dakota Kid, LLC, Little Deep Pasta Company, LLC, Prairie Grit Adaptive Sports, The Starving Rooster, Smorbrod, LLC, Whiskey 9 LLC, and JL Beers, collectively the "Company".

The Plan Sponsor has elected for this plan to be considered a multiple employer plan (MEP).

The Plan is a defined contribution plan covering all employees of the above companies who have one year of service in which they worked 1,000 hours and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by a committee appointed by the Company. A third party administrator performs general plan administration services. A separate party serves as the provider of the Plan, maintains the records of the participant data and holds the Plan assets.

Contributions

Each participant in the Plan may withhold up to 100% of their compensation. However, the maximum deferral amount may not exceed IRS limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to allocate contributions between pre-tax and Roth deferrals.

The Plan is a traditional safe harbor plan, in which the Employer matches 100% of salary deferrals up to the first 3% of plan year compensation, plus 50% of salary deferrals up to the next 2% of plan year compensation. In addition, the Employer may still contribute an additional amount at its own discretion.

Participants may make rollover contributions for amounts representing distributions from other qualified defined benefit plans, defined contribution plans, or individual retirement accounts.

Participant Accounts

Each participant's account is credited with the participant's contributions, the employer's matching contributions and profit sharing contributions, if any. Plan earnings are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan allows for participant-directed investment programs for which separate funds are maintained. The value of each participant's account is determined daily.

Participants' Investment Options

Participants must direct their salary deferral contributions, the employer's matching contributions and profit sharing contributions, if any, to selected investments as offered by the Plan. Participants may change their investment options throughout the year by contacting the Plan's investment advisor or the Plan Sponsor, or through their online account with John Hancock.

Payment of Benefits

Upon termination of service, death, termination of employment due to disability, or retirement, a participant may elect to receive a lump-sum amount equal to the vested value of his or her account. If the vested value of the participant's account is less than \$7,000, the participant will be forced out of the Plan. If a mandatory distribution is being made because a participant's vested interest in the Plan exceeds \$1,000 but does not exceed \$7,000, then the Plan will roll over the distribution to an IRA. If the vested interest is less than \$1,000, the mandatory distribution will be paid in a lump sum.

Hardship distributions and in-service retirement distributions are also permitted for participants who have not separated from service. Participants must have attained age 59 ½ to qualify for in-service retirement distributions.

Generally, certain minimum distributions are required for participants who have separated from service and have reached the required minimum distribution age.

Vesting

Participants are immediately vested in their voluntary contributions and safe harbor matching contributions. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

Forfeitures

The non-vested portion of a paid participant's balance is used to offset administrative fees or to reduce the employer's matching contribution. At December 31, 2024 and 2023, there were forfeited non-vested amounts of \$532 and \$4,716, respectively. Forfeitures of \$7,777 and \$11,650 were used to offset plan fees during the years ended December 31, 2024 and 2023, respectively. In addition, \$0 and \$243 were applied to participant accounts to correct contribution errors identified during the year ended December 31, 2024 and 2023, respectively.

Notes Receivable from Participants

Participants may borrow from the Plan in any amount greater than \$1,000 up to a maximum of \$50,000 or 50% of the participant's vested account balance, for a term not to exceed five years (fifteen years in cases where the loan proceeds are used to purchase the participant's principal residence). All loans shall bear a fixed interest rate at 1% above the prime interest rate. Principal and interest are paid ratably during the year through payroll deductions and credited to the participant's account.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Basis of Presentation

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("GAAP"), as codified by the Financial Accounting Standards Board.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by investment advisors and the Plan Provider. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year and is reflected in the statements of changes in net assets available for benefits.

Contributions

Contributions from Plan participants and matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits to participants are recorded when paid.

Administrative Fees

The investment funds in the Plan are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements.

Certain administrative expenses paid from Plan assets are reflected in these financial statements. Other administrative expenses that are paid by the Company are not reflected in the accompanying financial statements.

Income Taxes

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

NOTE 4 FAIR VALUE MEASUREMENTS

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;

 - Quoted prices for identical or similar assets or liabilities in inactive markets;

 - Inputs other than quoted prices that are observable for the asset or liability;

 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means;

 - If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change to the methodology used at December 31, 2024 and 2023.

Pooled Separate Accounts: Valued at the net asset value (NAV) of shares held by the Plan at year end. The NAV, as provided by the insurance company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the account less its liabilities. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the accounts, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan does not have any assets to be classified within the fair value hierarchy table. See investments measured using the net asset value per share practical expedient in the following table to reconcile to investments at fair value on the Statements of Net Assets Available for Benefits.

Aggressive growth pooled separate accounts invest in stocks of companies with potential for rapid growth. These investments seek long term growth of capital.

Conservative pooled separate accounts seek to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long term.

Growth pooled separate accounts include investments that invest in companies the account manager believes have above-average growth potential. Most underlying holdings are in common stocks. The accounts may make limited use of futures and/or options for the purpose of maintaining equity exposure. These managers are generally willing to pay higher market multiples for the superior growth rates and profitability they anticipate. As a result, stocks in growth portfolios will tend to have higher price/earnings ratios and will generally pay little or no dividends.

Income pooled separate accounts invest in bonds or other fixed-income securities as well as preferred shares and dividend stocks. These investments prioritize current income, often in the form of interest or dividend-paying investments.

Target pooled separate accounts provide investors with a portfolio of a mix of stocks and bonds, as well as cash equivalents, with a variety of objectives.

NOTE 5 CONTRACTS WITH INSURANCE COMPANIES

Effective August 13, 2021, the Plan holds pooled separate accounts through a Group Annuity Contract with John Hancock Life Insurance Company (U.S.A). As of December 31, 2024 and 2023, the long-term credit rating of the issuer was “A+” as reported by A.M. Best. The pooled separate accounts are credited with the earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

NOTE 6 INCOME TAX STATUS

The Plan is a Non-Standardized Pre-Approved Profit Sharing Plan With CODA sponsored by the TPA (Tax Sheltered Compensation (TSC)) and adopted by the Company. The Internal Revenue Service informed the TPA by an opinion letter dated June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing Plan is acceptable under Section 401 of the Internal Revenue Code. The Plan has not requested its own determination letter from the IRS. The Company and plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and the Plan continues to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

NOTE 7 EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST

Fees paid to John Hancock for administrative services during the years ended December 31, 2024 and 2023 were \$61,811 and \$49,778, respectively. In addition, during 2024 and 2023, \$13,925 and \$11,525 in loan set-up fees and distribution fees were paid to the third-party administrator for the Plan. During 2024 and 2023, \$2,361 and \$1,905 in investment advisory fees was paid to Wilshire Associates Inc. During 2024 and 2023, \$7,777 and \$11,650 in audit fees were paid to Brady, Martz and Associates, P.C.

NOTE 9 AMENDMENT AND TERMINATION

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination, the rights to all participants shall remain nonforfeitable. In the event of plan termination, participants will become 100 percent vested in their accounts.

NOTE 10 RISKS AND UNCERTAINTIES

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 11 SUBSEQUENT EVENTS

No significant events have occurred subsequent to the Plan's year end. Subsequent events have been evaluated through July 21, 2025, which is the date these financial statements were available to be issued.
