NOTE 1 – DESCRIPTION OF PLAN

The following description of LidWorks (“Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of the Company who are employed by the Company for a three-consecutive-month period and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute in accordance with the provisions of the Plan (limited by certain provisions of the Internal Revenue Code). Effective January 1, 2016, the Plan was amended to allow the option of ROTH deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds as investment options for participants.

The Company contributes 100% of the participant’s elective deferral (401k and/or ROTH) in total that does not exceed 1% of the participant’s compensation, plus 50% of the participant’s elective deferral that exceeds 1% of participant’s compensation but do not exceed 6% of the participant’s compensation. Additional profit-sharing amounts may be contributed at the option of the Company’s board of directors. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, allocations of the Company’s contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE 1 – DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested in the profit-sharing contributions after six years of credited service and 100% vested in the qualified safe harbor contributions after two years of credited service.

Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest which are commensurate with local prevailing rates being charged by financial institutions for loans which would be made under similar circumstances as determined by the Plan administrator. Principal and interest is paid ratably through bi-weekly payroll deductions or ACH from the participants' bank account.

Payments of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a ten-year period. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Amounts allocated to terminated participants at December 31, 2024 and 2023, were \$182,195 and \$34,582, respectively.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,852 and \$1,354, respectively. These accounts will be used to offset plan expenses and reduce future employer contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Date of Management's Review

Subsequent events were evaluated through July 22, 2025, which is the date the financial statements were available to be issued.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Basis of Accounting

The financial statements of the plan are prepared on the accrual basis of accounting.

Participant Loans

Participant's loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Shares in mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. Net appreciation in fair value of the Plan investments is determined based on the difference between market value at the end of the year and the market value at the beginning of the year or cost if acquired during the year. Loans to participants are valued at cost which approximates fair value.

The Standard, through Minnesota Life Insurance Company (MN Life), holds the Plan's investment assets and executes transactions therein. Financial information relating to the assets is included in the accompanying financial statements and is based on information provided by The Standard Insurance Company.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

All expenses of maintaining the Plan are paid by the Company.

NOTE 3 – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consists of quoted prices for similar assets in active markets and Level 3 inputs consists are unobserved and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Level 2 Fair Value Measurements

The mutual funds in this plan are pooled equity funds held in MN Life's separate account of equity funds. MN Life's separate account is not publicly traded but is instead comprised of assets that are valued by daily quoted prices, which is equal to fair market value.

Level 3 Fair Value Measurements

The insurance contract is not actively traded and significant other observable inputs are not available. Thus, The Standard Insurance Company believes that the contract value is an appropriate measure for the insurance contract and the contract value approximates fair value.

NOTE 6 – TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated July 5, 2005, that the Plan and related trust are designed in accordance with applicable sections for the Internal Revenue Code (IRC). 
