In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Meridian Products 401(k) Retirement Investment Plan's ability to continue as a going concern for one year after the date the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Meridian Products 401(k) Retirement Investment Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Meridian Products 401(k) Retirement Investment Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters - Supplemental Schedule Required by ERISA

The supplemental schedule of the Schedule of the Assets Held for Investment Purposes as of December 31, 2024, is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

Note 1 – Plan Description

The following description of the Meridian Products 401(k) Retirement Investment Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering all eligible employees of Nessco Enterprises, LLC d/b/a Meridian Products (the “Company”) and provides for retirement, death, and disability benefits. Employees are eligible to participate in the Plan after completing three months of service and attaining age 18. The Plan entry date is the first day of the Plan year quarter coinciding with or immediately following the date the Plan's eligibility requirements are satisfied. The Plan incorporates an automatic enrollment feature for participants and an annual automatic 1% deferral to escalation feature up to a maximum of 10%. The Plan Administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan's offerings and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Eligible participants may elect to defer a percentage of his or her compensation into the Plan up to the maximum amount allowed by law. New participants who do not make an election will be automatically enrolled at 2% of compensation. If the participant allows the automatic 401(k) contributions to continue, the Plan Administrator will increase the contribution by 1% each Plan year until the contribution equals 10% of compensation. Participants who have attained age 50 by the end of the Plan year (including highly compensated employees, “HCEs”) are eligible to make additional contributions in the form of catch-up contributions. Participants who are considered HCEs were limited to the prior year's non-HCE average deferral percentage plus catch-up contributions (where applicable) for the Plan years ended December 31, 2024 and 2023, respectively. Participants are permitted to transfer or rollover into the Plan certain distributions received from another qualified retirement plan. The Plan currently offers common collective trust funds and various mutual fund options for participants.

The Company may, at its discretion, match participant contributions to the Plan of an amount equal to 25% of the participant's first 8% of salary deferrals. Additional contributions by the Company are at the discretion of the Board of Directors. There were no such additional discretionary contributions during 2024 or 2023. The matching Company contribution and additional Company contributions are directed into the various investment options by the participants.

Participant Accounts – Each participant's account is credited with the participant's contribution and the participant's share of the employer contributions, an allocation of Plan earnings or losses based on the participant's directed investment accounts and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1 – Plan Description – Continued

Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants are vested in discretionary employer match contributions and profit-sharing contributions plus actual earnings thereon based on years of continuous service as follows:

Special vesting rules apply for participants who die, become disabled or reach the early retirement age (55) prior to becoming fully vested.

Payment of Benefits – Upon retirement, disability, death, or termination of service, a participant may elect to receive a lump-sum distribution equal to the vested value of his or her account. Account balances of terminated participants up to \$1,000, including rollover accounts, may be distributed to them without their consent. Account balances of terminated participants in excess of \$1,000 may remain in the Plan and are subject to minimum required distribution requirements at age 70.5 and are paid out in various ways depending on the circumstance. Hardship withdrawals are permitted from fully vested employee deferral accounts and any rollover contributions plus their earnings.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. Loans must be repaid within five years. The loans are secured by the balance in the participant's account. The loans bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. The rate of interest on all outstanding loans as of both December 31, 2024 and 2023 was 4.25% – 9.50%. Principal and interest are paid ratably through bi-weekly payroll deductions.

Forfeitures – Forfeitures occur as of the earlier of the last day of the Plan year in which a former participant incurs five consecutive one-year breaks in service or the distribution of a participant's entire vested account balance. Forfeitures are generally required to be used in the Plan year in which they occur and may first be used to pay Plan administrative costs. Any remaining forfeitures shall be used to satisfy the Plan Sponsor's discretionary matching and/or profit-sharing contribution obligation under the plan. For the years ended December 31, 2024 and 2023, there were forfeitures of \$2,229 and \$1,274, respectively, used to pay Plan expenses.

Note 2 – Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value as determined and certified by the Plan's Trustee. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end. The common collective trust funds are recorded at fair value based on underlying assets.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – All administrative expenses will be paid by the Plan unless paid by the Company. Certain administrative expenses associated with the Plan were paid by the Company.

Subsequent Events – Events that occurred subsequent to December 31, 2024 have been evaluated by the Plan's management through July 14, 2025, which is the date the financial statements were available to be issued.

Note 3 – New Accounting Standards

Pronouncements issued by the Financial Accounting Standards Board (FASB) with future effective dates are either not applicable or are not expected to be significant to the Plan's financial statements.

Note 4 – Investments

During the years ended December 31, 2024 and 2023, the Plan's investments in common collective trust funds and in mutual funds, including gains and losses on investments bought, sold, and held during the year, appreciated in value by \$865,056 and \$985,873, respectively.

Note 5 – Fair Value Measurements

Generally accepted accounting principles in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at quoted market prices, which represent the net asset value ("NAV") of shares held by the Plan at year end.

Note 5 – Fair Value Measurements – Continued

Common collective trust funds: The Plan invests in common collective trust funds. The Funds are designed to deliver safety and stability by preserving principal and accumulating earnings. These funds are primarily invested in guaranteed investments contracts and synthetic investment contracts. The funds are valued based upon the NAV of the underlying investments. Participant-directed redemptions have no restrictions, however, the Plan is required to provide a one-year redemption notice to liquidate its entire share in the funds.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6 – Investment Contracts with Insurance Companies

At December 31, 2024 and 2023, the Plan is invested in multiple common trusts. The common trusts at December 31, 2024 consist of The Morley Stable Value Fund, the Alta Trust AM1 Portfolio Diversifiers Fund, the Alta Trust AM1 Income Fund, the Alta Trust AM1 Domestic Equity Fund, the Alta Trust AM1 International Equity Fund, and the Alta Trust AM1 Core Fixed Income Fund (the “Funds”). The common trusts at December 31, 2023 consisted of The Morley Stable Value Fund, the Resources Diversified Equity Fund, the Resources Diversified Fixed Income Fund, and the Resources Diversified Risk Mitigation Fund (the “Funds”). The Funds are collective investment funds for collective investment in a variety of high-quality stable value investment contracts (the performance of which may be predicated on underlying fixed income securities), as well as cash and cash equivalents, designed for the stability of principal. The objective of the Funds is to provide preservation of capital, relatively stable returns consistent with their comparatively low risk profile, and liquidity for benefit- responsive payments.

The trusts invest primarily in wrap contracts. In a wrap contract, the underlying investments are owned by the trust and held in trust for Plan participants. The trust purchases a wrap contract from a high-quality insurance company or bank.

An issuer could terminate an investment contract upon the event of default by the contract holder, advisor, or trustees of the Funds if the issuer determines in its reasonable discretion, such event has had, or is likely to have a material adverse effect on the issuer’s interest with respect to the contract. Such events may include but are not limited to: management of the portfolio is not in accordance with investment guidelines, a breach of any material obligation under the wrap agreement, any representation of warranty made by the contract holder becomes untrue in any material way, a replacement of the advisor without proper consent of the issuer, a fund is terminated or ceases to qualify as a group trust or plans cease to meet the appropriate tax qualifications, or the wrap becomes a prohibited transaction within the meaning of Section 406 of ERISA. The Plan and participants may make withdrawals from a fund on a daily basis. There are no unfunded commitments and the Plan has a 12 month redemption period.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become 100 percent vested in their accounts.

Note 8 – Parties-In-Interest Transactions

Administrative fees paid during the years ended December 31, 2024 and 2023, which were paid to the third-party administrator, totaled \$59,963 and \$53,545, respectively.

As previously discussed, the Plan may issue notes receivable to participants that are secured by participant account balances. The value of the notes receivable outstanding was \$109,120 and \$113,245 as of December 31, 2024 and 2023, respectively. Interest income on notes receivable from participants was \$8,129 and \$8,804 for the years ended December 31, 2024 and 2023, respectively. All of these transactions qualify as party-in-interest transactions.

Note 9 – Tax Status

The Company adopted a Non-Standardized Prototype Profit Sharing Plan, which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020. The opinion letter stated that the Prototype Plan, as then designed, is in accordance with applicable sections of the Internal Revenue Code (IRC). The prototype has been amended since receiving the determination letter for various amendments. However, the Plan Administrator and third-party administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan continues to be tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and the Department of Labor. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10 – Information Prepared and Certified by Trustees

The following information for the years ended December 31, 2024 and 2023 included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by Ascensus Trust Company, the Trustee of the Plan.

Note 11 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for benefits.
