Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Four Seasons Orthopedic Center PA 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Four Seasons Orthopedic Center PA 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in Note 1 to the financial statements, the plan sponsor entered into an agreement with Northeast Orthopaedic Alliance to merge the Plan assets of the Four Seasons Orthopedic Center PA 401(k) Plan into the Northeast Orthopaedic Alliance, PLLC 401(k) Plan effective July 1, 2025. The Plan will cease to exist as a standalone plan on this date. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Four Seasons Orthopedic Center PA 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

(1) Description of the Plan

The following description of the Four Seasons Orthopedic Center PA 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan’s Adoption Agreement for a more complete description of the Plan’s provisions.

- (a) General – The Plan is a defined contribution plan covering all full-time employees, as defined by the Plan, of Four Seasons Orthopedic Center PA (the “Company”). Employees are eligible for participation after one year of service (1,000 hours) and attaining the age of 21. In accordance with the SECURE Act and SECURE 2.0, certain long-term, part-time employees may also be eligible to participate if they have completed at least 500 hours of service in three consecutive years (for plan years beginning before January 1, 2025) or two consecutive years (for plan years beginning on or after January 1, 2025), subject to the Plan’s provisions and applicable law. Upon meeting the eligibility requirements, a participant can enter the Plan on the first day of the following quarter.

Effective January 1, 2025, the Company became part of an alliance with several other orthopedic centers, creating Northeast Orthopaedic Alliance. The Board voted to merge the Plan into the Northeast Orthopaedic Alliance, PLLC 401(k) Plan, effective July 1, 2025. The Plan will cease to exist as a standalone plan on this date. All contributions after January 1, 2025, with the exception of the employer contribution receivable, will be deposited into the Northeast Orthopaedic Alliance, PLLC 401(k) Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Board of Trustees oversees governance of the Plan. The Plan’s Retirement Committee determines the appropriateness of the Plan’s offerings, monitors investment performance, and reports to the Plan’s Board of Trustees.

- (b) Employee Contributions – Participants may contribute up to 100% of eligible compensation as defined in the Plan, limited to a maximum amount as periodically set by the Internal Revenue Service (“IRS”). Participants who have attained the age of 50 before the end of the plan year may contribute an additional amount set by the IRS. Participants may also contribute amounts representing rollovers from other qualified defined benefit or contribution plans.
- (c) Company Contributions – The Company makes a matching contribution each payroll period for each employee who enters into a salary reduction agreement. The match during 2024 and 2023 equaled 25% of the first 4% deferred by employees, for a maximum match of 1%.

During 2024 and 2023, the Company made a safe harbor contribution equal to 3% of participants’ eligible compensation regardless of their deferral amount.

The Company may also contribute a discretionary profit-sharing contribution for each employee, without regard to current or accumulated net profits of the Company. Employees are eligible if they are active participants as of December 31st and have 1,000 or more hours of service during the plan year. For the years ending December 31, 2024 and 2023, the Company made a profit-sharing contribution in the amount of \$772,140 and \$681,974, respectively, after using forfeitures.

Description of the Plan (continued)

- (d) Participant Accounts – Each participant’s account is credited with the participant’s contributions, the Company’s matching and safe harbor contributions, and allocation of (a) the Company’s discretionary profit-sharing contribution, (b) plan earnings, and (c) forfeitures of terminated participants’ non-vested account balances. Allocations are based on a participant’s eligible compensation relative to total eligible compensation, deferred contribution amounts, or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant directs the investment of the contributions into various investment options offered by the Plan.
- (e) Vesting – Participants are immediately vested in their voluntary contributions and safe harbor contributions, plus actual earnings thereon. Vesting in the Company’s matching and discretionary profit-sharing contribution portion of the participant’s account plus actual earnings thereon is based on years of continuous service. A participant is 20% vested after two years of credited service, with an additional 20% per year thereafter until fully vested. Upon normal retirement age, 62 years old, death, or disability, a participant becomes fully vested.
- (f) Benefit Payments – On termination of service due to death, disability, or retirement, a participant may elect to receive distributions equal to the value of the participant’s vested interest in their account. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution, leave the funds in the Plan until retirement age, or transfer to a trustee of another qualified plan or individual retirement account. If the terminating employee’s non-forfeitable account balance is less than \$1,000, excluding rollovers, it is mandatory that the Plan distribute the entire account balance, less forfeitures, if any, as soon as administratively practical.
- A participant may withdraw rollover contributions at any time. In addition, if a participant has been an active participant for at least five years, a participant may make up to five withdrawals a year from vested discretionary profit-sharing contributions. The Plan also allows hardship distributions under federal rules.
- (g) Forfeited Accounts – Forfeitures represent amounts which could not be paid to terminated participants due to failure to meet vesting requirements and certain other adjustments. Forfeitures are used to reduce the Company’s contributions or expenses. Forfeitures of \$25,824 and \$49,249 were used to reduce the employer contribution receivables for the years ending December 31, 2024 and 2023, respectively. Forfeitures available at December 31, 2024 and 2023 were \$28,965 and \$51,910, respectively, prior to reducing the receivables.
- (h) Notes Receivable – Participants may borrow a minimum of \$1,000 up to a maximum, not to exceed 50% of their vested account balance or \$50,000, whichever is less. Loan transactions are treated as transfers between the investment fund and the loan account, representing issuance and repayments. Loan terms vary in range, up to five years. The loans are secured by the balance in the account and bear interest at the prime rate as published in the Wall Street Journal on the first day of such month. Principal and interest are repaid ratably through weekly payroll deductions.

(2) Summary of Significant Accounting Policies

- (a) Basis of Accounting – The accompanying financial statements are prepared on the accrual basis of accounting.
- (b) Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.
- (c) Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value except for fully benefit-responsive investment contracts which are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. All other investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. If available, quoted market prices are used to value these investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

- (d) Benefit Payments – Benefits are recorded when paid.
- (e) Notes Receivable – Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan Document.
- (f) Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Certain recordkeeping, audit, and advisory fees are paid by the Plan.
- (g) Subsequent Events – The Company has evaluated subsequent events through June 20, 2025, which is the date that the financial statements were available to be issued.

(3) Information Prepared and Certified by Trustee

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule of assets held for investment purposes as of December 31, 2024, and the related investment activity reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

(4) Investment Contract

The Plan has entered into a benefit-responsive guaranteed investment contract. The trustee maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. The investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment option or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants are probable of occurring.

The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

(5) Plan Amendment and Termination

As discussed in Note 1, the Plan will merge into the Northeast Orthopaedic Alliance, PLLC 401(k) Plan on July 1, 2025.

Additionally, the Company may amend the Plan at any time without the consent of any participant or any beneficiary, provided that no amendment deprives any participant of the participant's non-forfeitable accrued benefit.

(6) Tax Status

The Plan is based on a prototype plan that received a favorable opinion letter from the IRS dated June 30, 2020, indicating that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”), and was therefore exempt from federal income taxes. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability for uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

(7) Withdrawing Participants

There were no participant distributions requested in 2024, but not paid until 2025.

(8) Related Party Transactions

The Plan has a number of service providers. Such parties are considered parties-in-interest under ERISA.

(9) Fair Value Measurements

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds and self-directed account: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC").

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
