## INDEPENDENT AUDITORS' REPORT

To the Participants and Plan Trustees  
IMCO Carbide Tools, Inc. Profit Sharing Trust

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the IMCO Carbide Tools, Inc. **Basis for Opinion**

## 1. DESCRIPTION OF PLAN:

The following description of IMCO Carbide Tools, Inc. Profit Sharing Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan covering all eligible employees, as defined, of IMCO Carbide Tools, Inc. (the "Plan Sponsor" or "Company") who have completed one month of service and have attained the age of 20.5. Participation is not permitted for employees who are covered by a collective bargaining agreement, leased employees, or employees who are non-resident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### Contributions

Each year, participants may contribute up to 100% of their compensation (through pre-tax or Roth contributions), as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect another contribution election. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Plan also includes an automatic increase provision whereby participants' deferral rate increases by 1% per year up to a maximum of 6% of compensation.

The Company makes a Qualified Automatic Contribution Arrangement (QACA) Safe Harbor matching contribution of 100% of participant contributions up to 6% of eligible compensation. Additional discretionary profit-sharing contributions may be contributed to participants who have completed one year of service. Additional discretionary matching may be contributed to participants who have completed one month of service (prior to January 1, 2023 participants were eligible after one year of service). No such discretionary contributions were made for the year ended December 31, 2024.

### Participant accounts

Each participant's account is credited with the participant's and Company contributions, as well as allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's QACA Safe Harbor match is subject to a two-year cliff. Vesting in the Company's discretionary profit-sharing contribution is based on years of continuous service in which a participant is 100% vested after six years of credited service. Vesting in the Company's discretionary matching contribution is subject to a three-year cliff.

## 1. DESCRIPTION OF PLAN (CONTINUED):

### Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account. The interest rate is determined by the plan administrator at a rate commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions. Loans are generally payable within 5 years except when for the purchase of a primary residence.

### Payment of benefits

Distributions are payable upon termination of employment, death, disability, or retirement via a lump sum payment. Participants may also make withdrawals prior to termination upon attainment of age 59 ½, five years of participation, early retirement, or in the event of financial hardship, from 100% vested sources, as defined by the plan.

### Forfeited accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$-0- and \$2,659, respectively. These accounts may be used to reduce future employer contributions or pay administrative expenses. Plan expenses were reduced by \$2,679 from forfeited non-vested accounts for the year ended December 31, 2024.

## 2. SUMMARY OF ACCOUNTING POLICIES:

### Basis of accounting

The financial statements of the plan are prepared on the accrual basis of accounting.

### Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

## **2. SUMMARY OF ACCOUNTING POLICIES (CONTINUED):**

### **Payment of benefits**

Benefits are recorded when paid.

### **Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation of fair value of investments.

### **Subsequent events**

The Plan has evaluated subsequent events through July 28, 2025 the date the financial statements were available to be issued.

## **3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN:**

Management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Ascensus, LLC, as an agent for Ascensus Trust Company, the custodian, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024 and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

## **4. FAIR VALUE MEASUREMENTS:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**4. FAIR VALUE MEASUREMENTS (CONTINUED):**

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

**5. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS:**

Plan investments include mutual funds managed by Ascensus Trust Company. Ascensus Trust Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees are paid to certain parties in interest for services performed on behalf of the Plan. The plan sponsor pays directly any other fees related to the Plan's operations.

**6. PLAN TERMINATION:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

**7. TAX STATUS:**

The plan sponsor adopted a non-standardized regional prototype profit sharing plan, for which a letter from the Internal Revenue Service was received on June 30, 2020, indicating that an employer who adopts this prototype plan will be considered to have a plan qualified under applicable sections of the Internal Revenue Code (IRC). The plan sponsor has elected not to request a separate determination letter for the Plan. The plan sponsor and the Plan's administrator believe that the Plan is currently designed and being operated in compliance with applicable requirements of the IRC. Therefore, they believe the Plan was qualified as of the financial statement date.

**8. RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
