NOTE A -- Description of the plan and significant accounting policies

The following description of the Maxus Operations, LLC and Affiliates 401(K) Plan ("the plan") provides only general information. Participants should refer to the plan document for a more complete description of the plan's provisions. The employer, as described below, has adopted the Associated Trust Company, N.A. Non-standardized Pre-Approved Profit Sharing Plan, effective September 11, 2024. Prior to that date, the employer had adopted the Retirement Advantage, Inc. Non-standardized Pre-Approved Profit Sharing Plan with the most recent restatement effective January 1, 2021. The plan has an original effective date of January 1, 1987.

Effective September 11, 2024, the plan changed its asset custodian from Lincoln National Life Insurance Company (Lincoln) to Associated Trust Company, N/A (Associated). Associated also became the trustee on that date.

General

The plan is a defined contribution plan covering all eligible employees of MaxUS Operations, LLC, Max Pax, LLC, MaxPax 1140, LLC and US Packaging, LLC (herein referred to as "the company or employer") who have completed at least 500 hours of service in a six month period of employment or the completion of one year of service and are age twenty-one or older. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Committee is responsible for oversees governance of the plan, determines the appropriateness of the plan's investment offerings and monitors investment performance.

The Plan's federal identification number is 46-2715562 and the plan's number is 001.

Contributions

Each year, participants may contribute up to the maximum amount allowed by law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans. Participants direct the investment of their contributions into various investment options offered by the plan. The employer contributes 50% of the first 4% of eligible compensation as a discretionary matching contribution. The employer also has the right to make additional contributions to be allocated to participants pro rata based on compensation. No additional discretionary contributions were made in 2024. Annual contributions from all sources are subject to certain limitations defined by the Internal Revenue Service (IRS).

Contributions receivable

Contributions receivable are written off when they are determined to be uncollectible. The allowance for credit losses is estimated based on expected credit losses considering the plan's historical losses, existing economic conditions, and the financial stability of the company.

NOTE A -- Description of the plan and significant accounting policies (Continued)

Participant accounts and “rollovers”

Each participant’s account is credited with the participant’s contribution and allocations of (a) the employer’s matching and discretionary contributions, (b) plan earnings and (c) charged with an allocation of administrative expenses. Allocations of plan earnings are based on participant account balances, as defined, and allocation of company contributions are based on participants’ compensation, as provided in the plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. The plan permits the transfer of funds from other qualified plans to a separate participant’s rollover account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employer’s contribution portion of their accounts is based on years of continuous service. A participant vests over a six year period at a rate of 20% starting in year two. Participants who leave the plan because of death, disability, or reaching early retirement age, as defined in the plan, are considered 100% vested in all amounts.

Participant loans

Participants may not borrow from their fund accounts.

Benefits

On termination of service due to death, disability, retirement (age 65), or termination of service due to other reasons, a participant with an account valued at less than \$1,000 shall receive a lump sum distribution. An automatic rollover of a participant’s account to an IRA will occur if the account is valued between \$1,000 and \$5,000. For accounts exceeding \$5,000 the participant may elect a distribution in the form of a lump-sum, partial distributions to satisfy required minimum distribution rules, or may elect to defer such distribution to any valuation date subsequent to his/her termination but no later than the valuation date of his/her normal retirement date; or the participant may elect to rollover the distribution to another qualified plan. The plan permits hardship distributions if certain criteria are met. The plan permits in-service distributions at age 59 ½.

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,514 and \$0, respectively. These accounts can be used to reduce employer contributions, allocated as additional employer contributions, or used to pay plan expenses. In 2024, employer contributions were reduced by \$1,039 from forfeited nonvested accounts.

A summary of significant accounting policies follows:

Basis of accounting

The financial statements of the plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) under the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Committee determines the plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

The company pays some of the administrative expenses of the plan which are excluded from the financial statements. The major administrative expenses are recordkeeping and investment fees.

Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions and adjustment to net appreciation in fair value of investments. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and 2024, respectively.

Subsequent events

These financial statements have not been updated for subsequent events occurring after July 28, 2025, which is the date these financial statements were available to be issued. The plan has no responsibility to update these financial statements for events and circumstances occurring after this date.

NOTE B -- Information certified by the asset custodians

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Lincoln and Associated, the asset custodians of the plan.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Registered investments companies. Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Common/collective trust funds. Valued based on net asset values of the shares held by the plan at year end. While the majority of the underlying asset values are based on quoted prices, the net asset value of the collective trust funds are not publicly quoted. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.
- Pooled separate accounts. The pooled separate accounts are invested in investments such as stocks, mutual funds, short-term investments, bonds, etc. Lincoln owns the underlying investments in these separate accounts. The underlying measurements for the separate key prices are for similar assets in active or non-active markets. While the underlying asset values are quoted prices, the net asset value of the separate account is not publicly quoted.

Gains and losses (realized and unrealized) included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024 are reported in net appreciation in fair value of investments.

NOTE D -- Party-in-interest transactions

Lincoln and Associated are the asset custodians, and The Retirement Advantage is the third-party administrator of the plan, and are therefore designated as fiduciaries and parties-in-interest. The plan regularly invested in funds for which Lincoln and Associated or its affiliates were the issuing parties. These party-in-interest transactions occurred in the course of ordinary business and were exempt transactions.

NOTE E -- Plan termination

Although it has not expressed any intent to do so, the company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their employer contributions.

NOTE F -- Tax status

The Associated Trust Company, N.A. Non-Standardized Pre-Approved Profit Sharing Plan, that the plan adopted effective September 11, 2024 obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The plan administrator and the plan's tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the plan was qualified and the related trust was tax-exempt as of the financial statement date.

NOTE G -- Concentration of market risks

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE H -- Excess contributions payable

The Plan failed the discrimination test for the years ended December 31, 2024 and 2023. Excess contributions amounting to \$32,070 and \$21,906 for the years ended December 31, 2024 and 2023, respectively, are recorded as a liability in the accompanying Statements of Net Assets Available for Benefits and as a reduction of contributions for each year. The Plan has reimbursed these excess contributions to its participants during March 2025 and 2024, respectively. For purposes of the Form 5500, these excess contributions are not recorded until the year paid.
