INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of **Digging & Rigging 401(k) Profit Sharing Plan**:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of **Digging & Rigging 401(k) Profit Sharing Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of **Digging & Rigging 401(k) Profit Sharing Plan's** financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. A. Description of Plan

The following description of Digging & Rigging 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement or the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution, tax-deferred profit sharing Plan covering employees of Digging & Rigging, Inc. and Digging and Rigging II, Inc. (together, the "Company") who are age 18 or older and have 60 days of service with the Company. Any employees covered by a collective bargaining agreement and leased personnel are exempt from participation. Employees may enter the Plan monthly. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 100% of compensation, as defined in the Plan documents and subject to certain irregular pay provisions, such as for bonuses, not to exceed the maximum salary deferral limit and other limitations established by law. Participants may make contributions either as pre-tax contributions or Roth contributions, or both. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as allowed by the Internal Revenue Code (IRC). Participants may also make rollover contributions from other qualified defined benefit or defined contribution plans and certain individual retirement accounts. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company automatically enrolls new hires in the Plan at a deferral rate of 3% of employee compensation and automatically increases the deferral rate by 1% at the beginning of each subsequent Plan year up to a maximum of a 10% deferral. Employees have the option to select a different deferral amount, including zero. An affirmative employee deferral election overrides any automatic increase of the deferral percentage.

The Company makes a discretionary matching contribution, the amount of which is determined annually. In 2024, the Company matched 50% of employee contributions up to 6% of employee compensation, as defined by the Plan. Additional profit sharing contributions may be contributed at the option of the Company. Contributions are subject to certain IRS limitations. Matching and any profit sharing contributions are invested according to direction of the participants.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of any Company profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their own deferral contributions, rollover contributions and earnings thereon. Participants vest in Company matching and any discretionary profit sharing contributions and earnings over a six-year vesting schedule. Participants become 100% vested under certain other

circumstances, including attainment of age 65, the Plan's normal retirement age. Non-vested balances are subject to forfeiture upon termination of employment.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may have only one outstanding loan at a time. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1 percent above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Plan participants are eligible to receive benefit payments from the Plan at retirement, prior to retirement under certain circumstances, upon termination of employment with the Company, upon disability and at death. Benefit payments are limited to the value of the participant's vested interest in his or her account and may be elected as a lump-sum payment or rollover. Partial withdrawals are available only for required minimum distributions. Hardship withdrawals are allowed, subject to Plan provisions and applicable laws. In-service distributions may be made to a Participant who has not separated from service provided the Participant has attained age 59 ½. Accounts with balances of less than \$5,000 may be cashed out of the Plan at the discretion of the Company.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested balances held in interest bearing accounts were \$4,305 and \$11,200, respectively. Forfeited amounts may be used to reduce future employer contributions. Forfeitures totaling \$48,793 were used by the Plan to reduce employer contributions during 2024.

B. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

Preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The trustee of the Plan assets certifies the fair market value of the Plan investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. The loans are secured by vested participant account balances. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain administrative expenses of the Plan are paid by the Company and are excluded from these financial statements. Per-use transaction fees are charged directly to specific participant accounts for certain services, such as processing loans, in-service withdrawals, distributions, and other transactions. In addition to per-use transaction fees, participants with account balances share in the operational expense of the Plan. Investment related expenses are included in net appreciation or depreciation in the fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events for disclosure in these financial statements through July 18, 2025, the date the financial statements were available to be issued.

C. Information Prepared and Certified by the Plan Trustee

D. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability. Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds and the money market fund are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts are valued at the NAV of units of the trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions may occur daily. If the Plan initiates a full redemption, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

E. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported on the statements of net assets available for benefits.

F. Party-In-Interest Transactions

John Hancock Retirement Plan Services, LLC receives fees for recordkeeping services and per-use transactions, including loan setup, distribution and other administrative services that are included in administrative expenses. John Hancock Trust Company LLC received fees for trust services. Certain Plan investments are managed by John Hancock Life Insurance Company, U.S.A., for which John Hancock Life Insurance Company, U.S.A. receives fees for services rendered.

A third party administrator receives payment for administrative and transaction processing services that are included in administrative expenses. A financial advisor receives fees for services that are included in administrative expenses. The Company provides the Plan with accounting and administrative services, for which no fees are charged to the Plan. The Plan allows loans to participants. The Plan's trustees are members of Company management and are participants in the Plan. These transactions qualify as exempt party-in-interest transactions.

G. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In

the event of Plan termination, participants become 100 percent vested in their accounts and the Company will arrange for distributions as soon as administratively feasible.

H. Tax Status

The Internal Revenue Service has determined and reported in its opinion letter dated May 27, 2021, that the form of the adopted pre-approved plan was then designed in accordance with applicable sections of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan administrator believes the Plan is currently being operated in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Management believes that no uncertain tax positions have been taken or are expected to be taken that would require recognition or disclosure in the financial statements.
