We have performed audits of the financial statements of the Weekley Homes 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. #### Note 1. Description of the Plan

The following description of the Weekley Homes 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan whereby eligible employees of Weekley Homes, LLC and its related and participating employers (as defined and collectively referred to as the Company or Plan Sponsor) are permitted to make pretax contributions that are tax-deferred under section 401(k) of the Internal Revenue Code (the Code). The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company has designated management individuals to act as the Plan Administrator.

The Company appointed Charles Schwab Bank (Schwab) as trustee of the Plan, and authorized Schwab to invest and manage the assets of the Plan.

**Plan amendment:** The Plan was amended on November 15, 2024, to allow for provisions of the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), which includes relief for participants affected by SARS-CoV-2 or coronavirus disease.

**Eligibility:** Nonexcluded employees of the Company become eligible to make elective deferrals upon completion of one month of service, as defined by the Plan. Eligible employees may enter the Plan on the first day of the month coinciding with or the first day of a month following the date on which eligibility requirements are met. Employees become eligible for discretionary employer contributions upon the completion of six months of service, as defined in the Plan agreement. An employee who is classified by the Company as part-time, temporary, or seasonal is eligible for participation on the entry date coinciding with or the first day of a month following the completion of one year of service, as defined by the Plan.

**Contributions:** Participants may contribute from 1% to 50% of defined compensation to the Plan, subject to certain maximum limitations imposed by the Code. Unless otherwise elected, each eligible participant will automatically have 4% of defined compensation before taxes deferred into the Plan upon meeting eligibility requirements and the participant's automatic deferral percentage shall be increased as of the first day of each plan year by 1%, up to a maximum of 8%. Employees who are eligible to make elective deferrals under the Plan and who have attained the age of 50 before the end of the close of the Plan year are also eligible to make catch-up contributions subject to the maximum limitation imposed by the Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Effective January 1, 2024, participants may also contribute post-tax deferrals to the Plan.

The Company may make discretionary matching contributions to the Plan. In 2024, the Company elected to make matching contributions in the amount of 100% of the participant's contributions up to 8% of each participant's compensation in each of the four respective quarters within the plan year resulting in employer contributions of \$14,143,789. The Company may also elect to make an additional discretionary contribution to the Plan based on a percentage of the profit sharing compensation paid to eligible employees, as determined by the Company. There were no additional discretionary contributions for the year ended December 31, 2024.

**Participant accounts:** Each participant's account is credited with the participant's salary deferral contributions, rollover contributions, the Company's discretionary matching contributions, discretionary profit sharing contributions, if any, and an allocation of plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings and account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

#### Note 1. Description of the Plan (Continued)

**Vesting:** Participants are immediately vested in their voluntary contributions and investment earnings thereon. Participants become 20% vested for employer matching and profit sharing contributions and earnings thereon after one year of credited service and vest an additional 20% for each year of service thereafter until they are fully vested after completion of five years of service. In addition, each employee becomes 100% vested upon death, disability or attaining normal retirement age.

**Investment options:** Participants are allowed to invest in a variety of investment choices as more fully described in the Plan's literature. Participants may change their investment options any time throughout the year.

**Forfeitures:** At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$495,000 and \$198,000, respectively. The balance of forfeited employer contributions and allocated earnings thereon may be used to reduce employer contributions to the Plan or to pay the Plan's administrative expenses. During 2024, amounts of employer nonvested contributions forfeited were approximately \$1,457,000 and employer contributions were reduced by approximately \$1,160,000 from forfeited nonvested accounts.

**Benefits paid to participants:** Upon termination of service due to death, disability, or retirement, each participant can receive their vested account balance in one lump-sum payment or, in certain cases, the participant can defer withdrawals. For termination of service due to other reasons, a participant may receive their vested account balance in one lump-sum payment. If a participant's vested balance is \$7,000 or less, the participant will receive a single distribution of their entire vested account balance. The Plan provides for the automatic rollover of vested participant balances above \$1,000, but less than \$7,000 into an individual retirement account if the participant does not elect to have the distribution paid directly to an eligible retirement plan in a direct rollover or to receive the distribution directly. Hardship withdrawals are also allowed, subject to the provisions specified in the Plan agreement.

Installment distributions are allowed for participants who have attained the age of 60, have completed 10 years of service and have a minimum vested balance of \$1,000. Installment payments may be made over a term not to exceed 20 years.

**Notes receivable from participants:** Participants are allowed to borrow a minimum of \$1,000 and a maximum of \$50,000 from their fund accounts, up to 50% of the participant's vested account balance. Each note bears interest at prime plus 1%, with prime being determined by the rate published in *The Wall Street Journal* (7.50% at December 31, 2024). Interest rates on outstanding notes receivable ranged from 4.25% to 9.5% at December 31, 2024. Note terms generally range from one to five years except for notes to purchase a principal residence, which can exceed five years. Principal and interest are paid ratably through payroll deductions and notes receivable outstanding at December 31, 2024, are due in various amounts through November 2039. A participant may have only one note outstanding at a time.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits, and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Capital gain distributions from mutual funds that are reinvested are included in dividends on the statement of changes in net assets available for benefits.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental Schedule H, line 4i—schedule of assets (held at end of year).

**Benefits paid to participants:** Benefits paid to participants are recorded when paid.

**Administrative expenses:** Certain administrative functions are performed by officers or employees of the Plan Sponsor. However, such employees receive no compensation from the Plan. The Plan Sponsor and the Plan participants share in the Plan expenses. Plan expenses, such as transaction fees from receiving a loan, withdrawal, or distribution from the Plan, are deducted from participants' accounts or investment income.

**Subsequent events:** The Plan has evaluated subsequent events (events occurring after December 31, 2024) through July 30, 2025, the date the financial statements were available to be issued.

The Plan was amended, effective July 1, 2025, to exclude employees under internship from participation in the Plan.

#### **Note 4. Fair Value Measurements**

Financial Accounting Standards Board Accounting Standards Codification (ASC) Topic 820, Fair Value Measurements and Disclosures (ASC 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Money market funds:** Valued based upon quoted market prices in the active market in which they are traded and is classified within Level 1 of the valuation hierarchy.

**Mutual funds:** Mutual funds are reported at fair value based on the quoted market price of the funds and are classified within Level 1 of the valuation hierarchy.

**Changes in fair value:** To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. For the year ended December 31, 2024, there were no transfers in or out of Level 3 investments.

#### Note 5. Party-In-Interest Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. As such, transactions conducted with Charles Schwab Bank, the trustee of the Plan, and the Company qualify as party-in-interest transactions.

#### Note 6. Income Tax Status

The Internal Revenue Service has determined and informed the Plan Sponsor, by a letter dated October 18, 2023, that the Plan is qualified and the trust established under the Plan is tax exempt under the appropriate sections of the Code. Although the Plan has been amended since filing for the determination letter, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

Management has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

#### Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants would become fully vested in their entire account balances and the net assets of the Plan would be distributed to the participants of the Plan in accordance with the provisions of ERISA.
