INDEPENDENT AUDITOR’S REPORT

To the Participants and Administrator
of the Legal Professions Benefits Trust

Opinion

We have audited the accompanying financial statements of the Legal Professions Benefits Trust (Trust), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

In our opinion, the financial statements present fairly, in all material respects, the net assets available for benefits of the Trust as of December 31, 2024 and 2023, and the changes in net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (U.S. GAAS). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Other Matter

The accompanying financial statements are those of the Trust, a trust created as a grantor trust for the purpose of providing and maintaining various group insurance policies to be issued to participating employers. These financial statements do not purport to present the financial statements of the plans of the participating employers and do not contain certain information on accumulated plan benefits and other disclosures necessary for a fair presentation of the financial status of the plans of the participating employers in accordance with U.S. GAAP.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Trust agreement, including all Trust amendments, administering the Trust, and determining that the Trust's transactions that are presented and disclosed in the financial statements are in conformity with the Trust's provisions, including maintaining sufficient records with respect to each of the participating employers and insurance providers, to determine the benefits due.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with U.S. GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with U.S. GAAS, we:

NOTE 1 - GENERAL

The following is a general description of the group insurance arrangement maintained through the Legal Professions Benefits Trust (Trust). Participating employers should refer to their respective organization's benefit plan agreements for a complete description of their plan's provisions.

The Trust was created as a grantor trust for the purpose of providing and maintaining group insurance policies to be issued by various companies that include but are not limited to group life insurance; group accident, death and dismemberment insurance; short-and long-term disability insurance; and any other form of group employee benefit insurance except medical insurance. The Trust is the single policyholder for premiums collected from participating employers relating to the insurance benefits covered by their respective benefit plans. The Trust is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Alliant Insurance Services, Inc. (Alliant) is the trust administrator and insurance advisor.

Insurance coverage is provided by Unum (insurance carrier), which is solely responsible for the payment of benefits to the participating employers' eligible employees and their dependents. Under these fully insured group insurance arrangements, the insurance carrier assumes the full financial risk of adverse experience. During the years ended December 31, 2024 and 2023, 100% of Trust payments for insurance premiums were paid to Unum.

Insurance coverage is funded by participating employer premium contributions, which are based on the insurance premium payable to the insurance carrier by the participating employers for their respective covered employees and their dependents. For the years ended December 31, 2024 and 2023, three participating employers represented approximately 69% and 79%, respectively, of the total contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies consistently applied by the Trust's management in the preparation of the accompanying financial statements follows:

Basis of Accounting - The financial statements of the Trust are prepared using the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash - The Trust maintains, at one financial institution, cash that may exceed federally insured amounts at times.

Accounts Receivable - Amounts recorded as accounts receivable at year-end represent premium contributions due to the Trust for insurance coverage provided in the years ended December 31, 2024 and 2023, respectively. Amounts are recorded at net realizable value and are deemed to be fully collectible as of December 31, 2024 and 2023.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Accounts Payable - Amounts recorded as accounts payable represent amounts payable to the insurance carrier, brokers and vendors for insurance coverage, commissions and administrative expenses for 2024 and 2023, respectively. Amounts are recorded at expected settlement amounts as of December 31, 2024 and 2023.

Deferred Premiums - Amounts recorded as deferred premiums received represent amounts paid to the Trust during the year, for premiums relating to the following year. Amounts are recorded at amounts received and are recognized as a premium contribution in the year when coverage is provided.

Commission and Administrative Expenses - Expenses consist of commissions paid in connection with insurance agreements brokered and expenses for accounting and bank service charges. These expenses are reported as a deduction from net assets in the statements of changes in net assets available for benefits. Certain other expenses are paid by Alliant and are excluded from these financial statements.

Insurance Premiums - Amounts recorded as insurance premiums represents funds received from participating employers for insurance coverage that are then remitted to the insurance carrier.

Fair Value Measurement - Fair value is the price that would be received to sell an asset or paid to transfer a liability (i.e., exit price) in an orderly transaction between market participants at the measurement date. The Trust discloses the category of assets and liabilities measured at fair value into one of three different levels, depending on the assumptions (i.e., inputs) used in the valuation. (See Note 6.)

Subsequent Events - The Trust has evaluated subsequent events through July 29, 2025, the date that the financial statements were available to be issued.

NOTE 3 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Alliant receives commissions on the insurance premiums paid by the participating employers. Commissions received represent rates negotiated with the underlying insurance providers, and for the years ended December 31, 2024 and 2023 were approximately \$817,000 and \$728,000, respectively, of which approximately \$116,000 and \$107,000 are included in accounts payable for the years ended December 31, 2024 and 2023, respectively. There were no receivables from Alliant for commissions that are held by Unum and paid directly to Alliant and then subsequently reimbursed to the Trust as of December 31, 2024. The Trust had a receivable of approximately \$55,000 as of December 31, 2023 from Alliant for commissions that were held by Unum and paid directly to Alliant and then subsequently reimbursed to the Trust. The Trust has payables to the insurance carrier, which is considered a party in interest, of approximately \$1,491,000 and \$1,177,000 as of December 31, 2024 and 2023, respectively. During the years ended December 31, 2024 and 2023, the Trust paid the insurance carrier premiums of approximately \$10,638,000 and \$8,171,000, respectively.

Alliant provides administrative and accounting support to the Trust, and is a related party to the Trust. There were no administrative and accounting fees paid to Alliant for the years ended December 31, 2024 and 2023.

NOTE 4 - TAX STATUS

The Trust is designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code for a grantor trust and, therefore, the Trust itself is considered qualified and not subject to income tax. Additionally, the Trust is not subject to unrelated business income tax.

U.S. GAAP requires the Trust's management to evaluate tax positions taken by the Trust and recognize a tax liability if the Trust has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Trust is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Interest and penalties, if incurred, would be included in administrative expenses. The Trust administrator believes that the Trust is no longer subject to income tax examinations for years prior to 2021.

NOTE 5 - TERMINATION OF THE TRUST

Although the trustees have not expressed any intention to do so, the Trust may be terminated by notice in writing executed by the trustees. In the event of termination of the Trust, the trustees shall apply available assets to pay any and all obligations and expenses of the Trust and participating employer plans. Notwithstanding any other provision herein or in any participating employer plan to the contrary, upon satisfaction of all liabilities of the Trust and participating employer plans, any remaining assets of the Trust may be paid to, or applied for the benefit of, participating employers as the trustees in the exercise of their sole discretion; such surplus need not be applied for the exclusive benefit of employees (or beneficiaries of employees) of participating employer plans. Upon termination of the Trust, the trustees shall immediately notify each participating employer and the insurance companies of the policy or policies and shall continue as trustees for the purpose of dissolution. They may take any action with regard to any policy or policies that may be appropriate or required by the insurance carrier of such policy or policies.

NOTE 6 - FAIR VALUE MEASUREMENT

The Trust discloses the category of assets and liabilities measured at fair value into one of three different levels, depending on the assumptions (i.e., inputs) used in the valuation. Level 1 provides the most reliable measure of fair value, whereas Level 3 generally requires significant management judgment. Financial assets and liabilities are classified in their entirety based on the lowest level of input significant to the fair value measurement. The fair value hierarchy is defined as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Trust has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the valuation methodology used at December 31, 2024 and 2023.

The Trust has the following assets and liabilities whose carrying amounts on its statements of net assets available for benefits at December 31, 2024 and 2023 approximate fair value due to their short-term nature: cash, accounts receivable, accounts payable and deferred premiums received.

The Trust did not have any assets or liabilities categorized as Level 2 or Level 3 at December 31, 2024 and 2023.
