## INDEPENDENT AUDITOR'S REPORT

To the Administrator and Participants of the  
Claims Recovery Financial Services 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Claims Recovery Financial Services 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

#### NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Claims Recovery Financial Services 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan with salary reduction features as permitted under §401(k) of the Internal Revenue Code (IRC). The Plan covers all eligible employees of Claims Recovery Financial Services, LLC (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Eligibility:** Employees who have attained age 21 and have completed thirty days of service are eligible to participate in the Plan. Collectively bargained employees, non-resident aliens, and leased employees are excluded from the Plan. Participants are eligible for discretionary employer contributions after completing one year of service.

**Contributions:** Each year, participants may contribute up to 100% of pre-tax annual compensation up to the maximum limit allowed by Internal Revenue Service (IRS) regulations. The Plan also allows for Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (Rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

Prior to March 17, 2023, the Company contributed 100% of the first 3% of base compensation that a participant contributed to the Plan, plus 50% of the amount the participant contributed to the Plan that exceeds 3% of their base compensation but does not exceed 5% of their base compensation (Safe Harbor Matching Contribution). Effective March 17, 2023, the Plan was amended to remove the employer Safe Harbor Matching Contribution and change the type of plan from a Safe Harbor 401(k) Plan to a Profit Sharing and 401(k) Plan. Also effective as of that date, any existing employer Safe Harbor Matching Contributions were 100% immediately vested and could continue to be withdrawn upon attaining age 59 ½ for an in-service withdrawal.

Additional profit-sharing amounts may be contributed at the discretion of the Company's Board of Directors. There were no employer profit-sharing contributions for the years ended December 31, 2024 and 2023. Contributions are subject to certain IRS limitations.

**Participant Accounts:** Each participant's account is credited with the participant's contributions, Company contributions and Plan earnings (losses), and charged with withdrawals and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's profit-sharing contribution portion of their account is based on a six-year graded schedule utilizing years of continuous service. A participant becomes fully vested after six years of credited service.

**Notes Receivable from Participants:** Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the excess of the highest outstanding loan balance in the previous 12 months over the loan balance on the date of the new loan, or 50% of their vested account balance. The loans must be repaid within five years unless the loan is used to purchase a principal residence and are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through payroll deductions.

#### NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

**Payment of Benefits:** Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount or installment payments equal to the value of the participant's vested interest in his or her account. The normal retirement date is the date upon which a participant reaches age 65. Also, partial withdrawals of a participant's vested balance may be distributed prior to termination of employment for hardship or attainment of age 59 ½, as defined by the Plan document.

**Forfeitures:** Forfeitures of non-vested Company contributions are used to pay Plan expenses and then to reduce employer and/or matching contributions. During the year ended December 31, 2024, the Company used \$68 of forfeitures to reduce employer safe harbor matching contributions owed from the 2023 Plan year. No forfeitures were used during the year ended December 31, 2023. As of December 31, 2024 and 2023, unallocated forfeitures amounted to \$355 and \$140, respectively.

#### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting:** The Plan prepares its financial statements on the accrual basis of accounting.

**Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition:** Investments are reported at fair value (except for fully benefit responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the investment consultants and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits:** Benefits are recorded when paid.

**Administrative Expenses:** Administrative expenses can be paid by the Plan or the Company. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent Events:** These financial statements have not been updated for subsequent events occurring after July 10, 2025, which is the date these financial statements were available to be issued.

#### NOTE 3. FAIR VALUE MEASUREMENTS

Financial Accounting Standard Board (FASB) *Accounting Standards Codification (ASC) 820: Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities that the Plan has the ability to access.

- Level 2: Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Pooled Separate Accounts:** The separate accounts are stated at fair value based on the quoted market prices of the underlying mutual funds. The unit value of the separate accounts is calculated by dividing the total value of the assets of the separate account by the number of units in the separate account. Net asset value (NAV) is used as a practical expedient for estimating fair value.

**Registered Investment Companies:** Valued using the NAV provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market.

#### NOTE 4. GUARANTEED INTEREST ACCOUNT

The Plan is invested in a fully benefit responsive guaranteed investment contract with Massachusetts Mutual Life Insurance Company (MassMutual). MassMutual maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3%. The crediting rate is reviewed on a semi-annual basis for resetting. The guaranteed interest contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value, as reported to the Plan by MassMutual, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to a participant termination of employment due to: (1) removal of a group of participants from plan coverage as a result of temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; or (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the plan sponsor's business. Such events also include: (1) removal from the plan of one or more groups or classifications of participants; (2) partial or complete plan termination; or (3) plan disqualification. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with Plan participants, is probable.

#### NOTE 5. FINANCIAL CERTIFICATION

The following financial information regarding the Plan's assets at December 31, 2024 and 2023, as well as income and transactions for the years then ended, has been derived from information provided by Empower Life and Annuity Insurance Company of New York on behalf of Massachusetts Mutual Life Insurance Company and Empower Trust Company, LLC (collectively, "Empower"), the custodian of the Plan, and has been certified by them as complete and accurate. The incorporation of this financial information in the accompanying financial statements is based solely on their certifications and has not been audited by independent accountants.

#### NOTE 6. PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments are maintained in funds managed by Empower. Empower is the custodian for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Administrative expenses paid by the Plan to the custodian amounted to \$34,133 for the year ended December 31, 2024 (\$43,477 - 2023).

#### NOTE 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in employer contributions.

#### NOTE 8. TAX STATUS

The Plan has adopted a non-standardized pre-approved profit-sharing plan sponsored by PPS Pension & Financial Services Inc. The pre-approved plan has received an opinion letter dated June 7, 2021 from the IRS. In the opinion letter, the IRS stated that the pre-approved plan is in compliance with the applicable requirements of the IRC. The pre-approved plan's opinion letter has been relied upon by this Plan. The Plan has been amended since the pre-approved plan received the opinion letter. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE 9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
