### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Wyoming Seminary Defined Contribution Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

**1. Description of the Plan**

The following description of the Wyoming Seminary Defined Contribution Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan that operates under Section 403(b) of the Internal Revenue Code ("IRC") covering substantially all employees of Wyoming Seminary College Preparatory School ("Seminary") except for employees whose elective deferral is less than \$200 per year, employees who normally work fewer than ten hours per week and less than 500 hours per year, those eligible under another Section 403(b), 401(k) or 457 eligible governmental plans of Seminary, non-resident aliens and students. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan Administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Contributions**

Each year, participants may elect to contribute any amount of their eligible compensation (with a minimum of 1%), up to the maximum limits defined by the IRC. Participants who have attained the age of 50 before the close of the plan year were eligible to make an additional catch-up contribution up to \$7,500 and \$7,500 in 2024 and 2023, respectively. Participants who have completed 15 years of service may make additional contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their accounts into various investment options offered by the Plan.

Seminary provides a discretionary matching contribution of the participant's compensation for participants who are age 21, have completed one year of service and contribute at least 1% of their eligible compensation during the plan year. During 2024, Seminary's match was 5%. During 2023, Seminary's match was 5%. Contributions are subject to certain IRS limitations.

**Participant accounts**

A separate account is maintained for each participant. Each participant's account is credited with the participant's contributions, including rollovers, and Seminary's matching contributions and Plan earnings, including interest and dividends and net realized and unrealized appreciation (depreciation) in fair value of investments. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and Plan losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are fully vested in their contributions, as well as any matching contributions by Seminary plus actual earnings thereon at all times.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The notes are secured by the

balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably directly by the participant to the Teachers Insurance and Annuity Association and College Retirement Equities Fund ("TIAA-CREF"). In addition, as discussed in Note 9, there are loans outside of the Plan issued by TIAA-CREF.

**Payment of benefits**

On termination of service, death, disability, retirement or the attainment of age 59½, a participant is eligible to receive a distribution of their account balance. The normal form of benefit payment is a qualified joint and survivor annuity for married participants and a life annuity for unmarried participants. Participants can also elect a lump sum distribution. Hardship withdrawals are also permitted by the Plan.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by Seminary. Certain expenses of maintaining the Plan are paid directly by Seminary and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**SECURE 2.0 Act**

President Biden signed the Consolidated Appropriations Act (CAA), including the SECURE 2.0 Act, into law on December 29, 2022. SECURE 2.0 builds on changes made by the SECURE Act of 2019 and the Plan document has been amended for the provisions required to be effective in 2024 and will be amended in accordance with the required timeline of the act to meet the applicable provisions effective after December 31, 2024.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the

investment advisers, custodians and insurance company. See Note 5 for a discussion of fair value measurements. Pooled separate accounts are valued based upon the unit values of such pooled accounts held by the Plan at year end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold during the year.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participants' account and are recorded as administrative expenses and are expensed when they are incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Administration of Plan Assets**

The Plan's assets are administered under a contract with TIAA-CREF, the custodian of the Plan. TIAA-CREF invests funds received from contributions, investment sales, interest, and dividend income and makes distribution payments to participants. Administrative expenses of maintaining the Plan are paid by Seminary and are excluded from these financial statements. Expenses of \$38,541 and \$33,947 were paid by the Plan in 2024 and 2023, respectively.

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by Seminary. Expenses that are paid by Seminary are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses

**Payment of Benefits**

Benefits are recorded when paid.

**Subsequent Events**

The Plan has evaluated subsequent events for recognition or disclosure through May 12, 2025, the date the financial statements were available to be issued.

**4. Traditional Annuity Contract with Insurance Company**

The Plan offers the option to invest in the TIAA Traditional Annuity Account, a guaranteed fixed annuity contract with TIAA-CREF. The TIAA Traditional Annuity Account is a contractual obligation to repay the principal and a specified interest rate that is guaranteed to the Plan.

Contributions are maintained in a general account which is credited with earnings based on the guaranteed rate of return.

Plan participants enter into these contractual agreements with TIAA-CREF by selecting a TIAA Traditional Annuity Account. Participants of the Plan may invest in one of the following traditional accounts: Retirement Annuity ("RA") or Supplemental Retirement Annuity ("SRA"), which have varying withdrawal options and distributions.

The SRA is a fully-benefit responsive guaranteed contract. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by TIAA-CREF, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The RA is a non-benefit responsive guaranteed contract and is valued based upon TIAA-CREF's quoted redemption value of the contract owned by the Plan participant at year end.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon by the issuer, which will not be less than zero percent. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes under ERISA, or (5) premature termination of the contract. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with the Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The TIAA Traditional Annuity Accounts are single group annuity contracts with a fixed rate of interest. Interest is credited to the accounts and accumulations include a guaranteed rate, plus discretionary additional amounts determined annually by the TIAA-CREF Board of Trustees. The additional amounts, when declared, remain in effect through the "declaration year," which begins each March 1. The guaranteed annual interest rate is a minimum of 3% for all premiums remitted since 2002 under all TIAA Traditional Annuity accumulating contracts. They are not a portfolio of contracts whose yields are based on changes in fair value of underlying assets, therefore the average yield earned by the Plan is the interest earned on the group annuity contracts. The TIAA Traditional Annuity Account does not permit TIAA-CREF to terminate the agreement prior to the scheduled maturity date.

**5. Fair Value and Contract Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Gains and losses included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation in fair value of investments.

The Plan's policy is to recognize transfers of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers into or out of Level 3. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

The guaranteed annuity contract consists of the TIAA Traditional Annuity Account ("TIAA Account"). The TIAA Account is reported at contract value based on TIAA-CREF's ability to pay the guaranteed claims in accordance with the terms of the contract. As of December 31, 2024 and 2023, TIAA-CREF's credit ratings were as follows: A++ by A.M. Best Company, AAA by Fitch Ratings, Aa1 by Moody's Investors Service, and AA+ by Standard & Poor's. The high credit ratings of TIAA-CREF as of the measurements date uphold the TIAA Account's ability to meet obligations set forth in the contracts.

Contract value is the aggregation of contributions, plus interest, less withdrawals, if any. Crediting rates are a combination of a guaranteed rate and an annually established discretionary rate.

Additionally, the discretionary rate applied to contributions received during a reporting period may vary from the discretionary rate applied to account balances at the end of the prior reporting period. Contract value approximates a discounted cash flow value calculated using an appropriate risk-adjusted market discount rate which correlates closely with TIAA Account's historical crediting rates.

The TIAA Account has redemption restrictions (see Note 4 for a discussion of restrictions) based on the terms of the underlying contract and is an unfunded commitment as claims against the contract are solely supported by TIAA-CREF's ability to pay on such claims.

The redemption restrictions do not have a material impact on the contract value of the TIAA Account.

**6. Plan Termination**

Although it has not expressed any intent to do so, Seminary has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**7. Tax Status**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The plan administrator and the plan's tax counsel believe that the terms of the Plan have been prepared to conform with the written plan requirements of Section 403(b) of the IRC, and is currently being operated in conformity with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. Information Certified by Custodian**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Teachers Insurance and Annuity Association and College Retirement Equities Fund ("TIAA-CREF") (the custodian of the Plan).

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by TIAA-CREF.

**9. Related Party and Party in Interest Transactions**

The Plan's assets are administered under contract with TIAA-CREF. Transactions with TIAA-CREF qualify as party in interest transactions.

Administrative expenses of the Plan are paid by Seminary. Certain administrative functions of the Plan are performed by officers or employees of Seminary. No such officer or employee receives compensation from the Plan.

TIAA-CREF issues loans to plan participants which are secured by the participant's account balance, but are contractual agreements between the custodian and the plan participant and are funded from TIAA-CREF's general fund. A participant is required to transfer 110% of the loan value to the TIAA Traditional Annuity Account upon the issuance of the loan and is restricted from transfers or withdrawals. The restricted account balance is used as collateral on the loan balance in accordance with the terms of the note. The loans are to be repaid over no more than 5 years, unless for a principal residence and the interest rates range from 4.22% to 4.36% at December 31, 2024 and 2023. Those transactions qualify as party-in-interest transactions.

Participant account balances which were held in the TIAA Traditional Annuity Account to collateralize these loans totaled \$7,928 at December 31, 2024 and \$7,518 at December 31, 2023.

These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

**10. Risks and Uncertainties**

The Plan invests in various investment securities. The Plan's investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
