Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Atlantic Corporation of Wilmington, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Atlantic Corporation of Wilmington, Inc. 401(k) Profit Sharing Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. 1. Description of Plan

The following description of Atlantic Corporation of Wilmington, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information for the Plan sponsored by Atlantic Corporation of Wilmington, Inc. (the "Company"). Participants in the Plan should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan became effective on October 1, 1986 as a defined contribution plan. The Plan covers all full-time employees of the Company who are at least 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Assets of the Plan are held by the plan trustee selected by the plan sponsor. The Company acts as plan sponsor.

Contributions

Each year, participants may elect to defer a percentage of their annual compensation, which is treated as a pre-tax employee contribution. Employees may also elect to make Roth (after-tax) contributions to the Plan. The sum of Roth and regular pre-tax contributions may not exceed the annual limit set by the Internal Revenue Service ("IRS"). Employees are automatically enrolled with a 6% pre-tax deferral election, unless they elect to opt-out or select a different deferral election. Changes to deferral elections can be made at any time, but become effective at the biannual change date of January 1 or July 1. Participants can elect to stop deferrals at any time, effective immediately. The Plan also includes an auto-escalation provision in which participants are subject to an annual automatic deferral rate increase of 1% until their deferral rate reaches 10%. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan permits rollover contributions from other qualifying retirement plans as well as in-plan Roth rollovers from all or any portion of a participant's vested account.

The Company has a discretionary match, in an amount not to exceed 6% of compensation. During 2024, the Company matched 30% of the first 6% of compensation contributed to the Plan. Participants are eligible for the discretionary match effective January 1 or July 1 once they've completed one year of service. Additionally, the Company may make a discretionary profit sharing contribution. The discretionary profit sharing contribution equaled \$4,500,000 for the year ended December 31, 2024. Participants are eligible to receive an allocation of the Company's discretionary profit sharing contribution if they are an active participant at the end of the plan year and have 1,000 or more hours of service in the plan year. Participants will also be eligible if they were an active participant at any time during the plan year and died or quit working for the Company because normal retirement age was reached, or became totally disabled, during the plan year.

Participants' Accounts

Employee contributions, employer contributions, and rollover contributions activity are maintained separately in each participant's account. Participants direct the investment of their account balances into various investment options offered by the Plan. Participants may change their investments daily. Each participant's account is credited with the participant's contribution, the Company's contribution, and an allocation of plan earnings and administrative expenses. Allocations are based on participants' compensation or account balances, as defined. A participant is entitled to the benefit that can be provided from the participant's vested account.

1. Description of Plan (Continued)

Vesting

Participants are immediately 100% vested in the salary reduction amount contributed to the Plan and the Company's matching contribution. Vesting in the Company's discretionary profit sharing contribution portion of their accounts is based on the years of continuous service. Participants are fully vested after completing six years of service.

Forfeited Accounts

At December 31, 2024, forfeited non-vested accounts totaled \$110,293. Forfeited accounts may be used to pay Plan expenses, to reduce employer contributions or allocated to participants, as permitted by the Plan's provisions.

Payment of Benefits

Generally, a participant becomes eligible to receive benefits on their normal retirement age (65), death, disability, termination of employment, or reasons of proven financial hardship. Benefits are payable in lump-sum payments. Effective October 1, 2023, participants are also eligible to take in-service withdrawals once they attain age 59 ½.

Hardship Withdrawals

Upon approval by the plan administrator, a participant may withdraw all or part of their vested contributions for immediate and severe financial need. In accordance with IRS regulations, the participant must exhaust all other assets available prior to obtaining the hardship withdrawal.

Notes Receivable from Participants

Participants may borrow from their fund a minimum of \$1,000 up to a maximum equal to 50% of their vested account balance or \$50,000 reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made. A participant can have two loans outstanding at a time. The loans are secured by the balance in the participants' accounts and bear interest at a fixed rate based on prime plus 1% (9.50% at December 31, 2024) as of the date of the new loan. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants at December 31, 2024 and 2023 were \$3,548,870 and \$3,350,228, respectively.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

2. Significant Accounting Policies (Continued)

Cash and Cash Equivalents

The Plan considers all invested cash balances to be cash equivalents.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

Investment Valuation and Income Recognition

Investments are comprised of mutual funds, self-directed brokerage accounts, pooled separate accounts, collective investment trust funds, and guaranteed investment contracts. Pooled separate accounts are valued using the Net Asset Value (“NAV”) provided by the administrator of the fund, based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. Collective investment trust funds are valued using NAV based on the cost-plus credited interest, less expenses, subject to market value adjustment for early termination. The Plan’s mutual funds and self-directed brokerage accounts are stated at fair value. The fully benefit-responsive investment contracts are valued at contract value (see Note 8). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized and unrealized appreciation and depreciation in value of investments are allocated to the participant accounts based on participant holdings in each fund.

Plan Expenses

Certain plan expenses are paid by the plan sponsor as provided by the plan document. Expenses related to specific participant transactions (notes receivable from participants and distributions) are charged directly to the participant’s account.

3. Federal Income Taxes

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing plan document. This document received an opinion letter dated June 30, 2020, in which the IRS stated that the document was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). As allowed by the IRS, the Plan is relying on the opinion letter issued on the plan document for its own qualification. The plan document has been amended for changes required by the IRS since receiving the opinion letter. Plan management believes the Plan is currently designed and operating in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan’s financial statements.

3. Federal Income Taxes (Continued)

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would be sustained upon examination by the applicable authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

5. Investments

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the accompanying financial statements and supplemental schedule was obtained or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company ("Principal"), the trustee of the Plan, and was not subject to audit for the years ended December 31:

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 Inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.

Level 2 Inputs are based on significant other observable inputs such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs are unobservable and significant to the fair value measurement.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The Plan uses Level 2 inputs when market prices are not attainable but other observable inputs are available to arrive at a fair value, and Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There were no Level 2 investments in the Plan.

Level 1 Fair Value Measurements

The fair value of mutual funds, pooled separate accounts, and self-directed brokerage accounts is based on quoted net asset values of the shares held by the Plan at year end.

Level 3 Fair Value Measurements

The guaranteed investment contract is not actively traded and significant other observable inputs are not available. Thus, the fair value of the guaranteed investment contract is determined by the amount plan participants or plan sponsors would receive currently if they were to withdraw or transfer funds within the Plan prior to their maturity. The guaranteed investment contract is calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

7. Collective Investment Trust Funds

The Plan invests in various collective investment trust funds (“CITs”) maintained and administered by Principal, Ameriprise Trust Company, Fidelity Management Trust Company, Northern Trust and Great Gray Trust Company, LLC. The CITs’ interest in affiliated collective trusts and separate accounts may be redeemed as of any valuation date. The unit value of each of these CITs is determined on a daily basis. Unit purchases and redemptions are transacted at the NAV per fee class of the funds determined as of the close of business each day. Investment income earned is reinvested in each fund and included in the determination of unit values. There were no unfunded commitments.

8. Fully Benefit-Responsive Investment Contracts

The Plan has traditional, fully benefit-responsive guaranteed investment contracts with Principal Life Insurance Company and Lincoln National Life Insurance Company that are reported at contract value. Principal Life Insurance Company and Lincoln National Life Insurance Company maintain the contributions in a general account. The account is credited with contributions and earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than the guaranteed minimum interest rate. Such interest rates are reviewed on a semi-annual basis for resetting. The contract cannot be terminated before the scheduled maturity date. The Plan's ability to receive amounts due in accordance with a fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code (IRC) or the failure of the trust to be tax-exempt under Section 501(a) of the IRC
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.

9. Party-in-Interest Transactions

Plan investments are managed by Principal. Principal is the trustee as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Principal and other parties-in-interest for contract administration, advisory and professional services amounted to \$296,673 for the year ended December 31, 2024. The Plan also holds notes receivable from participants. As a result, these notes receivable and all related transactions were with a party-in-interest. All of these transactions are exempt from being prohibited transactions by ERISA.

10. Risks and Uncertainties

The Plan invests in various investment securities as directed by its participants. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

11. Prohibited Transactions

During 2023, the Company failed to deposit \$45 of participant deferrals within the required timeframe as stated by the United States Department of Labor ("DOL"). The DOL considers late deposits to be a prohibited transaction. The Company calculated and remitted the lost earnings during 2024 and filed the Form 5330 to pay applicable excise taxes. The excise tax payments were made from the plan sponsor's assets and not from assets of the Plan.

12. Subsequent Events

The Company has evaluated events and transactions for potential recognition or disclosure in the financial statements through July 23, 2025, which is the date the financial statements were available to be issued.

In December 2022, Congress passed the Setting Every Community Up for Retirement Enhancement Act of 2022 ("SECURE Act 2.0") that continued the retirement system reform previously passed in 2020. Provisions of the SECURE Act 2.0 are effective at various dates through 2026, with the plan amendment for the adoption of SECURE Act 2.0 due by December 31, 2026.
