## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Davis & Elkins Defined Contribution Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Davis & Elkins Defined Contribution Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

#### Note 1 – Plan Description

---

The following description of the Davis & Elkins Defined Contribution Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

##### *General*

The Plan is a defined contribution plan covering all full-time employees of Davis and Elkins College (the “College”) and part-time employees who work in excess of 1,000 hours per year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### *Contributions*

Each year participants may contribute a portion of their annual compensation as a pre-tax deferral as defined in the Plan, up to the maximum allowed by the *Internal Revenue Code (IRC)*. Participants may also contribute amounts representing distributions from other qualified plans. The College contributes 2.5% of compensation during a participant’s first five years of service, after which they receive 5% of compensation. Contributions are subject to certain limitations. Participants direct the investment of contributions into various investment options offered by the Plan.

##### *Participant Accounts*

Each participant’s account is credited with the participant’s contribution, the College’s contribution, and an allocation of Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

##### *Vesting*

Participants are immediately vested in their contributions and the College’s contributions plus actual earnings thereon.

##### *Payments of Benefits*

Upon termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum distribution, partial payments, installment payments, or annuity payments equal to the value of the participant’s vested interest in his or her account.

##### *Notes from Participants*

Participants may borrow from their account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant’s vested balance. Note terms range from one year to five years unless the note is for the purchase of a primary residence, in which case the term may exceed five years.

Notes are secured by the balance in the participant’s account and bear interest at market rates as determined by the Plan Administrator. At December 31, 2024, interest rates ranged from 4.25% to 9.50%. Principal and interest are paid ratably in accordance with the loan policy.

**Note 2 – Significant Accounting Policies**

---

*Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

*Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Valuation of Investments and Income Recognition*

The Plan's investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

*Notes from Participants*

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

*Benefit Payments*

Benefit payments are recorded when paid.

*Administrative Expenses*

Substantially all Plan fees and administrative expenses are paid by the Plan and some are netted with investment income. Administrative fees paid by the Plan during 2024 were \$27,572.

**Note 3 – Fair Value Measurements**

---

The Plan’s mutual funds, pooled separate account, and non-benefit-responsive traditional annuity investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 and Level 2 inputs were not available.

*Level 3 Fair Value Measurements*

The non-benefit-responsive TIAA Traditional Annuity is valued at fair value which equals the accumulated cash contributions and interest credited to the Plan’s contracts less any withdrawals. The significant unobservable inputs used in the fair value measurement of the Plan’s Level 3 investments include interest rates and the terms of individual underlying annuity contracts. Significant changes to the terms of these contracts or interest rates could have resulted in a significantly higher or lower fair value measurement for these investments. The following table provides further detail of Level 3 investments.

**Note 4 – Investment Contract with Insurance Company**

*Non-Benefit-Responsive*

Participants may choose to invest in a TIAA Traditional Annuity account that is not a fully benefit-responsive traditional investment contract. This contract pays a guaranteed rate of interest plus additional amounts that are not guaranteed but may be established on a year-by-year basis. These additional amounts, when declared, remain in effect through the end of the “declaration year,” which begins each March 1. Contributions to a participant’s account provide a guaranteed amount of lifetime annuity income. The guaranteed minimum interest rate is generally 3.00%. The interest rate ranged from 4.75% to 6.00% for the year ended December 31, 2024.

*Fully Benefit-Responsive*

Participants may also invest in fully benefit-responsive contracts: the TIAA Traditional Annuity account, a traditional investment contract, and the TIAA Stable Value account, a fixed-rate group annuity contract. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments in these contracts at contract value.

The TIAA Traditional Annuity contract maintains the participants’ contributions plus a specified rate of interest and is guaranteed by TIAA’s claims paying ability. Contributions to a participant’s account provide a guaranteed amount of lifetime annuity income. The guaranteed minimum interest rate is generally 3.00%. The expected rate of return ranged from 3.25% to 6.00% for the year ended December 31, 2024.

The TIAA Stable Value contract maintains the participants’ contributions plus a specified rate of interest and is guaranteed by TIAA’s claims paying ability. Contributions to a participant’s account provide a contractual or guaranteed amount of future benefits for the participant. This contract pays a guaranteed rate of interest and has the potential for crediting of additional amounts above the guaranteed minimum. These additional amounts, when declared, remain in effect from January 1 through June 30 and from July 1 through December 31 and are not guaranteed for future periods. The guaranteed minimum interest rate is between 1.00% and 3.00%.

The Plan’s ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- The Plan’s failure to qualify under Section 401(a) of the *Internal Revenue Code* or the failure of the trust to be tax-exempt under Section 501(a) of the *Internal Revenue Code*
- Premature termination of the contracts
- Plan termination or merger
- Changes to the Plan’s prohibition on competing investment options
- Other Plan Sponsor events that significantly affect the Plan’s normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan’s investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer.

When a participant’s account in the non-benefit-responsive and fully benefit-responsive TIAA Traditional Annuity is annuitized based on available options, the present value of the stream of payments is equal to the account balance. This annuitization is accounted for as an annuity settlement option, a type of distribution from the Plan used to purchase individual annuity contracts. The subsequent stream of annuity payments from the individual contract occurs outside of the Plan and does not represent an obligation of the Plan.

TIAA issues various types of contracts as funding vehicles for retirement plans. Certain contract types contain liquidity restrictions on the redemption of TIAA Traditional Annuity accumulations, which could impact the value realized upon exiting the contract.

Certain administrative functions are performed by officers or employees of the College. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Although they have not expressed any intent to do so, the College has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### Note 7 – Tax Status

---

The Plan is an adoption of a prototype plan sponsored by TIAA-CREF. The Plan is designed in accordance with applicable sections of the *IRC*. The Plan has been amended; however, the Plan Sponsor and Administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
