Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Specialty Restaurants Corporation 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 24, 2024, and December 31, 2023, and the related statement of changes in net assets available for benefits for the period ended September 24, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to Section 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with Section 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of September 24, 2024, and December 31, 2023, and for the period ended September 24, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

As discussed in Note 1 to the financial statements, the Plan sponsor elected to terminate the Plan effective September 24, 2024, and transfer the assets to a Pooled Employer Plan (PEP). As the intention of the Plan Sponsor is not to cease operations but continue to provide retirement benefits, the financial statements are presented on a going-concern basis. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

NOTE 1. DESCRIPTION OF PLAN

The following description of the Specialty Restaurants Corporation 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan, which was adopted by a resolution of the Board of Directors of Specialty Restaurants Corporation (the Company or Plan Sponsor) effective August 1, 1996 and is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code (IRC) of 1986, as amended. The Plan allows eligible employees the opportunity to participate in the salary deferral components of the Plan.

In 2024, the Plan Sponsor elected to participate in a pooled employer plan (PEP). The PEP is a defined contribution plan in which multiple employers can participate. All assets of the Plan were transferred to the PEP on September 24, 2024, and the Plan was terminated. As of September 24, 2024, there was no account balances remaining in the Plan.

Eligibility: Eligibility for participation in the Plan requires that all participants must have attained 21 years of age and have completed one (1) year of service.

All employees, except those covered by a collective bargaining agreement and nonresident aliens, are eligible to participate in the Plan. Special Events employees who are not managers or salespeople, as determined by the Plan Sponsor, are excluded from eligibility in the Plan.

Contributions: Participants may contribute up to 50% of pre-tax annual compensation, as defined by the Plan. The contribution is subject to a maximum of \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of \$7,500 for 2024.

Effective January 1, 2023, the Plan adopted a Safe Harbor Matching Contribution provision in which the Plan Sponsor matches 100% on participant salary deferrals up to 3% of eligible compensation plus 50% of salary deferrals between 3% and 5% of eligible compensation. Safe Harbor Matching Contributions are immediately 100% vested.

Additionally, the Plan Sponsor may, at its discretion, make a Flexible Discretionary Matching (FDM) contribution equal to a percentage of participant contributions.

Effective February 1, 2024, the Plan was amended to exclude Safe Harbor Matching Contribution provisions.

Investment Elections: Each participant directs the investment of contributions in one or more of the available investment options.

Participant Accounts: Each participant's account is credited or charged with the participant's contribution, the Plan Sponsor's contribution, allocation of earnings or losses from the participant's self-directed investments, and an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contribution and safe harbor matching contribution plus actual earnings thereon. Vesting in the Plan Sponsor's matching portion of their account plus actual earnings thereon is based on years of continuous service. Participants vest 20% per year of service and are 100% vested after five (5) years of credited service. Safe Harbor Matching Contributions are immediately 100% vested.

NOTE 1. DESCRIPTION OF PLAN (Continued)

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested account balance. The loans are secured by the vested balance in the participant's account, and bear interest at the prime rate of interest plus 2%. Principal and interest are paid ratably through payroll deductions. The term of loans shall not exceed five (5) years, except for loans used to purchase the participant's principal residence where the term cannot exceed thirty (30) years.

Benefit Payments and Withdrawals: Participants who terminate their employment with the Company for reasons other than death, disability or retirement shall receive the vested portion of the Plan Sponsor's contribution portion of their accounts. In addition, participants shall receive their total elective salary deferral account balance, which are fully vested and non-forfeitable at all times.

Upon incurring a disability, retirement, or death, the participant's shares in the Plan would become fully vested and distributed to the participant or beneficiary. Upon termination of service, a participant, in general, will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Forfeitures: Forfeitures of the Plan Sponsor's contributions may be used to reduce future Plan Sponsor contributions. During the period ended September 24, 2024, forfeitures used to reduce Plan Sponsor matching contributions and pay Plan expenses were \$125. As of September 24, 2024, there were no forfeitures available.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements of the Plan have been prepared under the accrual method of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for Plan benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value, except for the benefit responsive investment contract, which is valued at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 11 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net realized and unrealized appreciation in fair value of investments consists of the change in unrealized appreciation during the year, and the realized gain or loss on the sale of investments during the year. Acquisition costs are included in the cost of investments, and sales are recorded in net of selling expenses.

Investment contracts held by a defined contribution plan are reported at contract value. Contract value represents contributions made under the contracts, plus earnings, less participant withdrawals, and administrative expenses. For fully benefit-responsive investment contracts, participants would receive contract value for all permitted transactions under the terms of the Plan.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Contributions: Employee contributions are recorded in the period in which they are withheld.

Payment of Benefits: Benefits are recorded when paid.

Notes Receivable from Participants: Prior to termination, notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Administrative Expenses: The majority of administrative expenses incurred by the Plan are paid by the Plan Sponsor. Expenses directly attributable to a particular participant are allocated to and paid from that participant's account.

Subsequent Events: The Plan has evaluated subsequent events through July 29, 2025, the date the financial statements were available to be issued and has determined that no events or transactions require recognition or disclosure in these financial statements.

NOTE 3. RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility. The Plan's exposure to credit loss in the event of nonperformance of investments is limited to the carrying value of such investments. The Plan's provisions as well as those of ERISA and the participants' investment preferences dictate the Plan's concentrations of credit risk and market risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

NOTE 4. PLAN TERMINATION

In 2024, the Plan Sponsor elected to participate in a pooled employer plan (PEP). The PEP is a defined contribution plan in which multiple employers can participate. All assets of the Plan were transferred to the PEP on September 24, 2024, and the Plan was terminated.

NOTE 5. FEDERAL INCOME TAXES

The Plan may rely on the opinion letter issued by Internal Revenue Service (IRS) to the volume Submitter Sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable section of the IRC. Although the Plan has been amended since receiving the letter, the Plan Administrator believes that the Plan was designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan's policy is to recognize tax positions in the financial statements when it is more-likely-than-not the position will be sustained upon examination by the tax authorities. As of September 24, 2024, the Plan management has determined that the Plan had no uncertain tax positions qualify for either recognition or disclosure in the financial statements. As of September 24, 2024, the Plan's annual tax filings for the prior three (3) years are open for audit by the IRS.

NOTE 6. CERTIFIED INFORMATION

The Plan's investment assets as of September 24, 2024 and December 31, 2023, and for the period ended September 24, 2024, included throughout the Plan's financial statements, obtained by management, and agreed to or derived from information certified by Reliance Trust Company, the Plan's trustee through June 24, 2024, and from Transamerica Trust Company, the Plan's trustee through September 24, 2024. The Plan Administrator has obtained certifications from the trustees that information provided to the Plan Administrator related to the investment assets is complete and accurate. Accordingly, as permitted by Section 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements.

NOTE 7. PARTY-IN-INTEREST TRANSACTIONS

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. These transactions qualify as party-in-interest transactions. Transamerica is both a third-party administrator and custodian. Reliance Trust Company was the Plan's trustee through June 24, 2024 and Transamerica Trust Company was the Plan's trustee through September 24, 2024.

NOTE 8. ADMINISTRATION OF PLAN ASSETS

The Plan's assets are held by Transamerica, the custodian of the Plan. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan.

NOTE 9. REFUND OF EXCESS CONTRIBUTIONS

Amounts payable to participants for contributions in excess of amounts allowed by the IRS or other ineligible contributions are recorded as liabilities in the accompanying statements of net assets available for benefits with a corresponding deduction to Plan assets on the accompanying statement of changes in net assets available for benefits for the period ended September 24, 2024.

NOTE 11. FAIR VALUE MEASUREMENTS

Fair Value: Prior to termination, the Plan accounts for its financial instruments using a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value measurement hierarchy is based on three (3) levels of inputs, of which the first two (2) are considered observable and the last unobservable. The three (3) levels of the fair value hierarchy are the following:

Level 1: Inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in markets that are inactive; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3: Inputs to the valuation that are unobservable and significant to the fair value measurement.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

As of December 31, 2023, mutual funds are valued based on quoted market price. The Plan's investments, consisting primarily of mutual funds, are classified as Level 1 in the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 12. INVESTMENT CONTRACT WITH TRANSAMERICA FINANCIAL LIFE INSURANCE COMPANY

In 2010, the Plan entered into a fully benefit-responsive investment contract with Transamerica. Transamerica maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value, which equals fair value, as reported to the Plan by Transamerica. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value with no conditions, limits, or restrictions.

There are no reserves against contract value for credit risk of Transamerica. Since the contract value equals fair value, the average yield earned by the Plan is equal to the crediting interest rates. The crediting interest rate was 1.50% from January 1, 2024 through June 30, 2024 and 1.65% from July 1, 2024 through September 24, 2024. Since the investment contract is not guaranteed, there is no stated minimum or maximum interest rate. Interest is credited, based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for each month. Such interest rates are reviewed on a semi-monthly basis for resetting.

NOTE 13. SAFE HARBOR MATCHING CONTRIBUTIONS

In connection with the annual required nondiscrimination and other compliance testing, the Safe Harbor matching calculation for the year ended December 31, 2023 was initially calculated based on inaccurate compensation amounts and subsequently went through several iterations of testing. The revised final testing was completed in September 2024 and resulted in nominal differences versus Safe Harbor contributions made to the Plan during the period ended September 24, 2024.

NOTE 14. OPERATIONAL DEFECT

As of the report date, the Plan is in process of but has not completed the required nondiscrimination and other compliance testing for the period ended September 24, 2024. The Plan has retained National Professional Planning Group, Inc. (NPPG) to perform the compliance testing. The nondiscrimination and other compliance testing are an annual requirement to meet the specific guidelines established by the Plan document in accordance with the IRC. Completion of the testing is necessary to maintain the Plan's tax-exempt status.

The Plan Sponsor has instructed the Third Party Administrator to complete the testing and does not anticipate that the tax-exempt status of the Plan is at risk. In addition, the Plan Sponsor does not anticipate the results of the testing will have a material impact on the financial statements as of and for the period ended September 24, 2024.
